May 2015

## Notes of the monthly meeting of Sudbrooke Parish Council held on Thursday 14 May in Sudbrooke Village Hall.

### COUNCILLORS PRESENT:

Councillor Bob Waller (Chair), Ian Russell, Andrew Cottam, Mrs Lyn Etheridge, Paul Rignall, Stuart Curtis; Mrs Chris Myers, Clerk; Mrs Bridget Solly, Treasurer

Five residents attended the meeting to hear the update by Mr Dominik Jackson. On hearing that Mr Jackson had cancelled his attendance the residents did not stay for the meeting, but requested that their attendance be noted.

### 21) Election of Chairman

Proposed by Councillor Stuart Curtis, seconded by Councillor Ian Russell and Resolved that Councillor Peter Heath be elected Chairman of Sudbrooke Parish Council.

The Declaration of Acceptance of Office would be signed at the next meeting of the Parish Council.

### 22) Election of Vice-Chairman

Proposed by Councillor Ian Russell, seconded by Councillor Paul Rignall and Resolved that Councillor Bob Waller be elected as Vice Chairman.

Councillor Waller signed his Declaration of Acceptance of Office. He then took the Chair for the meeting in the absence of Councillor Peter Heath.

### 23) Receipt of Declarations of Acceptance of Office/Completed Register of Interest Forms from all Councillors

Completed forms were handed to the Clerk.

### 24) Introduction of New Councillor

Andy Cottam was welcomed to the Council by the Chair.

### 25) Apologies for Absence

Councillors Peter Heath, Miss Rose Dobbs, County Councillor Mrs Sue Rawlins. Proposed by Councillor Paul Rignall, seconded by Councillor Stuart Curtis and Resolved that the reasons given be accepted.

The Chair had received an email at 17.01 from Dominik Jackson, of Jackson and Jackson Developments, giving apologies for not being able to attend the meeting due to work commitments.

The email was shown to the residents who had come to the meeting especially to hear his address.

### 26) Open Forum for Parishioners

No public present during the meeting.

Councillors stressed, that prior to an outline planning application being submitted for consideration for development in Sudbrooke Park, it was essential that a public meeting be held in the Village Hall so that residents be informed.

## 29) Consideration of Adoption of New Financial Regulations

■ The Treasurer and Clerk had prepared the NALC model financial regulations in line with Standing Orders, copies which had been circulated to all members. The Treasurer explained two further amendments/deletions since circulating.

Proposed by Councillor Stuart Curtis seconded by Councillor Andy Cottam and Resolved that the Financial Regulations as above be adopted.

With reference to Item 13 - Stores and Equipment - Councillor Stuart Curtis was appointed as Councillor responsible for the care and custody of stores and equipment.

## 36) Report on Matters Outstanding cont

**b) Siting of Notice boards:** Quotations had been sought from two companies for siting the new notice board at the Jubilee Garden and moving the older one to the Park Gates.

The Clerk had obtained prices for two posts at a cost of £55.00, delivered.

Company 1 - No quotation received. Company 2 - £200.

That company 2 (Neil Smith) be asked to carry out the work at a cost of £200. Proposed by Councillor Ian Russell, seconded by Mrs Lyn Etheridge. Clerk to liaise.

**c) Slurry sealing of footways in village:** Following a request that other areas of footways in Sudbrooke be given essential footway maintenance LCC Highways had stated that they would be borne in mind for future treatments. In the meantime potholes along the footway on Holme Drive would be attended to.

**d) Siting of benches:** Messrs Wilkinsons had agreed that a donated bench could be sited on Beech Tree corner and confirmation in writing was awaited.

## 37) Tree Preservation Orders in Village

■ Councillor Ian Russell had met with the Trees Officer at WLDC and been issued with an updated plan with the type of TPO and what they cover.

The Parish Council agreed unanimously to review existing TPOs and to consider amending or providing additional TPOs.

## 38) Cutting of Footpaths Through Woods

■ Consideration was given to applying for more cuts of the footpaths through the Parish Paths Partnership Scheme including FP 159, FP 816, FP 817 and improvement of some with bark chippings or stone.

Further information was awaited regarding costings and current cutting schedules by LCC this year.

## 39) Community Wildlife Grant

■ It was noted that only approximately 10 per cent of the wildflower plants had grown, set last autumn, in the Jubilee Garden.

The grant scheme was being run again this year and Councillor Ian Russell offered to investigate the possibility of re-planting.

Council agreed unanimously that Glendale be asked to trim the area to 6" to keep it tidy, but also allowing for any plants just coming through to have a chance.

## 40) Consideration of Purchase of a Laptop/Printer for use by Clerk/

### Change of Email Address for Parish Council

■ The Chair stated that the shared computer/printer which the Clerk used was now at the end of its life. £400 had been set aside for replacement computer when required.

The Clerk had sought prices and a favourable laptop was £349.99. Software required - Microsoft Office 2013 £99.99 from PC World or purchased with PC £79.99.

Sage Computers had quoted £100 to configure and set up a new laptop computer with dedicated email address and provide/install Microsoft Office.

Members authorised the Clerk to purchase a laptop and printer and instruct Sage Computers to configure and provide software/set up Parish Council email address at a cost not exceeding £550 excluding VAT.

The above Resolved unanimously.

Members of Sudbrooke Parish Council have viewed this application and the following comments made:

- Neighbours have been spoken to and are concerned about the loss of established trees and wildlife in that area
- The application is for too high a density of dwellings
- Access onto Wragby Road would be a problem, this being an exceptionally busy road.'

ii. Planning Application - erect one dwelling in the garden of existing bungalow - Land to the rear of The Sonnets, Church Lane - 132809 - Response to WLDC as follows:

Sudbrooke Parish Council have no objections to this application, but request that any comments made by the neighbours be taken into consideration when determining the application.

iii Planning application - erect two storey extension to front - 4 The Paddock - 132874 - Comments to WLDC - 'Sudbrooke Parish Council has no objections to this application.'

d) Planning permission: 5 Wragby Road - ground floor extension - 132394.

# PARISH COUNCIL REPORT

## Brief report of meeting held on June 2, 2015

■ **Present:** Councillors Peter Heath (Chairman), Stuart Curtis, Paul Rignall, Mrs Lyn Etheridge, Andy Cottam, County Councillor Mrs Sue Rawlins, Mr Dominik Jackson, Jackson and Jackson Development, Mr James Rigsby, Globe Consultants, Mrs C Myers (Clerk), Mrs B Solly (Treasurer) and in excess of 120 residents

■ **Proposals for development in Sudbrooke Park:** The Chair opened the meeting by stating that the Parish Council wanted to take in the opinion of residents of the village with regard to proposals of a residential development in Sudbrooke Park by Jackson and Jackson developments. He suspended Standing Orders in order to allow residents to take part for a limited time and ask questions of Messrs Jackson and Rigsby.

The Chair stated that meetings of the Parish Council had not been held 'in secret' with developers. However, it would come back to the Parish Council to make judgments in the best interests of the village, hence some questions had been put to the developers in advance of this meeting and it was hoped that they could be answered for clarification.

District Councillor Stuart Curtis gave an update on the emerging Central Lincolnshire Local Plan relating to proposals for future development in the area and also gave general advice on existing planning policies under which present planning applications are determined by West Lindsey District Council.

Mr Jackson and Mr Rigsby stated that they were interested in working with everyone. They answered the questions previously put to them written in italics:

### Amenity Area

Will a commuted sum be provided for future maintenance of that part of the Amenity Area to be designated to the Parish Council?

What extent of potential amenity area would be accessible to the village compared to that under development? What is the total extent of the development and is it to be solely residential?

*A commuted sum would be made for rolling maintenance. There would be long-term maintenance of the amenity area, building on the existing footpaths, surfacing to the highest quality. There would be new footpaths into the woodland, additional benches and outdoor gym equipment, walkways around the water. This will be gifted to the village.*

*There is also a proposed extension into the Ten Acre Covert.*

*The Woodland Trust was interested in taking over the woodlands. The proposed development was for up to 140 houses.*

### Highway Matters

(a) What steps will be taken to safeguard or remove the legal right of access to the park gates on Main Drive by those who currently enjoy that access. Is there an intention to block road access to the gates from the bridge on Main Drive?

*The current access on the A158 would not be taken away. New residents would be discouraged from using this route as a short cut. There would be a change in the surface treatment of Main Drive. Consideration would be made to putting covenants on the sale of properties so that new owners cannot change access.*

(b) Would financial contributions be available in the event of the Highway Authority agreeing to provide traffic lights at peak time periods at the A158 junction and additional passing bays along Nettleham Lane?

*An independent consultant in Leeds had carried out an assessment which would be submitted with any planning application. LCC Highways would have the opportunity to agree or object at that time.*

### Retirement Homes

(a) What would be the total number of apartments within the proposed building?

(b) Would local residents have priority over those people outside the area?

(c) On the basis that the apartments would be leasehold, what plans do you have to form a management Company to maintain the building and communal areas?

*There would be 25 retirement homes – proposal to rebuild Sudbrooke Holme.*

*Local residents would be given priority. This would have to be written into the planning application. They would be leasehold with a management fee.*

*There would also be a small number of two-bedroom bungalows.*

### Protected Trees

What significance is the developer giving to protected trees? How can the scale of development proposed take place without major destruction of the amenity and wildlife value of the trees – the reason for which they were initially given TPO status?

*There will be a need to fell trees to facilitate access. Compensatory tree planting will be carried out within the development. Developers willing to work with WLDC to ensure trees are planted early and are of an acceptable age.*

*The Developer would look at which trees required to be removed for access.*

### Protected Wildlife

What ecological surveys have taken place and what were the results?

In addition to the impact on wildlife and ecosystems generally, how will the environment for known protected species be managed or enhanced.

*A site survey was carried out last summer – these show that no protected species had been found on site. Badger and bat surveys are being carried out. The developers would look at the wildlife plan for the area both woodland and residential. Wildlife will not be recklessly endangered. Poultry sheds within the woods would be removed.*

### Drainage

Will additional storage facilities be required to manage increased run-off from development – if so where and how big will this be? Who will maintain and fund this long term

*Additional storage facilities would need to be created, as shown on the plan. Local engineers have carried out a drainage survey, Greenfield run off rates will be achieved.*

*Drainage will not increase flood risks elsewhere or result in localized drainage issues. An additional pond would be made.*

# PARISH COUNCIL REPORT

## Brief report of meeting held on June 2, 2015 cont

Discussion/questions ensued at each point, with residents expressing extreme concern about any proposed development in the Park area; there being an obvious increase of vehicular traffic at Scothern Lane junction and on Nettleham Lane, this being a single track road;

The ingress/egress onto the A158 via Main Drive/Park Gates which in its present form could not be adopted by Highways - the entrance at the Park Gates being of insufficient width; the increase on medical services in the area; the increase in numbers of pupils for schools; the destruction of woodland and the effect it would have on protected species that do exist in the woods - this was argued with Messrs Jackson and Rigsby.

The Chair drew the Public Forum to a close at 8.45pm. Residents continued to view the drawings of proposals. Standing Orders resumed at 8.55pm and the Parish Council meeting continued in the Bramham lounge with one resident present.

■ **CCTV Equipment at Village Hall:** This has now been installed and is fully operational.

■ **Notification of street lighting replacements – St Edward’s Drive:** Notification received from LCC Highways that the replacement lighting scheme would commence in July 2015 and take duration of four weeks to complete.

■ **Planning Matters:** The meeting earlier in the evening with Jackson and Jackson Developments was discussed.

Members were disappointed that they had not had the opportunity to view the suggested proposals on the documents brought by Mr Jackson.

The public part of the meeting was discussed and it was felt that due to the strong reaction of residents, the Parish Council needed to meet Mr Jackson in a non-public meeting to understand what is being offered to the village through a Section 106 Agreement in his proposed planning application, emphasising that should an application be granted planning permission, the village needed to be able to gain the maximum benefit.

It was agreed that a letter be sent to Mr Jackson asking that he hold a Public meeting to address all the concerns that parishioners had raised earlier in the evening.

# SUDBROOKE PARK RESIDENTS' ACTION GROUP

They have their latest say on the proposed development of Sudbrooke Woods

## WERE YOU AT THE MEETING WITH THE DEVELOPERS ON THURSDAY 4 JUNE? DID YOU TAKE A LOOK AT THE PLANS?

If so, you're sure to have noticed that the number and extent of the promised new footpaths are really very small indeed. Most of the paths shown are the public footpaths that are already in existence. Remember the one by the beck and the one going up the field where horses now graze, towards Scothern? Sure, they're being retained – as established public footpaths, they have to be. The only difference you'll find in future is that at least in part, they'll be lined with roads and houses.

### *So there's a foretaste of the developers' generosity.*

Now let's look at the so-called "new" areas marked up with footpaths:

1) The New 10-Acre Covert. Paths there all right (well one, anyway, more or less round the edge), but don't forget about all the trees they admit they'll have to fell to create access and probably a few other trees as well, those that were left behind from the "thinning" which was done for "environmental" reasons a while back. One path, in a place perhaps of least use at present for exploitation by the developers. After all, the scheme's got to be worth their while.

2) Paths around the gravel pits (that's what they originally were, although some people call them ponds). These are paths that were used for donkey's years – probably ever since Sudbrooke Holme was demolished in the 1920s – until the landowners closed them off in 2012, and if the development doesn't go ahead, they could be registered as public rights of way in any case. So in that sense, they're not new at all. Trouble is, the process is so slow, the developers hope they'll be able to jump in first.

Let's consider the boundaries of the poetically named "Parklands" development (not that there'll be a lot of parklands left by the time they've finished). You'll notice that most of the old hall grounds and the field by the scout camp and Sudbrooke lake are completely excluded, both as far as development and access to the public are concerned. In other words, even though people have walked through the old hall grounds for almost as long as they have walked around the gravel pits, the developers' generosity doesn't extend to creating new footpaths in that area (even though the grounds were closed off by the landowners a few

years back, there could be exactly the same possibility and potential to claim public rights of way). Perhaps they're saving this part up as a haven for all the wildlife that will have been displaced from elsewhere? Perhaps they love what's left of the trees after all?

### *Sorry to disappoint you.*

Remember what we said before about the likelihood of future schemes? Maybe some of you will recall that about 10 years ago, there were ambitious plans to build around 400 houses on the field by Sudbrooke lake, not to mention a golf course and a hotel. And how convenient if the lake field has already been opened up and made accessible by a new roadway to take the construction traffic for the present scheme. So you see, having finished the first phase, the developers' sights will be set on the next one, as sure as night follows day. No wonder they don't want anyone to claim any public access rights on what were, until recently, well-trodden footpaths through the old hall grounds. But maybe someone should – because even if the process is a long one, it's going to take them several disruptive and destructive years to finish the first phase if it gets the go-ahead, so there may just be time to complete the process anyway.

### *Truly, to take so much away, and give so little in return...*

And think about the number of extra people who will be using these so-called "new" amenities – four, maybe 500? Let's just hope they don't all flock there at once.

Remember, those who aren't really bothered about the interests of Sudbrooke residents and whose only concerns are monetary ones often get what they want by trampling over the little people who get in their way. Don't let them trample over you!

It was with surprise that I saw on the morning of June 10, two large banners appear opposite the junctions to St Edwards and Holme Drive, and equal surprise and sadness that they suddenly disappeared on Friday 11th.

I should imagine they were expensive, and whilst expressing a view that maybe not all agreed with, at least they promoted healthy discussion in the village.

I understand that Councillor Curtis had them removed as they were misleading and they were on the public highway... so how do village fete/sports day etc. signs get left standing? Freedom of speech anyone?

The comment about 1200+ cars got me wondering if this figure could be true so I did some maths.

It is proposed for about 140 houses to be built. The ONS quote car ownership at about 1.4 per house currently (but this is an affluent area and probably would be higher), but at 1.4 this means 196 cars.

One trip out of the village and back means twice they have to be at the junction 400 times per day. But who makes just one trip? - two

All this of course assumes Mssrs Jackson and Jackson don't expand the amount of houses once outline permission is granted; I understand they have already added a northern set of houses to the estate and a possible mansion house of 40 odd flats.

## THIS MONTH'S FEATURED CONTRIBUTOR: ALEC C. CARROTTE

ABOUT the only occasions in our lives that we discuss 'boundaries' is when we either move house or attend a cricket match.

However, the consideration of 'boundaries' has a much wider significance and can affect many areas of our life, such as physical, emotional, spiritual, sexual and relational. But it is in the areas of daily exchanges where boundaries are perhaps the most significant.

The definition of 'boundaries' offered by Collins English Dictionary is 'something that indicates

the farthest point'. This, however, produces further questions 'what is the furthest point and who decides? This is often the result of cultural practice.

Take for instance, the boundaries of physical distance. Some cultures have no hesitancy in cheek-kissing or giving a hug when they meet, whilst other cultures maintain a discrete physical distance and settle instead for a handshake. In terms of emotional boundaries, some cultures will maintain a 'stiff upper lip', while others will quite openly express their emotions via wailing and beating their chests.

A further complication regarding physical and emotional boundaries is introduced when we consider the 'status' of our relationship with others, particularly with regard to our

relationship with professional workers in the 'health and social care services'.

Here we readily accept physical contact by medical professionals (doctors, surgeons or nurses), but would not readily do so by people who were not in such professions.

Likewise with our emotions, we may readily accept allowing people in the 'listening professions' (psychotherapists, counsellors, social workers and priests) into our emotional processes, but not be so willing to share our emotions with unqualified people or even sometimes those people we know very well, such as family members and friends.

In terms of the health and social care professions we are re-assured that they will be obligated to interact with us in a professional manner via their strict Codes of Professional Conduct.

This is not the case with other relationships (friends, family and strangers), where we need to spell out in the early stages of that relationship, exactly the boundaries of our interactions with them.

To summarise, we need to work thoughtfully at establishing healthy boundaries in all our daily interactions (deciding what is appropriate or inappropriate behaviour) and in this way ensure that there is never any room for ambiguity and no potential for later mis-understanding.

## THE RISE OF SOCIAL MEDIA ABUSE

■ Many of you will know that I am quite ‘into’ sport, hence Radio 5Live is my listening of choice. At the weekend, I was listening to an interview with Phil Neville, the former footballer and now a media pundit.

He was talking about his experience of Twitter and Social Media in general, commenting that as a footballer he had become used to abuse from all directions, but when the abuse began to be aimed at family, it crossed a line. He has a disabled daughter and when threats and comments ‘tipped over the edge’ he had on one occasion, referred the matter to the police who discovered that the threats were issued by teenagers, because they ‘thought it was a laugh’.

I am a fan of social media. I don’t go overboard, but I think it’s a useful tool and an instant way of communicating with people. It is probably here to stay until someone invents the ‘next thing’. Many of our schools, with the right safeguards in place, use it really well to communicate what the children are doing. However, that interview with Neville made me

think about labels and anonymity. One of the things that happens when people ‘troll’ over the internet is that they fail to see the person behind the comment. So, they are anonymous and the person they are abusing is anonymous, so they become a ‘label’.

No feelings, no humanity, just something or someone to have a pop at – the person to person contact is gone. I suspect that in almost every case, the abuser wouldn’t abuse if the person was sitting in front of them... if I am honest, I am not certain this is the sole province of social media either. It is very easy to anonymise people by labeling them and by taking the person out of the role and therefore feel its okay to ‘have a go’.

I guess this is part of human behaviour – it happened in the day of Jesus and it happens in relation to Jesus now. People like to label him as a mildly interesting historical figure, or a teacher whose teachings impress because they give voice to the voiceless, but to believe that He is the Son of God and central to the human story attaches an importance that rather blows the labels out of the box.

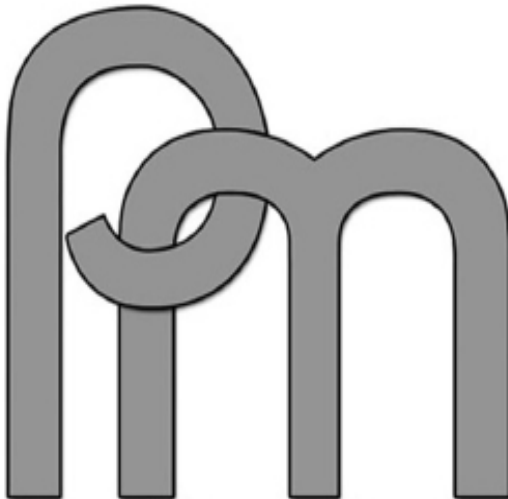

### STAFF UPDATE

■ We are delighted to announce that Ann Harland, an Advanced Nurse Practitioner will be joining the practice towards the end of August 2015 on a permanent basis.

The practice is aware that there has been some difficulty in booking an appointment with a GP or Nurse Practitioner recently, but with Ann joining the practice team this should help tremendously.

### REPEAT PRESCRIPTIONS

■ Dispensary are experiencing a lot of patients at the moment who are coming to collect their repeat prescriptions without allowing the 48 hours for processing.

The two working day turnaround takes into account the full process of issuing prescriptions correctly, which often involves checking medication records or even email contact with the relevant GP, and allowing enough time for the prescription (which will be one of several hundred) to be signed by the GP in between surgeries, home visits and the many other tasks of today's GP.

For this process to work efficiently and safely, we require the full two working days.

### NAMED GP

■ The practice has recently allocated all patients a named GP (you may recall we did this for all patients aged 75 or over last year), so that patients know who has overall responsibility for their healthcare.

We shall be informing patients of their named GP over the coming year when they contact or visit the practice, but should you wish to find out sooner, please ask the receptionists next time you are in one of the surgeries.

Having a named GP does not affect who you can see at the practice at all, nor does it give priority to be able to book an appointment with your named GP.

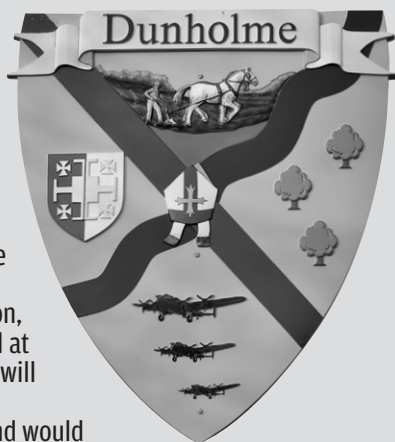

## SCAM MAIL

■ Have you received scam mail through your door recently? The likelihood is that you probably have.

Scam mail is sent by fraudsters, often from overseas, trying to persuade residents to part with money or personal information by tempting them with 'cash prizes'. These scams can result in considerable financial loss to the victims.

Trading Standards have become aware of an incident where a resident was sent a scam letter enclosing a photograph of a cheque with the victim's name on it, claiming that they had won the 'Football Lottery'.

The victim was asked to post a considerable amount of cash in order for the cheque to be released. Not surprisingly, this was a scam and the victim lost the money.

These types of scams are often time limited which puts pressure on the potential victim to reply quickly. Once the letters are replied to, the resident's personal details are often added to a list of potential targets which are then circulated to other fraudsters.

Residents who respond to scams can then be bombarded with similar scam mailings. Please keep an eye on vulnerable neighbours, family or friends to help prevent them becoming the

targets of these types of scams. Trading Standards advise you not to respond to any mailing which has the hallmarks of a scam and would encourage you to forward the letter to Royal Mail with a covering letter to:

You can also email Royal Mail at [scam.mail@royalmail.com](mailto:scam.mail@royalmail.com) or report your concerns by calling 03456 113 413.

We will send you a scam mail report form for completion together with a prepaid addressed envelope in which to return the form with examples of the scam mail received.

If you are concerned about a mailing call the Citizens Advice Consumer Helpline, who handle calls for Trading Standards, on 03454 040506.

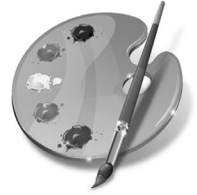
