






The Living Advent Calendar is back!

It was considered by the members to be good to see the field used and that the Parish Council be involved in the event which would be covered under the Parish Council's insurance. The Council, however, would not be involved in the evening event at the Village Hall. Proposed by Councillor Ian Russell, seconded by Councillor Bhikhu Mistry and Resolved. B) To consider cutting back northern boundary hedge of the field (deferred from May meeting): Confirmation had been received from Glendale that the quoted price of £245.00 still stood. Members agreed hedge be cut back in Jan to allow the birds to utilise the berries.



WINTER GARDENING

▶ We all deserve a rest at this time of year, so sit back and enjoy the winter interest of attractive seed heads and foliage rimed with frost and be pleased that invertebrates such as ladybirds, banded snails and spiders may have found protection in all your dead stems and foliage which you may have been unable to cut back this year.

Look out for blotches appearing on Hellebore leaves - these are often caused by a fungal disease that appears on the leaves in winter. Remove the infected leaves to stop the fungal spores from spreading to emerging foliage. Put them in the council green waste bin - not on your own domestic compost heap.

Then, when the garden is largely at rest, our thoughts will soon turn to thinking and planning for the next growing season, old packets of seeds will be sorted through, new ones ordered and we will soon be looking forward to seeing new shoots pushing through the bare earth and look forward to welcoming the delights of the first flowers of springtime.

If we should get a really severe spell of cold weather, then do remember to leave water and food out for the birds and, most importantly, make sure that your feeders are cleaned regularly. Enjoy the sweet and melancholy winter song of the Robin – a tonic on short winter days.

For indoor interest, why not plant and grow at least one Hippeastrum (commonly referred to as Amaryllis).

These bulbs are readily available from garden centres, most major stores and make wonderful seasonal gifts.

They come in single and double forms, in a wide range of colours and usually take about eight weeks to flower – children love to measure the rapid growth of the flowering stems. Enjoy!

LAST WALK

▶ Ten walkers set out on a bright dry day to do the Martin / Metheringham circular walk of approximately seven miles.

THE POTENTIAL CLOSURE OF SUDBROOKE LANE

Lincolnshire County Council have announced plans to close Sudbrooke Lane to all motor vehicles, to encourage more cyclists and walkers to use that route into Nettleham.

Right, is the letter released by the council.

This could have long-lasting implications on Sudbrooke residents, especially those who need to travel by car to Nettleham for medical appointments, for school, for shopping, etc... with more potential gridlock looming at the junction of Scothern Lane and Wragby Road.

Residents in Scothern will also be affected in that some people will choose to travel in that direction away from the A158 in order to get into Lincoln and beyond quicker.

Residents can air their views by taking part in a survey, but be quick as the county council will close it on Friday 17 December

THESE ARE SOME OF THE **VIEWS BEING AIRED ON** SOCIAL MEDIA....

'If you use the Lane to drive to the Co-Op, the GP, the pharmacy, school, pub, library, or just to visit friends and family, please go to the consultation documents at LCC and let them know that we use the Lane. Additional traffic on either the A158 or through Scothern past the school will be both dangerous and will increase carbon footprint. This scheme fails on every level.'

'The county council highway department need to get of their backsides and see what is going on in the community. All they want to do is close roads and cause more pollution. We need proper cycle lanes from the villages to Lincoln if we want people to cycle.'

'This is the most ridiculous proposal I've heard. I have already put my view to the LCC. It will not only put traffic onto the Wragby Road, which is nearly impossible to get out on to, especially to turn right, it will also send traffic down the Scothern road to Nettleham. That road isn't fit for purpose, if you meet a bus it's not wide enough. I really can't see the reasoning behind it at all. I use Sudbooke Lane four times a day and find most motorists are most courteous'

Starting today, (Nov 24) we will be seeking the views of residents, businesses and organisations on plans to create an active travel quiet route between Nettleham and Sudbrooke.

The Department for Transport (DfT) awarded Lincolnshire £799,900 to be used to give people more opportunities to choose walking and cycling for their day-to-day journeys, to boost active travel and reduce traffic congestion.

As part of the second round of funding, we've developed the prospective scheme below to potentially take forward:

Nettleham to Sudbrooke active travel quiet route:

The proposed scheme would see a single point closure on Subrooke Lane, to the west of Richmond Farm, in order to create a safe walking and cycling route between the villages of Sudbrooke and Nettleham. If taken forward, a closure will be installed

midway along Sudbrooke Lane and will be implemented by using high-quality temporary infrastructure, such as traffic planters. Nettleham Active Travel Projects: Cross St Low Traffic Neighbourhood: A point closure using traffic planters will be implemented midway along Cross Street to stop through motor traffic and allow an improved walking and cycling space

Church Street One Way System: A one-way west to east route along Church Street to reduce motor traffic flows in the vicinity of the Co-Op and encourage walking and cycling

We're now ready to engage on this to make sure it's appropriate and fit-for-purpose before we start the process of implementing a trial. We encourage anyone potentially affected by this to complete our online survey and share their thoughts.

The lane is the only SAFE way to get to Nettleham by car. The A158 is impossible to cross.'

'Why not close all roads every we're and increase public transport fares that will keep us all in our places?

'That's absolutely appalling, and typical of this hopeless county council. It's been asked numerous times to repair this road (all it ever does everywhere is bodge potholes several times over instead of permanently repairing them) so presumably they see closing it as the cheapest option. And if they succeed in that, which other roads will they close? There's literally no end to it.'

If it is supported by the public, this scheme would initially be installed temporarily for between a year and 18 months. After this time and following further engagement with local residents and organisations, a decision would be made about whether to make it permanent.

Like the other schemes we're trialling throughout the county, the hope is that for every journey we can make active travel a viable option for, we'll take a car off the road and reduce congestion and

COVID UPDATE

▶ I hope everyone is well and looking forward to a better Christmas than many of us experienced last year. Hopefully with the booster programme and the annual flu vaccination take up, the number of Covid cases across the district will level out and fall.

As I write this article, the numbers in West Lindsey are just below the national average. With a district-wide population of just over 98,000, the average equates to very nearly the exact number in the district. We really must not get complacent as the virus is still with us. I believe we should still take precautions where appropriate and encourage people who have not been vaccinated to do so. 88% of the eligible population of the district have had the first dose and 81.8% have had the second dose.

GREEN BINS

▶ Garden waste collections have finished for this year. I feel that this is too early and that the Council should provide this service all-year round. Now is the time that many gardens are covered with leaves from the trees. I along with some of my colleagues are trying to get this changed for the 2022 collection cycle. The cost for collection next year will be £39 (per bin). This is the first increase since the scheme started in 2018. This price will now stay fixed for 2022/23 and 2023/24 financial years.

PURPLE BINS

▶ Following on from successful trials in Boston and North Kesteven, a new twin streamed recycling collection service will come into operation next spring. The current blue recycling bin would be collected monthly rather than fortnightly. A new purple bin for paper and card will be collected in the alternate fortnight. There are no current proposals to change any collection days. .

FINANCIAL NEWS

▶ In the last budget, WLDC were awarded £10.3m from Central Government as part of the 'Levelling Up' Programme. This did not just happen. Earlier this year the Council submitted a very detailed and comprehensive bid to be awarded a share of the £4.8 billion central fund. The bid focussed on town centre regeneration, local transport projects plus cultural and heritage assets. Only 10 bids across the East Midlands were successful. PLATINUM JUBILEE FUND

▶ The Platinum Jubilee Community fund is now open for applications. This is a new community grant fund which is part of the Council's activity to support Her Majesty the Queen's Platinum Jubilee celebrations. Community organisations can apply for up to £700 from the fund to support their celebration projects. BY-ELECTION

• A by-election will be held in Nettleham on Thursday 16 December. Four candidates will contest the seat. Due to the political make up of the Council at West Lindsey this will be a very important election and will be very close.

ESCOOTERS:

An electric scooter is essentially a scooter powered by a motor, meaning they are classified as a 'motor vehicle' in law.

The Government is running trials to explore the positive and negative impacts of e-scooters on public roads, as well as to ascertain where the law should stand on electric scooters moving forward. Riding an e-scooter in public when it is not part of an authorised trial is against the law and can result in penalty points, a fine and the vehicle being seized.

If caught riding an e-scooter on a public highway, pavement, or cycle lane it could be seized by the police.

To recover the seized scooter could cost you £150 and a further £10 a day in storage fees.

You could then be reported for driving offences which would lead to significant penalty points and a fine.


