VICAR'S LETTER

Perhaps because the 40th day after we celebrate the Easter Resurrection falls on a Thursday, Ascension Day is less a major part of Christians' devotions today as it should be. The commemoration of Jesus being Raised to Glory, Ascended and Glorified, was seen as of great importance by Cranmer in his Book of Common Prayer – so much so that he included a Proper Preface (one of only 5 for use at Communion Services during the year - the others being Christmas Day, Easter Day, Whit-Sunday, and Trinity Sunday).

The Feast of the Ascension, celebrated this year on 17th May, should not be marginalized, or explained in purely symbolic language, for it marks a decisive moment in the purpose of the Incarnation itself, and is inseparable from the Resurrection.

If Christ rose from the grave, his departure from the world must have been equally miraculous – equally at variance with previous experience. The life of Jesus, and the fact of his Resurrection, plainly involved 'miraculous' events, and it is not possible to accept the claims of Christianity without acknowledging them. The central events of the life of Christ – the Virgin Birth, the descent of the dove at his Baptism, the Resurrection and the Ascension – were unique. When God was in the world as a person the distinction between the 'supernatural' and the 'natural' disappeared, for the Creator of all things was, as it were, creating as he went along.

The Ascension of Christ was a demonstration of the splendor and supreme authority of God. The risen Christ was revealed in majesty, time and eternity were joined, and the seen

and the unseen worlds opened to the gaze of mankind. Here was Jesus in the light of the heavenly presence, who had illuminated the world and now was drawn to a perfection beyond the world's understanding – as He passed from his humanity to resume his solely divine role.

People today, apart from their pre-occupation with materialism with a desire for comfort and convenience without great personal spiritual cost or effort, still have a great 'interest' in things supernatural. The Christian Faith has enough 'supernatural' content to satisfy a lifetime of searching – if people will only remember to look.

At the Shrine of Our Lady of Walsingham in Norfolk, there is a chapel that honours the Ascension, with artwork that is a startlingly realistic recognition of Jesus' ascension reminding us of the scriptural account of Jesus being 'taken up' (Acts 1:6-11; Luke 24:50-53).

This year we celebrate the 300th anniversary of the birth of Charles Wesley who gave us the greatest Ascension Day hymn – "Hail the Day that Sees Him Rise" – that first appeared in 1739 with 10 verses. Considerably revised by different editors over the years (particularly by Thomas Cotterill in 1820 and by the "Alleluias" at the end of each line in White's Intros and Hymns 1852 – resulting, with its increased length, in the usual number of verses sung today being reduced to 6).

The hymn is full of biblical teaching on the significance of the Ascension. It celebrates the accomplishment of Christ's work on earth, his triumphant entry into glory, his heavenly reign

earth, his triumphal entry into glory,
his heavenly reign and his priestly
intercession. It also reminds us of his
continuing kinship with his people on
earth.

The full ten-verse version is :-

Hail the day that sees him rise,
To his throne above the skies;
Christ, the Lamb for sinners given,
Enters now the highest heaven.

There for him high triumph waits;
Lift your heads, eternal gates!
He hath conquered death and sin;
Take the King of Glory in !

Master (will we ever say), taken from
our head, today,
See thy faithful servants, see
Ever gazing up to Thee.

Circled round with angel-powers,
Their triumphant Lord and ours :
Wide unfold the radiant scene,
Take the King of Glory in !

Lo, the heaven its Lord receives,
Yet he loves the earth he leaves;
Though returning to his throne,
Still he calls mankind his own.

See! he lifts his hands above;
See! He shows the prints of love;
Hark! His gracious lips bestow
Blessings on his Church below.

Still for us he intercedes,
His prevailing Death he pleads;
Near himself prepares our place,
He the first-fruits of our race.

Lord though parted from our sight,
Far above the starry height,
Grant our hearts may thither rise,

Seeking thee above the skies.

Ever upward let us move,
Wafted on the wings of love,
Looking when our Lord shall come,
Longing, gasping (sighing) after home.

There we shall with thee remain,
Partners of thine endless reign;
There thy face unclouded see,
Find our heaven of heavens in thee.

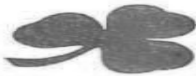

169 POLICE MATTERS

A Police Report had been forwarded as follows:-

A local young man had been arrested on Wragby Road, Sudbrooke for drink driving offences.

Damage to vehicles had occurred in Holme Drive, Greenway and West Drive, names of suspected youths had been given to the Police and investigations were being carried out.

A window of a property in Sibthorpe Drive had been damaged, and damage to a garage door at a property on Main Drive had been caused by an air rifle pellet.

The report concluded that over £3000 of damage had been caused. Extra patrols were being carried out in the village.

This was agreed and the public were asked to leave the meeting at this stage.

VISIT TO FOX LINDUM RECYCLING PLANT

Members of Sudbrooke and Langworth Parish Councils were invited to have a tour of the Recycling Plant at Caenby Corner where all the recycleable waste from our blue bins is sorted.

We were all pleasantly surprised at the tidiness of the plant, very orderly and odour free!

It was explained to us how the waste was sorted on arrival, being passed under a high powered magnet which has a rotating belt passing over it. This pulls up any ferrous material such as tin cans. The waste then passes under an electrostatic field which separates the types 1 and 2 plastics from the aluminum (the aluminum being the most valuable product for recycling).

The plastics and the glass then go through a cylindrical rotating drum which separates the glass from the plastics. The plastic and remaining products (ie any pieces of cardboard put in the blue bins) then pass along a conveyer belt where staff are removing lids from plastic bottles, retrieving any un-recyclable waste such as unclean plastic (the worst being unwashed pre-pack food containers).

Following sorting, the materials are crushed and baled to be dispatched to the processing companies for

recycling.

The glass is obviously very broken down at this point and will be ground up for use as road chippings and a sand like material for use between block paving.

The paper is handled in a separate area, where again, so much sorting takes place by hand, grading the paper, from office waste (the most valuable paper) – to newspaper and shreadings. An interesting comment was that newspaper more than three months old is worth very little for recycling, it being a low grade paper to begin with it is already beginning to degrade after such a short time.

The tour was an eye opener, a few points which came to light was that it is so helpful if a simple process such as removing the screw tops from plastic bottles were to be done before placing in the blue bins and rinsing of food containers. I think the tour highlighted the fact that if there weren't so much packing on products to begin with the process of all this recycling would be reduced dramatically. After all, do we really need 4 yogurts wrapped in a cardboard cover?

SUDBROOKE PARISH PLAN

The launch ceremony 20th April.

Thank you to all 269 residents who attended and made the event so worthwhile.

An important outcome was the prioritisation of actions in the action plan- residents identified 13 from the total of 35 actions for early attention. The service supplier representatives from County Council (Highways and Traffic), West Lindsey District Council, the Police Authority, Community Council of Lincs and AGAST were kept busy throughout the event.

A few more people volunteered to help with the action plan for which we are grateful.

Surprising that only one person identified themselves for membership of new clubs or activity groups whereas the questionnaire responses showed potentially large numbers of interested residents.

Finally there are a relatively small number of people in Sudbrooke who said in the questionnaire (which was completed anonymously) that some help was needed with the garden, shopping, neighbourly contact or visits from members of the Church. We tried, without success, to identify those people in need of help at the launch ceremony. Other means of achieving this will be considered.

Issues and prioritised actions.

1 Majority of residents do not want housing development- to inform the planning authority and landowners.

2 Quality and sufficiency of police services- to ensure frequent availability of beat and community police in the parish.

3 Busy –time traffic lights needed at

junction of Scothern Lane and Wragby Road- to gather required evidence and lobby Lincolnshire County Council.

4 Permanent doctors surgery is required in Sudbrooke- gather required evidence and lobby service provider.

5 Increase local bus services over longer hours- work with service suppliers to achieve improvements.

6 Introduce a footpath/ cycleway between Sudbrooke and Nettleham on Sudbrooke Lane- lobby appropriate authorities.

7 Provide separate recreational facilities for teenagers- bring together interested parties and relevant outside expertise.

8 Provide an outdoor sheltered meeting place for teenagers- ditto 7 above

9 More use required of village hall and bar for social gatherings- Village Hall Committee to consider how achievable.

10 Increase access to Sudbrooke Park and improve as an amenity area- take up with landowners and other appropriate authorities.

11 Campaign against litter and rubbish dumping is needed- create working group to devise and implement campaign.

12 The landscape and wildlife in the parish are important to us and should be safeguarded/protected-

Conservation Committee, Parish Council and relevant environmental authorities to provide guidance on what parishioners should do and monitor this.

13 Object to gas storage proposals- Parish Council to lobby relevant authorities.

SUDBROOKE PARISH PLAN cont'd.....

Work has started on numbers 1, 2, 3 & 5.

Some actions fall naturally to existing groups e.g. the Village hall Committee will lead on number 9, the Conservation Committee will lead on numbers 10 & 12.

The issue attracting most responses from residents was 'object to gas storage proposals'. The action on the Parish Council is to lobby relevant authorities which is being done as an ongoing process (see Parish Council Minutes) as well as through the AGAST action group. It may prove necessary to resort to European legislation if UK laws do not protect residents.

Sudbrooke Parish Plan Advisory Group

The purpose of this group is to monitor and assist progress of the action plan. It is made up of parishioners and some Parish Councillors.

The group met for the second time on 27th April to assess the success of the launch event and give an initial consideration to the prioritised actions.

The role of group members is likely to be:

- 1 Act as lead or support with one or more of the actions contained in the Action Plan.
- 2 To encourage others to help and tap into expertise in Sudbrooke and elsewhere.
- 3 To report back to the Parish Council on progress.

The next meeting of the Advisory Group is Tuesday 17th June at the village hall from 7-30pm, when the Group's constitution, officers and roles will be decided. It is likely appointments will be made on an annual basis. This may all sound very

formal and boring but is essential particularly when dealing with funding bodies.

Much of the meeting time should be devoted to progressing the Action Plan. There is no reason why some of the non prioritised actions cannot be started if people volunteer to do them or at least get involved.

Many people have expressed a willingness to give some time to the community and the challenge for the Advisory Group is to identify and direct those people to appropriate activities. This is likely to take some time but will be done.

If you wish to find out more about the Advisory Group without necessarily committing yourself to formal membership, do please turn up on 17th June or phone me on 754686 for further information.

By the time you read this note your household should have received a copy of the Sudbrooke Parish Plan and Action Plan, 2007- 2017. If you have been missed please let me know. Finally, the pupils of Ellison Boulters School designed a 'welcome to Sudbrooke' sign for the launch event.

Dear Editor

It was interesting to see the Parish Plan in the village hall and we have now received the Action Plan 2007 - 2017.

However I am very disappointed to see two of the projects in the Plan. The first is the proposed cycleway/path between Sudbrooke and Nettleham which I believe can not be justified. The cost of the work and the disruption while it is carried out on what is a pleasant rural road will be out of proportion to any benefit there might be.

The road as it exists is wide enough for vehicles to pass cyclists, and anybody diffident about that can stop at the verge or in a passing place for a few seconds.

One thing, if anything at all is thought necessary is to check if the verges have encroached onto the road over the years and can be cut back a little. Certainly there are dips and holes at the road sides that need attention. That is the maximum that should be done on this road.

What does the Council propose at each end of the path if it is constructed? Do they want to encourage the illegal use of footpaths by cyclists, even if the law is rarely upheld? The roads in Nettleham and Sudbrooke might be wider but there is much more traffic and it moves a lot faster.

If cyclists can get to and from the road in question then they should have no difficulty in using it as it is - as I have done, with my daughter on numerous occasions.

Please do not waste money on something that is not needed.

The second item that disturbs me is that the traffic light fiasco has come up again.

A few years ago this was raised by the Parish Council and rejected, quite rightly, by the County Council. The Parish Council tried to say that lights were needed because of accidents at the junction. That simply was not true, as I found out from the Police Accident Unit, and as my letter to the magazine at that time proved.

Nothing has changed in that regard and I can only assume the present effort is driven by the impatience of certain drivers who can't wait up to 2 - 3 minutes to get out of Scothern Lane to travel towards Lincoln.

Do they not see that if lights are installed the traffic on Wragby Road will receive priority, and the time to get out of Scothern Lane is likely to be no shorter than it is now. However considering that some system will be required to allow traffic to cut across the main flow - filters or delay system and maybe pedestrian facilities to cross to the bus stop etc., you can see that a much longer delay is very likely. So what benefit is there for the residents of Sudbrooke? That for a massive disturbance while any work is carried out, which is likely to take months. And no figure from the Council on the cost.

The, so called, busy time lights idea really does puzzle me. If we take 7.30 - 9.30 on a weekday morning what gain is there going to be. Surely I have shown there is unlikely to be any. Other busy times would normally involve late afternoon/evening but traffic returning to Sudbrooke can surely turn in to Scothern Lane without any delay at all. No benefit there then.

So that leaves a few weeks in the summer, and possibly bank holidays when there is some increase in traffic flow along Wragby Road. Is it proposed that the lights operate on a Saturday morning and Sunday evening ? I am sorry if the people who ticked the yes box think my comments are harsh but I do not see how this proposal can have been thought through. Perhaps somebody on the Council can justify what will be a very big project in rural Sudbrooke, which does not by any measurement have a traffic problem.

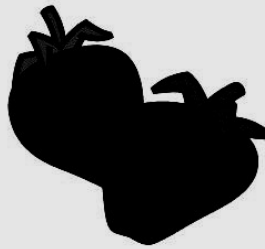

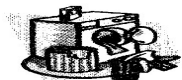

COUNTY COUNCILLOR'S CORNER

This month, I thought I would start with a few numbers.

200 to 300 are the first..

This, in millions, is the amount of money needed to repair our existing minor road network. This is not to improve the roads, merely to get them back to the standard that they were a few years ago. Eight in every ten miles is the Lincolnshire average proportion of our minor roads to our A and B main roads.

The money being spent is 40.

That is forty million pounds per annum on maintenance. This doesn't mean that, on the lower end of the scale, in five years we will have cracked the problem. The money is being spent just to try to maintain things in their present bad state. Many roads will deteriorate rapidly from merely bad to terrible if the money is not spent on temporary repairs.

Many people, on seeing the temporary repairs say 'surely it would be cheaper to do the job properly and not have to do another temporary repair in a short time?' In fact the temporary repairs are needed now to prevent even more expensive problems developing in the near future. 'Doing it properly everywhere' involves spending money the highways department does not have, and not doing the temporary repairs somewhere else involves the problem get much worse and even more expensive to solve later. It needs more money now to save tomorrow.

£50 per meter is the average cost of repairing the edge of a road 'properly'. The money is not there and there is no obvious solution in sight.

Government, who provide most of the money do not hear the details of the problem, even when it is explained to them. In the absence of a change of policy, our local road problems are set to get worse.

Lincolnshire is worse off because we have much more roads per voter than most places, and our proportion of minor roads is greater.

Improving our roads would cost a great deal more.

But this is what most people want.

They want proper repairs and improvements at the same time. But they most certainly do not want to pay more council tax! In fact, the amount of money needed is so great, there is no prospect of it being found in that way. We need to recognise as a nation that rural counties rely on cars even more than urban areas, but have worse roads. Many villages in Lincolnshire do not have the luxury of a nearby main road and instead rely entirely on local country roads for access.

There is one way that you can help.

By not driving off the carriageway onto the verges, the damage will be reduced, and with it the cost of repairs. Your car may well be very capable of dealing with the rough ground at the margin of the road, it is the road that can't cope! You may like to think of it this way, in the end, it is your money paying for the repairs.

That is repairs to the road, not your car.

Dispensary staff still continue to report an increasing amount of requests for repeat prescriptions to be issued “urgently” (nine requests before 9.30am one morning recently) We do require 48 hours (two working days) notice to process the repeat application and remind patients that this can be requested 24/7 by answer phone or by posting a request through

the letterbox or dropped into the surgery. If a prescription needs to be sent to a chemist please remember to indicate this each time a request is made.

For those jetting off on holiday we would remind patients of the need to apply for travel advice giving as much notice as possible of travel intentions to ensure that appropriate timely vaccination schedules can be offered. DNA (did not attends) for April – 32 surgery patients and notification to date of 9 hospital appointments. As always, please let us know if you are unable to attend so that the slot may be offered to others.
