NOTES OF THE MEETING OF SUDBROOKE PARISH COUNCIL HELD ON THURDAY 4th OCTOBER 2007 IN THE VILLAGE HALL, SUDBROOKE

APOLOGIES: Councillor I Russell

62 PARISHIONERS ITEMS

It was brought to the attention of the Council that the footpaths and highway on Chestnut Close and Chestnut Drive require attention. The Clerk would contact the Highways Department regarding this.

It was also noted that the street sweeper was not sweeping into the Park Gates area causing a build up of debris. Councillor Stuart Curtis would take this up with the Street Cleansing Team.

<u>**63 POLICE MATTERS**</u> - There was no Police present at the meeting.

64 COUNTY COUNCILLORS REPORT

County Councillor Roger Hiscox reported that the Highways Department had been funded an additional £500,000 for maintenance work.

The responsibility of the local authorities was outlined regarding

flooding.

The Parish Council brought to the attention of the County Councillor notice that frontages on the road between Sudbrooke and Nettleham were encroaching onto the land belonging to the Highway and concern was made that if this was allowed it may cause a problem in the future, if or when, a Cycle path between the two villages became a reality.

66 REPORTS ON MATTERS OUTSTANDING

- a) Parish Plan and Action Plan Cllr M Halliday said the Parish Plan Group had met on 11th September and covered the following matters:
- 1 Clarification of the eligibility criteria for traffic lights would be sought from Lincs County Council.
- **2** A satellite doctors surgery was not available to Sudbrooke according to the Practice Manager. The legal position concerning the prescription pick-up point was under review.
- **3** A large enough site had been identified in Sudbrooke for the proposed new Nettleham medical practice and the landowner had expressed a willingness to participate subject to various conditions being satisfied. This had been conveyed to the Practice Manager.
- **4** West Lindsey Local Development Framework consultation - the parish plan relevant issues had been incorporated into the Parish Council's response.
- **5** Open Day would be held on Friday 12th October to enable parishioners to register interest in new or existing activities.
- b) Sports Day Review It was

reported that the Sports Day had been a successful event, with glorious weather. There had been a total of £370.00 sponsorship. The possibility of purchasing a megaphone for use at future events was suggested.

- c) Footbridge West Drive This had again been vandalized and the Parish Council agreed unanimously to offer a reward of £50 leading to the successful prosecution of the vandal(s) concerned.
- **d)** Overhanging shrubs Cllr Paul Rignall had cut back the foliage covering the road sign near to the village hall.
- e) Trees Holme Drive/Courtfield Close Members had looked at these trees and it felt that no cutting back was necessary at the present time. It was agreed that the matter be left in abeyance.
- f) Dropped Kerbs Councillor Derek Ordish had been asked to attend a site meeting with a member of the Highways Team on 8th October 2007.

g) Christmas Tree Event -

Arrangements for this event were progressing. The Clerk was asked to publicise the event in local magazines and notice boards.

Report from Parish Council meeting on 1st November

Audit 2006/7 – The Parish Council has been charged an additional fee by the Auditor because a resident has raised several issues with him about the Parish Council Annual Return for 2007. One item was irrelevant as it was about the previous years return, and another about the raising of two cheques for £6.00 each! The Responsible Financial Officer responded very quickly to the queries, supplying all the information required. These were accepted and the accounts have since been passed by the Auditor. This has cost the parish an

additional £279.00 when the questions could have been directed to the Council in written form and answered. When so much effort is made by Volunteers in the village, to **save** expense on jobs such as litter picking, trimming of shrubs, hand delivering of Sudbrooke News, bulb planting, the voluntary help for the Christmas tree etc, it is a shame that this has to happen. A full report on the question and answer will be published in the minutes.

properties and arrange to trim them back if they are overhanging the footway. Thank you.

Police matters – PC Diamond reported that a property had been entered in Sudbrooke with many items being taken.

Street Force Warden, West Lindsey District Council

Mr Kevin Dunne, the newly appointed Street Force Warden gave an interesting brief on the Street Force Team as follows:-

West Lindsey District Council Street Force Wardens Unit was created in September 2006, working under the management of the Environmental Protection, and Community Services Department. Their role is to provide a reassuring presence within the community by tackling environmental crime, such as Graffiti, Littering, Flytipping, Dog fouling, Abandoned vehicles.

The Wardens present a high visible uniformed official presence in town centres and public areas, throughout the West Lindsey District. Although, the Street Force Wardens are not police officers they work in close partnership with PCSO's and have powers under the Clean Neighbours and Environment Act 2005 to issue Fixed Penalty Notices by acting as eyes and ears of the community to tackle environmental crime.

The Wardens also work in partnership with local communities and promote environmental initiatives including litter picks and educational visits to schools by highlighting problems of litter, fly-tipping, and responsible dog ownership.

Street Force Wardens have a zero tolerance approach to environmental crime and will issue Fixed Penalty Notices to any person or businesses which fail to comply with Environmental legislation, such as, Environmental Protection Act 1990 and The Clean Neighbourhoods and Environment Act 2005.

Fixed Penalty Notices provides the Council with an effective and visible way of responding to environmental crimes. The Fixed Penalty Notice offers the offenders the opportunity to discharge any liability to conviction for the offence by payment of a fixed penalty notice within a prescribed timescale, normally 14 days. However, should the fixed penalty notice not be paid this will result in prosecution for the offence within the Magistrates' Court and, if convicted, could receive a much larger fine, imprisonment or both.

The Street Warden Team can be contacted on any of the above matters on 01427 676676.

Grass cutting – An additional area of verge on Scothern Lane and around the Church Lane junction will be cut by the Parish Council grass cutting contractors from next season. This will hopefully give a clearer view for motorists when exiting Church Lane.

The area of land at the end of Beresford Drive will also be cut on a regular basis.

Firstly I would like to mention that we have had three burglaries in the area (Sudbrooke and Reepham) during the month of November. These crimes took place during the day whilst the occupants were at work and either windows or doors were forced to gain entry. Please be alert. Make sure that all your windows and doors have substantial locks. Make sure that your property is as secure as it can be when you leave and set your alarm if you have one. Keep an eye on your neighbour's property and if you see anything suspicious report it immediately. We do not mind if it turns out to be a false alarm. If you are planning to go away at Christmas invest in a number of timer switches for your lights in order to create the impression that someone is in and therefore deter any undesirable people. (NOT the hall lights - how many of us only use the hall light when we are in? This is a sure sign to

the burglar that you are out!) We need to ensure that no one gets the opportunity to commit these offences. Please keep an eye out if you have an elderly, or vulnerable person living near you. Be a good neighbour!

On the same lines make sure that your vehicle is locked and secure and that you do not leave valuables on show in your vehicle. If you are shopping for Christmas presents in town, lock them in your boot and out of sight.

On the same note we have also had a spate of thefts of vehicle badges in the surrounding villages. If you see anyone taking the badges from vehicles please ring us straight away. Getting the badges off the vehicles often causes damage to the metalwork of the car and also makes the vehicle look unsightly when they are missing. This is criminal damage. Collecting vehicle badges is not a good idea unless they can be bought from legitimate places.

On these dark nights please make sure that you have adequate lighting on your bicycle and that of your child's. Over the last few days I have seen paperboys and papergirls zig zagging across the road on the bikes delivering papers, wearing dark

clothing and no lights on their bicycles. Lots of clothing these days is made with reflective strips as an integral part of the item. Reflective waistcoats and strips and be bought relatively cheaply. Reflective bits that go on the spokes of the wheels can make them visible when side on. Regularly check the batteries and bulbs in your lights before you leave your home.

Please make sure your child can be seen in the dark.

Finally, just to point out that it is not

all doom and gloom. We live in a beautiful part of the world and in an area that has relatively low crime. I have been touched at the friendliness of everyone in the area and I look forward to seeing you out and about during the coming year.

And finally, we would like to take this opportunity to wish you all a Merry Christmas and a Happy New Year from everyone here at the Nettleham Police Station.

COUNTY COUNCILLOR'S CORNER

Incomprehensible Spending Review

My title this month is a bit tongue in cheek I admit, but I think I need some light relief if I am to talk about central government spending your money. The Local Government Association has

been assessing Central Government plans for the money it pays to councils over the next few years. As regular readers will know, your council tax only covers a quarter of the £1 billion the county council spends each year. Other taxes pay for the other three

quarters. 1% less centrally distributed money would take a three percent rise in council tax to make up the shortfall, which is why the 'comprehensive spending review,' to give it it's correct title, is so important. Setting out the details of that document is not really possible in an article of this type, but I will pick out an important example.

Central Government expect Local Government to make 3% a year efficiency savings. For separate reasons, all the principle councils in Lincolnshire have come together in what is known as a 'Pathfinder' process to find ways of working together more effectively and more efficiently. The ultimate aim is that you can contact any principle council about council services and they will be able to deal with the matter, even if it involves services provided by another council. But in setting out to do this a long term goal - it is obvious there is room to do some jobs better and more cheaply across the whole county than have eight councils all doing their own thing.

One of the first 'easy wins' is legal services. Not all Lincolnshire councils employ lawyers. Some pay for the advice they need as they need it. But that is not cheap. It has become clear that there are savings to be made and the participating councils have joined together to have one service, with branch offices. The savings are quite large and it is anticipated that we will be saving Lincolnshire's council taxpayers about £400,000 per year. This sort of innovation should be common but is not. Legal Services is easy to agree, because each council saves money. It will get more complicated when we share a service

that saves one council money but not another.

The council taxpayer benefits whichever council shows the lower cost, because their overall council tax bill is a bit lower as a result. But if voters only reward councils that show reductions, there is likely to be political pressure to show the savings equally shared between councils even though it is one council saving more than another.

But that difficulty lies in the future. There are several other back offices functions that can be done more efficiently overall, if all councils cooperate, and the resultant savings will be across the board.

Procurement (buying goods, services and a few other things in plain English!) is a likely next step. It is not the only saving, but buying larger quantities can in itself can helps costs. This has been done for many years by Eastern Shires Purchasing Organisation (ESPO) and you may see this logo on a van delivering stationary to a school. But it tends to deal with bulk supplies of things rather than services, and it is the latter where there are still savings to be made. Property management, computer services, training and similar things can all probably be done better and cheaper collectively, if we can work out the detail.

And it is not only back office services, but such things as customer services that can be done collaboratively, but now I am back to where I started. Making things work as if there is just one council at your service. It is a lot of work and a long slog but I for one am committed to it.

COMPUTER CLASSES

Due to the success of the classes run during the summer and autumn terms of 2007 further computer lessons will again be offered in the spring of 2008 at the Area Community Education and Training Centre at the Old School Dunholme.

Two classes for beginners are offered; one on Tuesday morning 9.30am to 11.30 am and the other on Thursday afternoon 12.30pm to 2.30pm. These classes are for those that have little or no knowledge of computers. It covers aspects of computing that is not normally covered by other training providers or in house training. It starts with how to set up your own filing system in your own folders and creating shortcuts and changing the appearance of icons. The course progresses using a word processor (Microsoft Word) for learning how to create formal letters, using the auto-correct function, setting up Templates and letter headed paper and creating your own pamphlets flyers and even magazines by creating text boxes and inserting clip-art and photos. Other topics will be using a scanner, photo editing and the use of the Internet and emailing with attachments and surfing the net using search engines and on line shopping.

To meet the demand for different levels there will be a class on Monday evening of two hour duration 7.00pm to 9.00pm to cover additional skills. Not normally taught in other training centres. The course covers the syllabus of the beginner's course but does it in a little bit more depth. It also includes using Microsoft Publisher to create leaflets and newsletters as well as creating animated presentations using Microsoft PowerPoint.

All courses will cost £40 for ten weeks for each course starting week beginning Monday 7th January 2008 (there will be a break for the School half term). The course will be open to every one of any age, gender or ability and to ensure personal attention from the tutor no more then six places will be offered for each class.

The courses are on:
