SUDBROOKE REFERENDUM Dear Resident of Sudbrooke...

Welcome to the third decade of the the third Millennium or in shorter terms, 'Happy New Year'. The Parish Council wish you all the very best for

the future. To try to help with that future your Parish Council and group of volunteers created a Neighbourhood Plan to guide the village through the next 25 years. On February 13 you will have the opportunity to vote on this long-awaited document.

WHAT IS THE NEIGHBOURHOOD PLAN?

It is a review of Sudbrooke in terms of housing, environment, historical significance and finally heritage. It also has a series of policies for how you want the village to develop over that period. We are defined as a medium village so the development potential for new housing is constrained within that definition and clarified by the neighbourhood plan.

It is your wishlist for housing, schools, medical services and business. It has to be put to a referendum and for it to be approved it needs only a simple majority. Without that approval then the plan is dead and development in Sudbrooke will be controlled by the wider policies of the Central Lincolnshire plan.

The Parish Council hope that you will take the time to look at the plan and that you will support it with your vote. There are copies of this on-line, at the Village Hall, Nettleham library, and I have a copy if need be.

125 PLANNING MATTERS

a) To consider request by Truelove Homes to alter specification for construction of footpath, Nettleham Lane: Members discussed the suggestion of a change of specification to the construction of the footpath. That the original specification be maintained unanimously Resolved.

 b) Neighbourhood Plan: The final report from the examiner had been received and amendments made to the Plan bringing it to the Referendum stage. It was hoped that this could be carried out as soon as possible.
 c) Park Development: Nothing further to

d) Application 140180 - 30 Wragby Road -

Planning application for demolition of the existing dwelling and erection of a large house of multiple occupation (sui generis use class) with associated access alterations, vehicle parking and landscaping: Many residents had raised objections to this application and the Parish Council also raised concern. District Councillor Bob Waller had requested that the determination of the application be made by the full West Lindsey District Council Planning Committee, comments of which the Parish Council re-iterated as follows:

"LP1 - The application is in direct conflict with LP1 as it does not provide sustainable development and is unlikely to be used by existing residents.

LP2 - Sudbrooke has far exceeded the housing stock in the Neighbourhood Plan.

LP3 - Does not apply because development targets met and exceeded by Sudbrooke Park Development.

LP7 - This is not high quality visitor facilities and conflicts with the majority of LP7. Sudbrooke Parish Council state this as to the complete uncertainty of the use of the building. The applicant has stated that it is to be used as an air bnb and an 'overflow' for hospital consultants. This does not fit in with Sudbrooke Neighbourhood Plan.

LP10 has already been met by The Park development for the next 25 years; it conflicts with Neighbourhood Plan 4.5.1.

LP17 - The new building in relation to the townscape afforded by existing houses is in direct conflict with LP17.

LP 26 - In conflict with design principle LP26(B). The access on the main arterial route into Lincoln (A158) is a known accident blackspot.

LP2C - It will be completely out of character with other houses in the village.

Sudbrooke Neighbourhood Plan 5.22 - This application for a block of eight 'flats' as stated use of air bnb does not provide for existing and future residents to live in a home appropriate to their needs.

5.23 Section 13 - The proposed build of this application is completely out of character with a village mentioned in the domesday book. Sudbrooke Neighbourhood Plan does not identify a need for this type of accommodation. Paragraph 5.23 does not respect the Neighbourhood Plan and Sudbrooke Village Character Assessment despite stating otherwise in the application.

6.2 - States that the proposed building is on a residential street within the village. However Sudbrooke Parish Council would like to point out that the A158 is the main arterial road from Skegness to Lincoln.

6.3 - The existing two-storey property is entirely in keeping with the street scene and this development will be considerably larger and not in keeping with the street scene.
6.5 - Mr Martin Evans, the Planning Officer referred to is not, to the knowledge of Sudbrooke Parish Council, a Senior Planning Officer with West Lindsey District Council.

6.6 - Sudbrooke Character Assessment suggests that Sudbrooke is an attractive village to live and this proposal would not 'raise the standard of design more generally in the area'. 6.7 - Sudbrooke PC does not agree that this application confirms with the Policies stated. 6.9 - There has never been a call for this type of accommodation in the area. It will not fulfil a non-existent local need.

6.11 - Sudbrooke Parish Council disputes that this development meets the aspirations of National and Local Planning Policy and it should be rejected.

LP 10 - This does not support LP 10. Material Planning Considerations:

The overbearing nature of the proposal. Access and Highway safety will be impaired by the arrival and departure of residents and service vehicles on the main A158 just metres from the junction of Scothern Lane. Traffic Generation - The development will generate more traffic by its concept. Noise and disturbance from the Scheme -Residents will be able to arrive any time - day or night, having paid their fees on-line. The design and appearance is a Material Consideration in that it is out of keeping with the rest of the village.

Sudbrooke Parish Council has been approached by numerous residents concerned about the use of this building as a potential party house, brothel, and drugs county lines operation.' • e) TPO 041321 - Garden House. West Drive

We set up camp on a warm summer's day, and did a quick tour of the facilities. A large TV room was available. The toilet block was clean with plenty of hot water, and reminded me I needed a shower!


We saw on a hilltop an abbey that we could explore. It was occupied by a group of close order monks who were sworn to silence for periods of up to five years! This was the year when they were allowed to speak, and in the woods below the abbey, a market and fair was being held and the next day we observed some of the abbey inmates on their day out exercising their lungs. And they were chatting up a group of nuns! The day following we had some housekeeping to do on the campsite, and we had a rest day before we found out what was involved in getting in to Krakow 6km away.

It turned out to be relatively simple. A bus stop was found almost outside the camp entrance that took us right up to the tram terminus, and a tram into the centre of Krakow ran every few minutes. Tram tickets could be obtained from any tobacco booth of which there were plenty, and they were validated at a ticket 'validator' in the tram. Krakow is a stunning city and there is so much to do



and see. We did a tour round the city centre in a horse and cart (I think that's what it is called), and ate some cake and drank several coffees in the most expensive coffee shop on the planet in the main square in the sunshine!

Later in the afternoon, the local TV company were setting up for a TV extravaganza to be televised from the square, and it was fascinating to watch them preparing for the evening concert. We did stay and watch the beginning before making our way to our tram. We

had obtained a free map of the city that had lines drawn down the streets indicating what trams went that way, and I still have it. Probably the routes have all been changed now!

We heard that a trip to a coal mine was on the cards, and not very far away, so we trotted off to the railway station to get some information. Turns I settled for out that the mine was In the the 'piers z town of Wieliczka just 8km kurczaka w away, and the trains ran quite bardzo frequently so we bought ostrym sosie tickets for the following day. Vindaloo' This world heritage site is a must see place for any visitors to Krakow. I had seen photos on the internet, but nothing prepares you for just how jaw dropping this place is. Almost as soon as you enter the mine you begin your descent down 380 steps to level 1.

Then you enter quite large tunnels where you begin the tour. It takes you through many tunnels and caves which are all subtly lit and contain many, many salt carvings. Leading down many easy



stairs and ramps, the highlight is the enormous cave at the deepest level of 160 metres.

It is like a cathedral with enormous chandeliers and exquisite wall carvings all fashioned in salt crystals. The mine no longer produces salt, but various artists were invited to carve these wonderful masterpieces. During the war, the Nazis gave it over to aircraft

> production. You completely forget how deep underground you are, but after another set of tunnels and staircases you arrive at the inevitable souvenir shop before being whisked to the surface in a modern dav lift. A half-an-

hour wait for a train and we were back in Krakow in time for another coffee in the square. We found out later there were plenty of tour buses we could have opted for at a third of the price!

The following day we saw a little more of the city when we visited what was the Jewish Ghetto during the war. We got invited into a Jewish museum next to a crammed cemetery, where we were asked to wear a 'kippah'. First time I've

had a kipper on my head! Later, we smelled out an Indian restaurant and through a doorway that still had the bullet holes from wartime weapons, we saw the sign Bombaj Tandoori and knew we were in the right place!

I settled for the piers z kurczaka w bardzo ostrym sosie Vindaloo' with 'ryz smazony' and Sally had the 'piers z kurczaka w sosie ze swiezego imbiru i ' Sounds delicious eh? And washed down with a bottle of Kurpiowsky. It was time to leave, and our next destination was in front of us, Zackopane in the Tatra mountains, on the Czech border. We settled for the site owner down in his anxiety to wave us into his field. We only had two other on a motorcycle and quickly got out spread them between a fence and their bike, and with their bedrolls under the 'awning' settled down to make a cuppa. These soldiers were very adept at

LATEST NEWS UPDATE

▶ A lot has happened in the last few months; a new Government, Brexit is now on course for the end of January and not least a new Chief Executive and structure at West Lindsey District Council. I am sure that many of you agree that it is time to put the Westminster in-fighting to one side and concentrate on moving forward, concentrating more on local issues.

The Neighbourhood Plan for Sudbrooke has passed the examiner's scrutiny stage and is going to the referendum, with voting taking place on February 13 at the Village Hall. Hopefully you have all received your polling card from WLDC. Voting is obviously a personal choice, but I would encourage you to vote in support of the plan.

It has taken a lot of time and hard work by many volunteers over the last three years to get to this stage. The plan, if voted for will protect and enhance your village for years to come. You will not be voting for a political party and when the plan is adopted by WLDC it will not change, even if the Government changes.

At the end of last year, the Head of Paid Services at WLDC retired, this position was not advertised and a new structure was put in place with the appointment of Mr Ian Knowles as CEO. The new structure will save money and hopefully increase efficiency through delegation and decision making from front line managers. Mr Knowles was formally the Executive Director of Resources and Finance and has been at the council for over seven years.

Applications for the renewal of garden waste through the Green Bin scheme can now be made on line through the WLDC website. The council is pleased to say that the cost for the scheme remains the same for the third year running, £35 for each green bin. The scheme has been a success with less now going into landfill. The first collection is March 26.

The West Lindsey Community Awards 2020 is now accepting nominations, with the closing date being Friday 6 March.

Do you know someone who goes out of their way to help others? Then don't let their hard work go unnoticed-nominate them for an award. There are seven categories; Contribution to the Environment, Young Citizen of the year, Good Neighbour, Contribution to the community, Contribution to Sports, Contribution to Wellbeing and Contribution to Arts and Culture. Campaign launched today aims to SCRAP fly-tipping in Lincolnshire

Lincolnshire has launched the SCRAP fly-tipping campaign today which aims to fight the blight of fly-tipping in the county and cut clear up cost.

The campaign reminds people to check their waste is being taken away for disposal by a licensed carrier – either by asking to see a Waste Carriers Licence or by looking up the company on the Environment Agency website.

Cllr Roger Gambba-Jones, Vice Chair of Lincolnshire Waste Partnership and portfolio holder for place at South Holland District Council said: "Fly-tipping is illegal, unsightly and pollutes our environment. There are lots of ways that people can legally get rid of the things they no longer want, so in addition to asking people to avoid giving their waste to rogue traders, the SCRAP campaign will be highlighting how people can dispose of items and stay within the law. We're urging people to follow the simple SCRAP code and are reminding people that if it's their waste it's their responsibility."

People can avoid an unlimited fine by following the SCRAP code:

Suspect ALL waste carriers Check with the Environment Agency on 03708 506 506 that the provider taking your waste away is licensed Refuse unexpected offers to have waste taken away Ask what will happen to your waste Paperwork should be obtained – get a full receipt

All of Lincolnshire's councils, the Environment Agency, Lincolnshire Police and Crime Commissioner are joining together to support the SCRAP fly-tipping campaign. SCRAP is based on an award-winning and successful campaign continuing to be developed by the Hertfordshire Waste Partnership and its partner authorities, with more joining all the time.

Stuart Hoyle, Waste Crime Engagement Specialist for the Environment Agency said: "The Environment Agency advises both businesses and the public to check on its website to see if a company or individual removing their waste has a waste carrier's licence. They should also ensure that the waste is being taken to an authorised site."


