PARISH MEETING OF SADBROOKE TO BE HELD ON THURSDAY 22 OCTOBER IN THE VILLAGE HALL, 7.30PM

All residents invited to attend to discuss the consideration of formulating a Neighbourhood Plan for Sudbrooke.

The draft Local Plan for Central Lincolnshire covering West Lindsey, North Kesteven and the City of Lincoln, setting out planning policy proposals for the growth and regeneration over the next 20 years, including proposed sites for new residential developments and other areas designated for protection will be out for public consultation from mid October for a period of six weeks.

Once finalised the policies within the Local Plan will make sure that our settlements grow in the right way, ensure we have homes and employment where we need them and our new communities are sustainable accessible and inclusive.

A public consultation event is due to be held at Cherry Willingham covering the Lincoln fringe villages in West Lindsey to enable you to have your say on the emerging plan and as a member of the planning committee I will be happy to answer any questions at the next two Parish Council Meetings in October and November. The Local Plan is due to be adopted in December 2016.

July 2015

Notes of the monthly meeting of Sudbrooke Parish Council held on Thursday 2 July in Sudbrooke Village Hall.

PRESENT:

Councillors Peter Heath (Chairman), Ian Russell, Andy Cottam, Mrs Lyn Etheridge, Mrs C Myers (Clerk), Mrs B Solly (Treasurer), PCSO Ross Payne, one member of the public.

APOLOGIES:

Councillors Miss Rose Dobbs, Stuart Curtis, Bob Waller and Paul Rignall.

That the reasons given for non-attendance at the meeting be accepted proposed by Councillor Mrs Lyn Etheridge, seconded by Councillor Andy Cottam and Resolved.

67) Parishioners Items

■ A letter had been received from a resident expressing concern about the untidy state of the Jubilee Garden. Members instructed the Clerk to request that the grass cutting contractors cut the shrubbed area to a shorter height.

A resident had reported that some trees planted in the verges on St Edward's Drive were either dead or dying. The Clerk was instructed to report this to LCC Highways.

The resident present at the meeting enquired about the Environmental Report requested for Sudbrooke Park, but was informed that this had not been received.

68) To Receive Declarations of Interest on any Item on the Agenda

■ Councillor Mrs Lyn Etheridge declared an interest in item 19(a) of the agenda as a resident of Sudbrooke Park - Proposed development, Sudbrooke Park, correspondence for and against gated access of West Drive from Scothern Lane.

69) Notes of Meeting held on June 4, 2015 for Approval

■ Proposed by Councillor Andy Cottam, seconded by Mrs Lyn Etheridge and Resolved that the notes be signed as a correct record of the meeting.

70) Police Matters

PCSO Payne was in attendance to speak about the recent anti-social behaviour in the village, which had resulted in vandalism in the Holme Drive area and broken glass in the Northfield Park play area.

PCSO Payne stated investigations were continuing and that patrols were being increased in the village.

71) County/District Councillor's Reports

- None received.

72) Report on Matters Outstanding

■ **a) Tree Preservation Orders in the village:** Councillor Ian Russell reported that he had been reviewing protected trees in the village and had identified a number of issues which required clarification. Councillor Russell offered to pursue the matter with the Trees Officer at WLDC.

Proposed by Councillor Peter Heath, seconded by Councillor Andy Cottam and Resolved that Councillor Ian Russell be in contact with WLDC on tree matters on behalf of the Parish Council.

■ **b) Strimming of public footpaths in village/Parish Paths Partnership:** The Clerk had reported FP 817 as not being cut by LCC and this was being followed up.

A proposed work form had been submitted to LCC Footpaths Officer, but rejected due to cost being too high. Re-submission for consideration would now have to be next year.

Discussion took place regarding surfacing some of the footpaths with woodchip or stone in order to improve them for use. Proposed by Councillor Andy Cottam, seconded by Councillor Peter Heath and Resolved that Councillor Ian Russell take this matter up on behalf of the Parish Council with LCC Footpaths Officer.

73) Highway Matter: Parking in Slipway at Scothern Lane/A158 junction

■ This matter was discussed following a letter to Councillor Stuart Curtis from a resident living close to the slipway, outlining concerns of parents dropping off/waiting in the slipway for the school bus and causing poor visibility to other motorists.

Members felt that this was a matter for the Police to deal with. However Councillor Peter Heath agreed to write an article regarding the problem for publication in the **Sudbrooke News**.

74) New Councillors Training Course: June 15, 2015

■ This course had been attended by Councillor Andy Cottam, with the Clerk attending for observation. Councillor Cottam explained that he had found the course useful and informative.

75) Consideration of Provision of Passive Speed Signs to be sited on Scothern Lane

■ This item was deferred until the next meeting of the Parish Council.

76) Request by Owner of Village Shop for Directional Sign to be Sited at Scothern Lane/Wragby Road junction

■ Unanimously agreed that the Parish Council have no objections to a sign at this location. The shop owner would, however, be required to approach LCC Highways for their permission and advice on the type of sign to be used.

77) Noticeboards – Work Required

- **a) Removal of board at Scothern Lane junction:** The Clerk was given authority to arrange removal and disposal of this notice board at a cost not exceeding £50.00.
- **b) Noticeboard on wall at Park Gates:** Councillor Ian Russell offered to remove and dispose of.
- **c) Renovation of board re-sited at Park Gates:** Councillor Peter Heath offered to renovate this board.
- **d) Treating of new notice board posts (Jubilee Garden):** Councillor Peter Heath offered to treat the posts. The Clerk would purchase the appropriate treatment.

Proposed by Councillor Mrs Lyn Etheridge, seconded by Councillor Andy Cottam and Resolved that all of the above be approved as stated.

78) CCTV Signs Sited at Village Hall

■ A resident had pointed out that in his opinion the CCTV sign at the front of the Village Hall was not clearly visible in the notice board and that signs should be displayed on all sides of the Hall.

It was noted that signs were currently on the kitchen side and to the rear of the Hall.

The Clerk was instructed to purchase three further signs in order for them to be displayed on all sides of the hall and the tennis court area.

Proposed by Councillor Peter Heath, seconded by Mrs Lyn Etheridge and Resolved as above.

79) Consideration by Parish Council for Registration with the Information Commissioner under the Data Protection Act

■ The Council considered registration due to the installation and holding of data connected with the CCTV and other items of confidential information.

Proposed by Councillor Andy Cottam, seconded by Councillor Ian Russell and Resolved that the Parish Council register with the Information Commissioner and that the Clerk be the contact.

80) Sudbrooke Sports Event: September 5, 2015

■ **Request for use of funds provided in budget for the event/volunteers from Parish Council able to assist:** Mrs Emma Chapman, having taken over the organisation of the sports event from Mr Mike Halliday, requested financial support for the event.

Members agreed unanimously to the release of the £250 budgeted amount for expenditure for this village event.

Councillors Paul Rignall, Stuart Curtis and Andy Cottam agreed to help with the event. Councillor Andy Cottam offered to assist with carrying out the Risk Assessment.

Members unanimously agreed the action of the Chair and Clerk and approved the expenditure incurred.

■ **b) Signage:** The Clerk was instructed to obtain a disclaimer sign for the play area.

■ **c) Renewal/repairs to post and rail fence at entrance to play area:** The Clerk was instructed to obtain quotations for the renewal/repairs to this fence. Agenda item for the next meeting of the Parish Council.

82) Consideration of Appointment of Temporary Village Handyman

■ It was noted that there were several maintenance jobs in the village that the current Handyman was not able to commit to at present. Proposed by Councillor Peter Heath, seconded by Councillor Ian Russell that the Clerk make enquiries locally to ascertain if any person was interested in being appointed on a temporary 'as and when required basis' to carry out light maintenance duties.

84) Planning

■ **a) Proposed development, Sudbrooke Park - correspondence received:** A letter had been received from a resident living on West Drive, suggesting that gated access could be sited at the Scothern Lane entrance to West Drive. Members felt that this was an item for consideration by the developer as the Parish Council had no responsibility for this stretch of road.

A letter had also been received from a 'Sudbrooke Park Residents Group', with no contact details of the actual sender being given. Members felt that they could not discuss anonymous letters.

■ **b) Informal meeting with Developer:** The Parish Council had requested an informal meeting with the developers, but this had been refused by them.

Members felt that another approach should be made to the developers as it was considered important to discuss their proposals and maximum benefits to be achieved for the village prior to any planning application being submitted.

■ **c) Planning Application - 133058:** Erection of a lean-to building to accommodate a bio mass boiler on conveyor system for burning of straw bales to heat poultry units - Grange Farm, Station Road, Langworth.

The application had not been able to be accessed due to the WLDC website being down and despite a request from the Clerk for a hard copy of the plans. The Parish Council were therefore unable to comment.

■ **d) Central Lincolnshire Local Plan:** Notification received that the next round of consultation will take place in Oct-Nov 2015, subject to the draft Local Plan being approved at Committee on September 7, this being a public meeting.

85) Chairman's Comments

■ The Chair stated that he wished to re-iterate that the Parish Council were neither for nor against a proposal for development within Sudbrooke Park.

Concern was also expressed by the Chair of the cost to the village for having to pay for repairs caused by vandalism.

■ **Donation of two benches to village by Plymouth Brethren Christian Church:** The Chair expressed sincere thanks to the Plymouth Brethren Christian Church for the donation to the village/ Parish Council of the two benches, one being sited on Beech Tree Corner and one near to the shop.

■ **Footpaths in village requiring maintenance:** Reports had been received that a continuation of resurfacing of the footpaths on St Edwards Drive was required as was Church Lane from the junction with Scothern Lane to the Church and areas on Scothern Lane. The Clerk would report to LCC Highways.

■ **Conclusion of External Audit of accounts for 2014/15:** The accounts had now been signed off by the External Auditor and Conclusion notices displayed.

■ **Appointment of Handyman for village:** Resident of Church Lane, Mr Bernard Bartram, has kindly offered to carry out small repair jobs/maintenance in the village with no charge for labour. Bernard has offered to plant some bulbs in the Jubilee Garden and expenditure of £20 was approved for the bulbs.

■ **Treating of carved posts and seats:** Mrs Coral Evans, leader of the Wood Carving Group, has kindly treated all the carvings with preservative.

■ **Planning application 133284 - Hybrid application comprising of Outline planning application with means of access to be considered for erection of up to 140 dwellings and a new building to replace the former Sudbrooke Holme to provide up to 25 apartments for retirement living. Erection of a new building to provide restaurant-public house. Extension and widening of West Drive and Holme Drive to serve the development, associated hard and soft landscaping and, demolition of existing poultry sheds. Change of use of land to provide a new area of open space including provision of new footpaths and sustainable drainage infrastructure. Change of use of land to provide new community allotment facilities, land adjacent Sudbrooke Park, Off West Drive.**

The Chairman explained that two public meetings had been held regarding this planning application and the feeling from those meetings was that residents were generally not in favour, although the survey carried out by the proposed developers did not significantly show this.

Points to take into consideration were:

► Core 10 Open Spaces/landscaping - ensure important nature conservation features are retained and seek to enhance the sites wildlife value.

- ▶ Strat 1 - All development must take full account of the need to protect environment
 - ▶ NB12 - Ancient woodland
 - ▶ NB8 - Historic parks/gardens - remains of Sudbrooke Park/Holme
 - ▶ The land to be transferred to the parish which was currently not accessible.
 - ▶ The increase in traffic which would be detrimental to the village, taking into account also the additional development in Scothern.
 - ▶ The wildlife survey appears to be flawed - there are Great Crested newts in The Park, the species of which is protected by law.
 - ▶ A large number of trees would be required to be removed from the area.
 - ▶ The Tree Survey made no reference to the 1988 or 2005 Orders.
 - ▶ The application lodged with Lincolnshire County Council on 20.12.2012 by the Parish Council for modification to definitive map and statement of public rights of way - claimed footpaths in Sudbrooke Park - was currently ranked 141 out of 160 in the County Council's list of priorities.
 - ▶ The Council voted to object to the application, with the exception of Councillors Stuart Curtis and Mrs Lyn Etheridge, both of whom had declared their interests in the application and took no part in the discussion.
- **Consideration of production of a Neighbourhood Plan for Sudbrooke:** A parish meeting to discuss this proposal has been arranged for Thursday 22 October 7.30pm in the village Hall, Sudbrooke, when two representatives of the District Council will attend to address the meeting.

SEPTEMBER WALK

■ Six walkers gathered on a dry pleasant day for the nine-mile circular walk from Rothwell village in the Wolds.

There is a significant climb on each side of Nettleton Beck valley compensated by the superb views from the tops of the Wolds.

The Humber Bridge is clearly visible to the north east from Rothwell Top and the walk passes quite close to the radar early warning station.

In Nettleton Beck we passed a number of blocked up tunnel mouths that once led to ironstone mines inside the hill.

His talk entitled "Apple Trees - Their Care and Identification", should be of interest to first-time apple tree growers up to and including custodians of established orchards. Cultivating

fruit can be particularly tricky in this region and Trevor can advise on all aspects of culture as well as suggesting which varieties to grow if you are considering planting new trees.

If your apple trees are suffering from pests and diseases, he can also offer advice on how to deal with them provided you can supply samples or photographic evidence of the problem.

Apple identification can also be done provided that examples are brought along on the night. Many gardeners lack confidence when it comes to pruning apple trees and Trevor can guide us through the principles and practice of this skill.

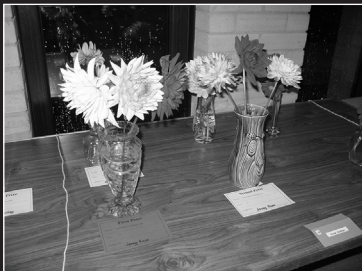
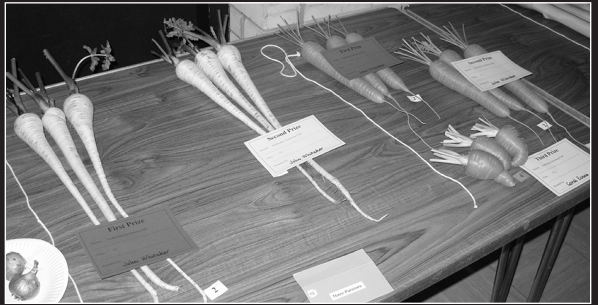

A TIME TO THANK THE UNSUNG

■ I suspect that we have all looked with horror at the recent images of men, women and children fleeing for their lives, crossing borders, placing themselves sometimes in the hands of unscrupulous people and being cast adrift on boats not fit to carry them.

So it is with refugees who have come to the end of their capacity to live with uncertainty, violence, war and who no longer wish to live in fear of what will befall them in their next moments.

If you are like me, you probably watch these scenes feeling powerless.

Now read this story...

...a boy went to the beach one day. In front of him were thousands of starfish that had been washed up on the beach with the tide. The boy looked at the pile, wondered what he could do and then, one by one he picked up a starfish, put them in his small bucket, ran to the edge of the water and put them back into the water.

A stranger walked down to the beach and watched him do this a number of times - he was puzzled by the boy's actions and went up to him and said 'you know, that's a huge pile - it won't make any difference'

The boy took three or four starfish put them in his bucket, took the man's hand and led him to the edge of the water. He took one starfish out of his bucket and placed it in the water, and then another and then another and as he put them back in the water he turned to the man and said and simply said 'it makes a difference to this one, and this one, and this one'.

When we feel powerless to change a situation it paralyses us. Yet we are not

powerless, we can make a difference.

What has been gratifying, however, has been to see individuals and groups organising collections of clothes, food and blankets to take to Calais and Greece; to see people offering homes to refugees.

We can talk all we want about the politics, about possible solutions and where the fault lies, but ultimately these are people like you and me who are searching

for things we all take for granted - freedom, peace, the opportunity to choose and to bring their children up in a place of safety.

It is not lost to me that we are about to celebrate harvest, to give thanks for the abundance that we all share, maybe we should spend some time appreciating and giving thanks for freedom, for peace.

It's not though, all about giving thanks, its also about giving and helping to improve the lives of other people.

Our harvest gifts this year are going to The Nomad Trust.

However, perhaps this year we can go another mile and give to one of the aid organisations that are working with refugees: Oxfam, Save the Children, Red Cross and UNHCR are all working on the ground to alleviate distress, to provide medical aid and to feed people.

It is estimated that there are eight million displaced people from the war in Syria and four million of them are now refugees.

This is a massive humanitarian crisis and we must take an opportunity to do something that will make a difference.

WORLD WAR I COMES TO SUDBROOKE

Local filmmakers turn farmer's field into No-Man's Land

WAG Screen is a Sudbrooke-based community filmmaking group dedicated to telling the stories of Lincolnshire's history and heritage.

In 2013, with the anniversary of the outbreak of the First World War approaching, we selected a war memorial and began researching it.

We found that the family of one individual, Robert Crowder, who died at Passchendaele aged just 21, had kept a remarkable archive of material including Robert's letters written from the front line.

Directed by Nick Loven of Crow's Eye Productions, we made a feature-length film 'Tell Them of Us'. Robert's story was based on his letters told from the perspective of his family at home.

We are now making a follow-up drama documentary on Robert's brother William, who received the DSO for his courage, and his wife Violet, who was a VAD nurse throughout the war. We have just filmed our final scene in Sudbrooke at Hall Farm with the help of Steven Wilkinson.

We turned one of his fields into No Man's Land in France 1918. It was a remarkable transformation.

The drama-documentary will be finished in time for Christmas.

Dear Editor,

A couple of letters in the September edition of **Sudbrooke News** addressed the publications by the Sudbrooke Residents' Action Group.

One of the writers thinks the photographs are rather exaggerated, but surpasses the alleged overstatement of these images by some imaginative hyperbole of his own, citing "Armageddon" and "a row of lorries from India"!

The same writer wonders why "*the residents were not aware that the woods and associated grounds were for sale in the first place.*" The writer seems not to know that the land was apparently the subject of a private sale between the former and the current owners - and the sale was therefore not advertised. To continue in the writer's idiomatic vein concerning stables and horses bolting, it would be like crying over spilt milk. And why was development "*always going to happen*"? There is a saying that nothing is certain in life but death and taxes.

The author of another letter feels "*that the full story is not being revealed*". I have read the literature put out by the Group most carefully, and nowhere do I find any claim that the land in question is not private. If attention was not specifically drawn to the fact that it is private, perhaps it was merely a case of not wishing to insult the reader's intelligence by stating the obvious! It is, however, true that paths may be claimed as public rights of way if they have been used for many years, as is the case in Sudbrooke.

The writer also says that the woods would pass into the ownership of the village if the development goes ahead. But I think the author is just being coy. Surely he means what's left of them?

I have also read the literature drawn up by the developers in support of their planning application, and I cannot find any reference to "*complete access*" to the woods, although they do have a great deal to say about a so-called "*series*" or "*network*" of paths stretching for "*nearly a mile*" (though it is not made clear

whether this "*mile*" includes the existing public footpaths or just the "*new*" ones). But just how ludicrous is the notion of "*a country pub/ restaurant which they [local residents] could visit after a day enjoying the proposed new footpath links around the Sudbrooke Woods*" (Integrated Planning Statement, page 15)? Probably the entire circuit could be completed by most people in well under an hour, unless they happened to take a detour via the "*outdoor gym*" - another promised "*amenity*" which will more than likely become a vandalised, rusting wreck and a hang-out for the drunks from the pub before many weeks have passed.

This letter goes on to state that "*it was only the indifferent attitude*" of the former landowner (incidentally, a long drawn out indifference which went on from the demolition of Sudbrooke Holme in the 1920s until 2012!) that allowed public access to the area at all. I have heard it said, though, that prior to acquiring the land the current owners were also quite happy to avail themselves of the very same freedom of access made possible by the "*indifference*" of their predecessors. Clearly, their change of attitude to this laxness has only emerged since acquiring it themselves.

As regards the writer's inclination to "*acknowledge the owner's right to use his land as he wants and within the law*" - again, I cannot find any claim to the contrary in the Group's publications. However, the comparison between a development of 140 houses plus 25 retirement apartments with the loss of swathes of woodland and "*laying a patio*" with the loss of a few shrubs is a singularly inopportune one - in the common phrase, it is like comparing apples with oranges.

The very law to which the writer makes reference dictates that if the owner wishes to use his land for a housing development, as opposed to a patio, he must seek planning permission in order to do so. The superfluity of further discussion of this point really IS self-evident!

REFLECTION CORNER

Where Sudbrooke residents can share their thoughts on life and living

ALEC C. CARROTTE ON FORGIVENESS

FOR many people, the concept of forgiveness can be a somewhat difficult area of inter-personal relationships. It also contains many potential 'twists and turns' within its definition:

To cease to blame or hold resentment against someone

To grant pardon for a wrongdoing

Collins Dictionary

So we can see from the above, that one person may feel aggrieved by the actions of another person. They can then choose to handle this grievance in two ways:

Firstly, they can choose to do nothing and live with it.

This option is not really desirable, in that it can lead to psychological consequences for the person who feels aggrieved (eg) anxiety, depression, feelings of failure and self-blame, feelings of impotence to effect change if a solution is not apparent.

Further, any such unresolved conflict may well have a severe effect if it involves the potential ending of what was once a close and loving relationship.

The second option is to try and seek a resolution. However, this route needs to appreciate several factors on both sides.

Questions for the 'aggrieved' person to consider:

- Am I being over-sensitive to the incident?
- Have I misinterpreted the incident?
- Do I demand a price for my forgiveness? (ie) an apology from the other person?
- Am I making demands on the other person so that I can feel superior and therefore a winner in the conflict?
- Although I accept their explanation (or apology if given) do I still want revenge, or can I let go of my former bitter feelings?

■ Do I want a 'climb-down' by the other person to make me look like 'the winner'?

■ Do I want a public apology to make me look righteous to others?

■ Do I still want to punish the other person?

■ Have I got it all out of proportion? (Was it a big hurt or a little hurt?)

■ Do I need a 'scapegoat' to take the blame for all the other problems in my life?

■ Can I forgive my own part in this conflict process?

■ Even though I have accepted the other person's explanation, can I forget their actions (bury the past) and forgive them?

■ If I forgive the other person, do I also want a reconciliation with them, whilst accepting that our relationship will possibly never be on the previous footing??

Questions for the perpetrator to consider:

■ Do I accept that there is a relationship problem?

■ Is what I have 'done or said' justified and therefore does not merit an apology or a retraction of my actions/statements

■ Do I want/need any forgiveness from the other person?

Question for both sides to consider:

■ Can we both explain our relative positions in a calm atmosphere of understanding and reconciliation?

■ Even if we both reach a congenial understanding, do we want a reconciliation whilst accepting that our relationship will possibly never be on the previous footing? (theory of homeostasis)

CRIME REDUCTION TIPS FOR STUDENTS

It's no surprise that, as a student you're easy prey for burglars and other criminals. Car theft, burglary and having a purse, wallet or bag stolen continue to be the most common crimes affecting students.

DON'T LET THEM STEAL YOUR DEGREE...

If your laptop's nicked, that's how many weeks of hard work gone? Save yourself the grief (and cost) by doing what you can to protect what's yours.

AT HOME

Lock your bedroom door, even if you're only going to the kitchen or bathroom.

Check doors and windows are locked at night or when going out, don't assume someone else will do it.

Make a list of your personal property including the serial number and descriptions, use an ultraviolet pen to mark electrical and other items with your university address and name of institution or your parent's postcode. Not only will it make it easier to trace stolen property but it can help police gain evidence about offenders.

PERSONAL SAFETY/THEFT

Think ahead, don't walk home alone late at night, arrange in advance to stay with a friend or pre-book a taxi. Never leave drinks unattended in pubs or clubs, when you dance or go to the toilet, ask a friend to keep an eye on your drink. Men's drink gets spiked too. If you think your drink has been spiked tell a member of staff or a trusted friend.

Try to go to the cashpoint in daylight if possible, be aware of people standing too close to you and always conceal your PIN.

If it's dark, go with a friend if you can and don't check your money in full view.

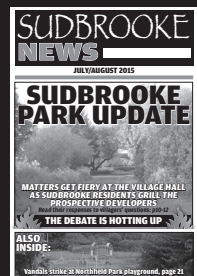

■ Public Health England has recently launched a new vaccination campaign for the Meningitis ACWY vaccination. The practice is currently inviting teenagers aged 17 and 18 (born between 1 September 1996 and 31 August 1997) for the vaccine. Where possible, it's important that anyone who plans to go to university this year gets vaccinated before they leave.

NAMED GP UPDATE

■ As part of the initiative to provide better support to patients the practice provided a named GP for all of our patients back in May 2015.

The named GP is, where necessary and appropriate, responsible for coordinating a patient's care with other health professionals. You are able to see any GP you would like at the practice and are not restricted to just this one GP. If you would like to know who your allocated GP is please ask at reception.

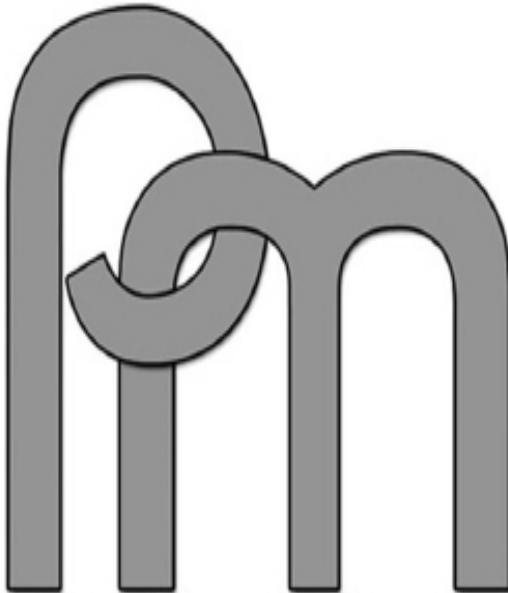

INFLUENZA VACCINATIONS

■ September will have seen one of our three drop-in 'flu clinics having already taken place.

In October there will be two further drop-in clinics for those that are eligible. These will be held on:

All pregnant women are also eligible and this can be discussed with your midwife or you can attend one of our 'flu clinics.

If you think you are eligible, please attend one of these 'flu clinics or speak to Reception to make an appointment.

If your child fits these criteria, please contact reception to book an appointment with one of our nurses.

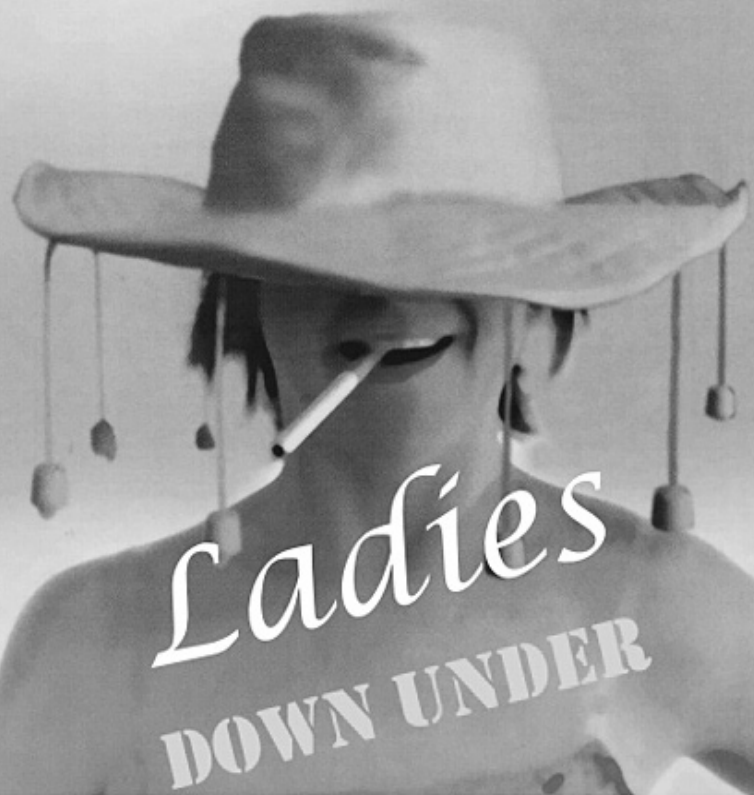
