

■ Councillors Paul Rignall, Mrs Lyn Etheridge, Bob Wallerm and Stuart Curtis declared an interest in Item 7a on the agenda, all as members of the Village Hall Management Committee - CCTV equipment at Village Hall.

A request for the statistics, particularly burglaries to be more specific to the road had been negative. Members instructed the Clerk to write again to the Police as the previous reply had been unhelpful.

5) District Councillor's Report

■ DC Stuart Curtis stated that there was a post code problem in Church Lane which was being dealt with.

6) Notes of Meeting held on March 5, 2015

■ Proposed by Councillor Martin Dickie, seconded by Councillor Paul Rignall and Resolved that they be signed as a correct record

PARISH COUNCIL MINUTES

7) Reports on Matters Outstanding

■ **a) CCTV equipment at Village Hall:** Councillor Martin Dickie had met with the contractor who had pointed out the necessity for the removal of two cherry trees to allow vision. Councillor Dickie offered to carry out this work and Councillor Peter Heath would assist.

Councillor Martin Dickie offered to follow the project to completion.

■ **b) Transporting of waste along West Drive – report of meeting with Environment Agency representative March 6, 2015:** It was considered that this meeting had proved useful. It confirmed that there were no restrictions on the carrying of waste by farm traffic on West Drive and that no Environmental Permit was required.

It was considered that the Parish Council had done all within its powers to ensure the matter was investigated and that the matter be now closed.

Proposed by Councillor Peter Heath, seconded by Councillor Martin Dickie and Resolved as above.

■ **c) Elections:** It was noted that closure of nominations was 4pm on April 9.

■ **d) Siting of notice boards:** The Clerk reported that she was arranging a site meeting regarding the installation of the new notice board and re-siting of the current board in the vicinity of the Park Gates. Once company approached were unable to assist. She would report back at a future meeting.

8) Tree Preservation Orders in the Village

■ Concern had been raised that current TPOs on Wragby Road, Sudbrooke, would not cover all the softwoods and this had been brought to the attention of the Trees Officer at WLDC. It was also pointed out that if softwoods were not included in TPOs the yew trees at the church might not be covered.

WLDC had supplied a TPO Plan. Councillor Ian Russell offered to meet with the Trees Officer at WLDC to discuss this matter further. Proposed by Councillor Stuart Curtis, seconded by Councillor Martin Dickie that Councillor Russell meet the Trees Officer and report back to the next meeting.

9) Best Kept Village Competition – Entry for 2015

■ Proposed by Councillor Martin Dickie, Seconded by Councillor Paul Rignall that Sudbrooke enter this competition at a cost of £20.00.

10) Slurry Sealing of Footways in Village

■ It was noted that areas of footpath on Scothern Lane had been slurry sealed, but not what was considered the worst area.

LCC Highways had confirmed that patching would occur in the meantime.

The Clerk was asked to report to LCC Highways that areas requiring attention were Manor Drive, Holme Drive and the stretch of footway from Church Lane junction to Manor Farm Courtyard.

■ b) **34 St Edwards Drive: Single storey side extension - 132438**

■ c) **Casa Grande, 65 Wragby Road: Erect ground floor extension to existing dwelling to include the conversion of existing garages into an annexe to be used in conjunction with the main dwelling - 132394**

Comments: Sudbrooke Parish Council have no objections to the proposed extension to the existing dwelling on condition that the conversion of the existing garages into an annexe must be ancillary to existing dwelling at all times.

Proposed by Councillor Martin Dickie, seconded by Councillor Bob Waller and Resolved that the comments above be submitted to West Lindsey District Council Planning Department.

17) Chairman's Comments

■ The Chair drew to the attention of the meeting that Councillor Martin Dickie was not seeking re-election. Councillor Martin Dickie was thanked for his work for the parish during the 14 years he had served as Councillor, eight of which he had been Chairman. Thanks were re-iterated by all members.

■ Community Facilities Advisory Service: It was noted that this concerned community buildings of which Sudbrooke Village Hall were members.

Request from Dominik Jackson, of Jackson and Jackson Developments, to meet with the Parish Council to outline updated plans for Sudbrooke Park. This would be an agenda item for the next meeting.

■ **Parishioners items:** A report was made of a motorbike revving loudly around the village during the hours of darkness. It was noted that the Police had been notified.

Mr Dominik Jackson had cancelled his attendance at the meeting when he was to outline his latest proposals for possible development in Sudbrooke Park. Members stressed that prior to an outline planning application being submitted for consideration, it was essential that a public meeting be held in the Village Hall so that residents are informed. The Parish Council agreed it needed to explore the benefits to the village that would be associated with any major development with the developer and as such would endeavour to contact Mr Jackson to find out his proposals.

SIGNIFICANT OTHER

Another special feature from Sudbrooke's resident philosopher

■ It will most likely have come to your attention that a popular 'relationship title' has emerged over recent times, namely that of 'significant other'.

Usually, this is used in general conversation as a gender-neutral way of describing a sole key person in one's intimate private life, thus replacing former titles such as spouse, sweetheart, lover, husband, wife.

However, when digging a little deeper, the singular title of 'significant other' may need to be extended to that of 'significant other(s)' when considering our intimate relationships over a lifetime.

The reason for this is that via divorce, separation or death we are highly likely to engage with more than one 'significant other' in our intimate relationships.

As we approach our later years, we tend to reflect on such people and come to recognise the contribution they have made (large or small) to our development and our 'way of being'.

Sadly, this appreciation sometimes occurs when it is too late to say 'thank you' as the people concerned were either only in our lives briefly, or are now deceased.

Nevertheless, the fact that we have 'finally and formally' recognised the contribution of significant others (past or present) to the quality of our lives and sometimes our life chances, is perhaps all they would ask of us.

BOUNDARY CROSSING

■ Yesterday I spent some time in church preaching about 'crossing boundaries'.

My thinking had been stimulated by the account of Peter, in the book of Acts, who was at the centre of probably the most monumental event in the life of the early church.

Peter, a Jew, 'crossed a boundary' by responding to the invitation of a Gentile, a non Jew, called Cornelius to tell him about Jesus. As a result Cornelius and his household came to faith.

The issue for Peter was that as a Jew, visiting the house of a Gentile would have made him 'unclean'. Peter brought up in the Jewish faith, would have spent his whole life believing that and yet, because he was convicted by the Holy Spirit, he crossed the boundary and went.

Peter risked a lot in this story including the hostility of his own people who believed that he crossed a boundary that should never have been crossed (the account of this comes later in the book of Acts). That has made me think a

lot. Crossing boundary lines is a difficult thing to do - it takes courage, it means stepping out - often alone, but Peter was able to do it because of the conviction of the Holy Spirit - for whilst this story is played out through people, the point of it is to describe to us how the purposes of God are accomplished in spite of the boundaries that we construct.

Boundaries help us to reinforce our identities as people - they can also segregate, but the Holy Spirit has something else in mind. He is working a powerful transformation among early Christians, challenging their perceptions and their belief systems.

Wounds of exclusion run deep through our culture and frankly they run deep in the church; the realities of uncrossed boundaries still exist.

The recent election has demonstrated and it will it take people of courage to cross boundaries that will bring about healing. The new Government, opposition, leaders in our society need our prayer as they face massive challenges to bring people together and set a healing tone.

LINCOLNSHIRE EMERGENCY BLOODBIKE SERVICE

■ LEBBS is a non-profit charitable organisation providing out of hours and weekend cover in order to transport medical items around the hospitals of Lincolnshire and the main blood bank centre at Sheffield Northern General.

It is run by a dedicated core of volunteers who give up their time to courier these medical supplies around the county. This, ultimately saves the NHS a large sum of money.

LEBBS is now linked to the National Bloodbike Service and all Riders are required to have an advanced riding qualification.

LEBBS has a fleet of bikes and a couple of cars (for the winter months of snow and ice) that have been kindly supplied following donations from local people, businesses and other groups like the Round Table for example. The riders fund their own petrol costs at the moment but, as donations rise, it is hoped to provide fuel cards.

The work is mostly at weekends with riders providing cover in the Lincoln and Boston/Grantham areas on a two-shift system involving day or night cover.

They are mobilised by a team of volunteer LEBBS Controllers who receive the calls from the local hospitals. Once the call comes in the riders mobilise to collect the package and transport it to the required destination.

The packages can contain anything, from blood and platelets, to medicines or even breast milk. Basically anything that will fit on



the back of a bike! Bloodbikes are all fitted with blue lights, but due to present legislation they cannot be used and the Riders have to observe all speed limits and other traffic regulations.

There has been talk of changes in the law to allow the use of blue lights; this would however mean extra cost for the additional rider training.

I have been a LEBBS rider for over a year now and find the work very rewarding (any excuse to get out on a bike!).

I have found it a natural progression after my retirement from the Fire and Rescue Service.

RE. SUDBROOKE PARK DEVELOPMENT

I note the letter in last month's **Sudbrooke News** requesting that the proposed development of Sudbrooke Park does not use Holme Drive as an exit/entry to the new housing estate.

The way this letter is written, it is assumed that this person approves of the planning as long as it doesn't use Holme Drive.

No matter which road is used - Holme Drive or Manor Drive or Main Drive - this development will have a huge detrimental effect on the village as a whole. Apart from the traffic problem of 200 plus cars trying to get in and out of the village and using Church Lane as a short cut, there are many other things to consider.

There is a considerable amount of new housing already passed and seeking planning permission in Welton, Dunholme and Scothern adding another 600 houses to these villages. All of these villages are served by two health centres.

Today I have spoken to a person who has tried to get an appointment for her child to see a doctor, only to be told there are no appointments this week! The local schools are over-subscribed, with Ellison Boulters having to extend upwards

to accommodate children. The children of Sudbrooke will not stand a chance of getting places at William Farr School - even a few years ago, several Sudbrooke children were refused places because a big school year moved the catchment area in.

Another big problem with the proposals is the destruction of Sudbrooke woods.

We are a very fortunate village to have such varied and beautiful habitat on our doorstep, which support a variety of wildlife and fauna.

Mr Curtis, in his letter to the **Sudbrooke News** states that in the event of development going ahead, 'existing wildlife habitats are fully protected'.

However, many of these habitats have already been destroyed as can be seen by the felling of trees and destruction of undergrowth. The promise of extra footpaths, fail to mention that most of these will be through a housing estate and shared with a possible 400 extra people!

Mr Curtis also states in his letter that 'only allotments and retirement homes have been suggested' as benefits people would like to see.

Perhaps nothing else has been suggested, because this development is unwanted?

DUNHOLME OLD SCHOOL COMMUNITY CENTRE

■ AFTER some consideration at looking at several options for the future development of the Dunholme Old School Centre, the committee has decided to revert back to their original development plans of 1995.

It was considered that any new buildings at the front of the old school would reduce the car parking at a time when we were anticipating greater usage. The proposal now is:

1) To remove the old canteen from the front yard, reduce the wall height and add railing, widen the vehicular access and add a new pedestrian

access on the right nearest the coop store. This will show the northern facade of the Old School as it did when built in 1864.

2) Carry out restoration work on the main building and extend the existing kitchen and toilets.

3) Remove the wooden annex building at the rear then build an additional hall which we hope to use for performing arts, dancing and music performances and will include offices, lecture rooms, club rooms to accommodate the existing users and any future users and add additional toilet facilities.

4) We would then use the existing main hall as a tea room, which, should our expression of interest prove successful, include a community Post Office at one end.

We have already employed Gelders, a local building and architects firm, to draw up some plans and to progress the outline planning to a pre-planning stage with the West Lindsey planning department.

However whatever we do now or in the future we will be taking into consideration the needs of the area of benefit. Our governing document, our constitution, lists the area of benefit as the residents of Dunholme and surrounding area. The trustees therefore wish to include all surrounding villages and conurbations in our development plan.

Therefore if any member of this enlarged community wishes to help in any way or has any ideas of how we should develop the Old School building or what additional facilities they would like to see, we will listen. Providing it meets all the requirements of our constitution, does not contravene the Charities Act or jeopardise our charitable status we will endeavour to implement those ideas if at all practical and financially viable. The trustees must always act reasonably and prudently in all matters relating to the charity and the charities income and property must be applied only for the purposes set out in our governing document.

It is not the intention of the Old School committee to provide facilities that already existed in the village or compete directly with any other group or organisation in the area.

At present the plans are only an outline, but the trustees and committee have several exciting ideas on the development which will be reported on in our July report. So please contact me if you have any of your own ideas which we can discuss and hopefully incorporate within the development.

MISSED APPOINTMENTS

■ The practice is continuing to experience a high number of appointments which patients do not attend (called "DNAs" for short). During April 2015, 11¾ hours of doctor time and 32 hours of nursing time were lost due to DNAs. If you are unable to attend an appointment that you have booked, please contact the practice and cancel so that it can be given to someone else.

ELECTRONIC TRANSFER OF PRESCRIPTIONS (ETP)

■ The practice successfully went 'live' with Electronic Prescriptions on May 13, 2015 (for more information please go to the ETP website - <http://systems.hscic.gov.uk/eps>).

How this will affect patients with repeat prescriptions depends on several criteria so below is a summary of what it actually means for you:

- Dispensing Patients - nothing will change for you at all and you will continue to request and obtain medications just as you do now.
- Non-Dispensing Patients - If you have nominated a pharmacy, your prescription will be sent to them and you will be able to collect your medication in the usual way two working days later.
- Non Dispensing Patients - If you have not nominated a pharmacy, you will need to collect your signed prescription from one of the dispensaries and then take to a pharmacy of your choice. You can nominate a pharmacy of your choice at any time (and change the pharmacy) by letting the dispenser at the practice know who will update your records at the practice.

If you are issued an acute prescription, this may be sent via ETP but you will need to allow at least 2 hours for the prescription to be available to download at the pharmacy.

If you require a medication that is not on your normal repeat list or the medication is a hospital request, please allow us 24 hours to process your request.

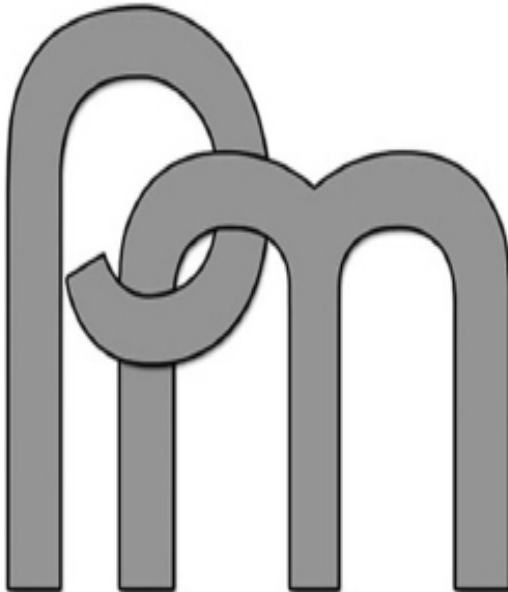
DNAs (Did Not attends) in April amounted to 11 hours of clinical time lost due to patients not

CONTROL OF HORSE ACT GUIDANCE

■ The Control of Horses Act 2015 received Royal Assent on 26 March. This act, which amends the Animals Act 1971, is intended as a strong deterrent against so-called “fly-grazing” of horses and other equines by improving the remedies available for the timely detention and disposal of horses unlawfully present on public and private land. It will become operative on May 26, 2015.

Under the Control of Horses Act 2015, local authorities may detain horses present on public land without lawful authority, and occupiers and freeholders may do the same on private land, so long as the officer in charge of a police station is informed within 24 hours, as well as the owner of the horse – if known.

The owner of the horse is liable for any damage done by the horse to land or property, and for expenses reasonably incurred in detaining the horse.

If the horse is not claimed within four working days, ownership passes to the person detaining horse, and they may dispose of it by selling it, arranging for it to be destroyed, or in any other way including through gifting or rehoming.

Hitherto, horses detained under the Animals Act 1971 could only be sold at market or by public auction.

Additional guidance for local authorities is expected to be released from both the National Animal Health and Welfare Panel before the act comes in to force on 26 May.

three rounds during May, June and July and a final is held later in the year between the highest scoring clubs.

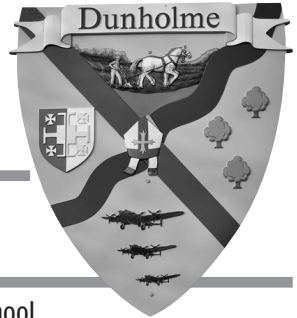
Our first round (and first meeting in June will be on the June 11, starting at 7.30 so come along and see some great images.
