PARISH COUNCIL MINUTES

September 2015

Notes of the monthly meeting of Sudbrooke Parish Council held on Thursday 3 September in Sudbrooke Village Hall.

Councillors Peter Heath (Chair), Bob Waller (Vice Chair), Paul Rignall, Ian Russell, Stuart Curtis, Andy Cottam, Mrs Lyn Etheridge, Mrs C Myers (Clerk), Mrs B Solly (Treasurer) and 14 residents

That the reasons given for absence be accepted proposed by Councillor Mrs Lyn Etheridge and seconded by Councillor Bob Waller.

89) Parishioners Items

■ A resident of Courtfield Close drew attention to trees between Courtfield Close and Holme Drive overhanging her property. These would be reported to LCC Highways by the Clerk.

■ A resident asked for clarification on the suggestion in the draft Lincolnshire Plan that several villages be moved up the settlement hierarchy, amongst them being Sudbrooke from 'Small Villages' to 'Limited Growth Villages'.

Councillor Stuart Curtis answered the query in that Sudbrooke is intended to be designated as a medium Village under the Settlement Hierarchy which will accommodate a limited amount of development and will be permitted to grow by 10 per cent over the Plan period.

■ It was brought to the attention of the meeting that trees which may be protected had been cut back at a property on Wragby Road. The Trees Officer at WLDC had been notified.

■ It was stated that a large number of HGVs were using Church Lane and suggested that it may be appropriate to request signage by LCC Highways for a 7.5tonne limit. Agenda item for next meeting.

91) Declarations of Interest on any Item on the Agenda

■ Councillor Mrs Lyn Etheridge declared an interest in item 15 of the agenda - Planning Matters - planning application 133284, as a resident of Sudbrooke Park.

Councillor Stuart Curtis declared an interest in item 15 of the agenda - Planning Matters - planning application 133284 as Chair of WLDC Planning Committee.

92) Notes of Meeting held on July 2, 2015 for Approval

■ Amendment - Minute 72b third paragraph - after 'woodchip' add 'or stone'. Subject to the above amendment, proposed by Councillor Ian Russell, seconded by Councillor Andy Cottam and Resolved that the notes be signed as a correct record of the meeting.

94) County Councillor's Report

■ CC Mrs Sue Rawlins sent a report stating that Welton Library would close on September 30, 2015, but would re-open under the Volunteer Libraries Group.

95) District Councillor's Report

■ DC Stuart Curtis explained that Sudbrooke is intended to be designated as a medium Village under the Settlement Hierarchy which will accommodate a limited amount of development and will be permitted to grow by 10 per cent over the Plan period.

Only sites for development of 25 dwellings or more will be shown as allocated sites on the Local Plan for Large Villages. The Lincolnshire Plan will not be adopted until at least the end of 2016 after all objections have been considered by the Government Planning Inspector.

In the meantime all planning applications have to be determined under the existing West Lindsey Local Plan 2006 and National Planning Policies. This is why over the last couple of years there has been a flood of applications by developers trying to get permission before the adoption of the new Plan. However, during the next 12 months the existing Plan is expected to lose weight and the new Plan gain weight on policies which have to be considered by the Planning Committee.

96) Report on Matters Outstanding

■ **a) Tree Preservation Orders in village:** Councillor Ian Russell explained the value of the current TPOs in that there was no change to the 1950 Orders or 1988 Woodland - all species within that area are protected. If trees are taken down under licences there would be no protection on their replacements.

It was noted that the Trees Officer had visited the site on Wragby Road proposed for six dwellings with a view to placing protection orders on trees on the site.

b) Strimming of public footpaths in the village: It was reported that FP816 was overgrown and not passable. The Clerk would report to LCC.

c) Donation of two benches to the village by Plymouth Brethren Christian Church: The Chair expressed sincere thanks to the Plymouth Brethren Christian Church for the donation to the village/Parish Council of the two benches, one being sited on Beech Tree Corner and one near to the shop. The Clerk was instructed to add these to the Parish Council insurance schedule.

d) Appointment of Village Handyman: Mr Bernard Bartram, resident of the village had kindly offered to carry out small jobs in the village at no charge for labour. This was acknowledged with thanks by the Chair.

Mr Bartram had offered to plant a small selection of bulbs in the Jubilee Garden. Expenditure of £20 for the bulbs was agreed, proposed by Councillor Paul Rignall, seconded by Councillor Andy Cottam. The Clerk to purchase.

e) Cutting of hedge, Sudbrooke /Nettleham Lane: The Clerk was asked to write to Truelove Property and Development asking if the cutting of the hedge in this location would be taking place prior to the winter.

f) Sudbrooke Sports Event, September 5 – update of arrangements: The following was noted:

- Councillor Andy Cottam would complete the Risk Assessment on behalf of the Parish Council prior to the event.
- The pitch had been marked out.
- The organisers reported that they expected to have a surplus of funds from the £250 awarded for the event.

97) Consideration by Parish Council of Passive Speed Signs to be sited on Scothern Lane

■ Six speed signs were available from the Lincolnshire Road Safety Partnership at a cost of £40 licence fee.

Councillors Bob Waller and Paul Rignall offered to complete the necessary application form for suggested sites of the signs.

Proposed by Councillor Paul Rignall, seconded by Bob Waller and Resolved as above.

98) Community Wildlife Grant – Wild Flowers

■ It was noted that the previously planted plug plants had not grown successfully.

To make a display of wild flowers in the Jubilee Garden it was considered that an area should first have weed killer applied and the soil prepared for seeds. Costing for this was approximately £150 for which it was hoped that a Community Wildlife Grant would be available.

That the grant be applied for as above proposed by Councillor Peter Heath, seconded by Councillor Paul Rignall and Resolved.

99) Highway Matters – Footpaths in Village Requiring Maintenance

■ Reports had been received that a continuation of resurfacing of the footpaths on St Edwards Drive was required as was Church Lane from the junction with Scothern Lane to the Church and areas on Scothern Lane. The Clerk would report to LCC Highways.

100) Footpath Between Main Drive and Fox Covert – Consideration of Maintenance

■ Comments had been received that this footpath required some maintenance. The Clerk was asked to obtain quotations for gravelling/stone chipping the pathway.

101) Northfield Park Play Area – Renewal of Fencing

■ Two quotes had been received – Company A - £130.00; Company B - £150.00.

Resolved unanimously that Company A quotation from Glendale Countryside – be the successful quotation.

102) Review of Parish Council Communications Protocol

104) Planning Matters

■ **a) Planning application 133284: Hybrid application comprising of Outline planning application with means of access to be considered for erection of up to 140 dwellings and a new building to replace the former Sudbrooke Holme to provide up to 25 apartments for retirement living. Erection of a new building to provide restaurant-public house. Extension and widening of West Drive and Holme Drive to serve the development, associated hard and soft landscaping and, demolition of existing poultry sheds. Change of use of land to provide a new area of open space including provision of new footpaths and sustainable drainage infrastructure. Change of use of land to provide new community allotment facilities, land adjacent Sudbrooke Park, Off West Drive.**

Note: Parish/District Councillor Stuart Curtis was present at the meeting, but did not convey any verbal or written opinion as to the merits or otherwise of the scheme recorded below. Councillor Mrs Lyn Etheridge took no part in the discussion.

The Chairman explained that two public meetings had been held regarding this planning application and the feeling from those meetings was that residents were generally not in favour, although the survey carried out by the proposed developers did not significantly show this.

Points to take into consideration were:

Core 10 Open Spaces/landscaping - ensure important nature conservation features are retained and seek to enhance the sites wildlife value.

84) Planning Matters cont

Strat 1 - All development must take full account of the need to protect environment

NB12 - Ancient woodland

NB8 - Historic parks/gardens - remains of Sudbrooke Park/Holme

The land to be transferred to the parish which was currently not accessible.

The increase in traffic which would be detrimental to the village, taking into account also the additional development in Scothern.

The wildlife survey appears to be flawed - there are Great Crested newts in the Park, the species of which is protected by law.

A large number of trees would be required to be removed from the area.

The Tree Survey made no reference to the 1988 or 2005 Orders.

The application lodged with Lincolnshire County Council on 20.12.2012 by the Parish Council for modification to definitive map and statement of public rights of way - claimed footpaths in Sudbrooke Park - was currently ranked 141 out of 160 in the County Council's list of priorities.

Recorded vote taken - Against the application Councillors Peter Heath, Bob Waller, Andy Cottam, Paul Rignall and Ian Russell.

The Clerk and Chair to formulate a response against the application taking into account the above points, to circulate to all members, with the exception of Councillor Stuart Curtis, prior to forwarding to the West Lindsey District Council Planning Department.

b) Planning applications brought to members' attention throughout August and comments forwarded to the WLDC Planning Department by the Clerk under delegated authority:

i Application 133193: Tall Trees, 32 Scothern Lane - demolition of existing dwelling, erection of one replacement dwelling and two additional dwellings - No objections to a replacement dwelling, but feel that only one dwelling should be built in St Edwards Drive to maintain the density of adjacent properties and street scene. If permission is granted it is suggested that it is a condition that the developer completes a footpath along that stretch of St Edward's Drive linking with Scothern Lane.

It should also be noted that the frontage on Scothern Lane includes protected trees, some of which have already been felled. The remainder must be retained. It is noted that there is no reference to protected trees in 13 or 15 of the application, though there is reference to TPOs on the Design Statement.

ii Application 133250: Barbers Garage, Wragby Road - Extend existing brick vehicle workshop with a steel portal framed building to the rear for the incorporation of a new MOT testing station lane - No objections.

iii Application 133185: 3 Maple Drive - single storey and two storey rear extension including removal of conservatory - No objections.

c) Consideration by Parish Council of production of a Neighbourhood Plan: The Chair stated that he was disappointed that an unknown resident had invited a member of the District Council to this meeting in order to speak about the production of a Neighbourhood Plan. The Chair stressed that it was the Parish Council to decide who it invites to address it.

Standing Orders were however suspended at this point during the meeting to allow a resident to speak on the benefits to the parish of a Neighbourhood Plan.

Members agreed that two representatives of West Lindsey District Council could be invited to a parish meeting to address those present on the production/cost/grants available and work involved. It was hoped that this could be arranged towards the end of October 2015.

105) Chairman's Comments

■ The Thanks were extended to Mrs Coral Evans for treating all the carved seats/posts. Item for next meeting would be re-considering a window for the bus shelter on Wragby Road.

Brief report of meeting held on October 4, 2015

■ **Police Report:** PCSO Jackie Parker attended the meeting and reported on the following:

- The Police would be monitoring the report of cars waiting in the slipway on Wragby Road whilst waiting for the school bus.

■ **Footpath between Fox Covert and Main Drive:** Quotations were being sought for work to this footpath.

■ **Best Kept Village Competition:** The Judges' comments had been received and are published in this issue of **Sudbrooke News**. Sudbrooke had proceeded into the second round of the competition.

■ **Maintenance in village:** The Chairman extended sincere thanks to Bernard Bartram who had carried out repairs to the village map frames, planted bulbs in the Jubilee Garden and painted the seat on Wragby Road near to the Park Gates. It is hoped to renovate the Silver Jubilee Seat on Wragby Road.

■ **Overhanging hedges in village:** It was reported that although many residents had trimmed back their hedges to avoid overhang onto the footpaths there were still some hedges that required cutting back. Residents are respectfully asked to have a look at their hedges and shrubs to see if they do in fact make it difficult for persons to walk side by side on the footpaths.

■ **Parish Meeting October 22, 2015:** This meeting has been called so that two representatives from West Lindsey District Council can give an address about the production of a Neighbourhood Plan. The Parish Council will then make a decision at its next meeting as to whether one should be produced for Sudbrooke.

OCTOBER WALK

■ Fifteen walkers gathered in sunny weather for the eight-mile walk from Sutton-on-Sea.

On the outward journey we passed several dwellings which had been constructed using former railway carriages.

We then proceeded via Acre Gap (currently a flood relief area) and then along a section of the route of the former Sutton to Willoughby railway line that was opened in 1887.

Peak passenger numbers totalled 166,000 in 1936 and the line was closed by British Rail on October 5, 1970.

Whilst returning via Huttoft Bank, we were lucky enough to be able to closely observe a female Goldcrest (Britain's smallest bird).

A three-mile walk along the sea wall brought the group back to Sutton, where we all enjoyed a fish and chip meal at Waldos restaurant.

APPLE TREES - THEIR CARE AND IDENTIFICATION

At our October meeting, members and visitors were presented with a very interesting talk by Trevor Rogers, a renowned fruit growing consultant and horticultural specialist, currently working on a voluntary basis at nearby Gunby Hall.

It was surprising to learn that there are approximately 2,000 varieties of British apples, whilst world-wide the figure rises to 7,000. Current scientific thinking is that British apples originated in Central Asia, particularly from Southern China, where growing conditions are ideal - hot summers and cold winters.

The lecture covered all aspects of apple growing, particularly stressing the importance of spending sufficient time investigating which

varieties to grow in your area; selection of the correct root stock; preparation of the ground; the use of proper adjustable tree ties; pruning after planting; the importance of correct pruning and training, as well as the necessity of Spring feeding all fruit (with the exception of strawberries which require a September feed).

Trevor answered lots of questions from the audience and also identified several apple varieties which had been brought to the meeting. He also displayed a colourful array of apples grown at Gunby Hall to show which varieties grow well in Lincolnshire.

OUR HEROIC CARERS

■ So I think I should begin this blog with a bit of a 'rant' warning. I am about to sound off - sorry - but maybe you might feel as strongly as I do about this issue...

I have a lot of contact with the care system. My mother has been in a nursing home (not locally) for 15 months, and I visit twice a week. I visit nursing homes in the course of my work.

My mother received care at home prior to becoming too ill to stay at home. I am not a professional in these matters, largely I am a grateful relative who sees what carers have to manage and cope with on shifts lasting 12 hours. Trust me I couldn't do that job - you need the patience of a saint, the energy of a Duracell battery (other brands are available), the ability to multi-task, organise, record every detail, spot when someone is low, make sure that people feel loved and valued and generally be a saint.

Yes there may be a few out there who don't show the compassion needed, but honestly, most I have come across are amazing people who work really hard and do their best in sometimes trying circumstances... but what value do we place on them?

I have just watched a programme on the TV that has described the conditions that some carers have to operate under.

As austerity bites, as Local Government funding is cut and as the demands on the care

system grow, it seems to me that we have to begin to make some difficult decisions about the value we place on care and the people who deliver it.

We cannot expect people to work for a minimum wage and pay the cost of their travel to go from house to house. We can't continue to put so much pressure on people who work in the care system that they give it up because it is too stressful and there are too many demands. We rely on these folk to look after our loved ones, people who are precious to us, and they look after the vulnerable who have no-one else to care for them. We have to value that highly don't we?

I guess we have very little control over the big issues. Decisions made at government level, funding issues, but there is one thing we can all do - if we know a carer, or if we have someone who is cared for by others - then say thank you, often, and tell them how high a value you place on the work they do.

That's also making me think about the army of carers out there who are looking after their own loved ones, many of whom give 24x7 care and frankly never get a break or have time to themselves. If you are one of those people I would like to hear from you - what can we do to support you? What would help? Call me or email me - my details are at the top of this blog.

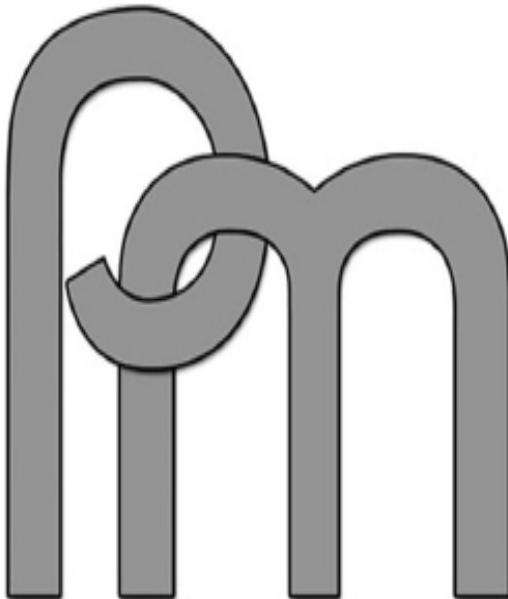

Dear Editor,

THE centrefold showing a reconstruction of trench warfare during the First World War by WAG Screen, a Sudbrooke-based community filmmaking group, in October's **Sudbrooke News** is both moving and dynamic. The production of our magazine goes from strength to strength in its coverage of local news, events and issues.

I was also moved by the September extraordinary meeting held by the Parish Council to discuss the application for the proposed development in Sudbrooke Park, when a gentleman spoke with such eloquence and feeling about the joy and pleasure he finds when walking through the Park, the heart of Sudbrooke, and without it the village would lose its character and identity.

He echoed my own view that it would be more constructive for any new development to take place around the area of Church Lane - thus uniting the village. The audience was equally moved as shown by their heart-felt applause.

At the same meeting, Mr Bakovic, who is the planner looking at the validity of the scheme, spoke with clear and expert statements, and his considerate, dignified dialogue with the residents of Sudbrooke, made me feel that, despite 18 months of discussions between the developers, WLDC and our Parish Council, that this was the first time that we, as residents, had been heard and understood.

Fortunately, with the exception of two interested parties, our Parish Council have noted that residents were generally not in favour of the scheme and they have voted unanimously to object to the application for the proposed development of Sudbrooke Park for the stated (see **Sudbrooke News** October 2015).

Although he is not in a position to comment, we may now have the support of our District Councillor, whose election pledges included support for both Scothern and Sudbrooke to be designated as a small village in the emerging

Central Lincolnshire Local Plan where development will be of a limited nature as well as aiming to preserve existing woodlands and wildlife and to register established footpaths in Sudbrooke Park.

Certainly, our Parish Council has supported both these issues, as shown in the minutes (**Sudbrooke News** November 2014) by unanimously voting that Sudbrooke remains designated as a small village together with a wish to register the existing woodlands and lakes in Sudbrooke Park as Local Green Spaces.

However, a significant change has been made in the Central Lincolnshire Plan in that Sudbrooke is now described in the settlement hierarchy as a medium-sized village with limited development (10 per cent increase in housing ie 70 new dwellings).

This change can be queried at a public consultation event at the Church Hall, Cherry Willingham on Friday 6 November, 2-8 pm.

The Localism Act, which was introduced by the Government in November 2011, giving communities more say over developments in their area, and bringing in new powers for local people to make their own funded Neighbourhood Plans.

There are many residents in Sudbrooke with excellent skills who would be willing to give their time and energy for the benefit of the village. A funded Neighbourhood Plan would enable the residents to give their unbiased opinions about the future of Sudbrooke.

Lastly, I would like to thank all those involved in the excellent Harvest Festival weekend at our Parish Church.

The concerts and talks were interesting, entertaining and moving. We certainly have a caring and talented community.

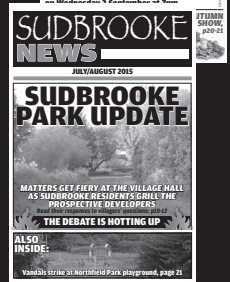
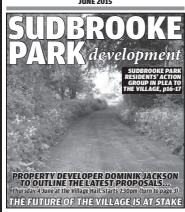

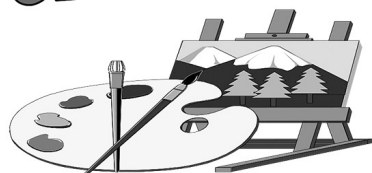

INFECTION CONTROL

■ This time of year at the surgery we are always busy giving vaccinations, and lots of them!

Flu vaccines definitely take the lead with over 1000 doses being given to adults and young children. We also give vaccinations against shingles and pneumonia to vulnerable adults, as well as all the routine childhood vaccines.

In fact, despite all that we hear about NHS cutbacks, we now vaccinate more people against more diseases than ever before. There is a lot more that we need to do to reduce the spread of infection however, there is a change coming up that parents need to know about.

TOYS

■ After a great deal of thought, we will be removing toys from our waiting room from the beginning of November. We would like to explain why. Imagine this scenario:

Child A wakes up one morning with a nasty sore area under his nose. Mum thinks that this is caused by his cold, so books him in at the surgery. While he is waiting, the child picks up a toy, and has a good old chew. When the nurse sees him, she immediately realises he has impetigo, and gives him some treatment.

In the meantime Child B has come with his Mum, who has attended for a routine appointment. Child B is perfectly healthy, so she too has fun with the toys. Two days later, she wakes with a sore under her lip...

Now imagine the same scenario if the child had something more serious. We do of course clean the toys daily, and sometimes during the day too, but we just can't clean them between children.

We realise that children share toys at pre-school and school, but we feel that surgery toys are different. After all, we want you to bring your poorly children into us!

We really hope you understand therefore, why we are making this step, and will support us in this. We do try to keep waiting times down, but still we know that at times you may have a long

wait. Please come equipped with toys etc... to keep your own child amused and safe!

INFLUENZA VACCINATIONS

■ Hopefully by the time you read this we will be well on our way with vaccinating those “at risk” patients. For those that have not be able to attend the Saturday drop in clinics we will now start to offer selected appointment slots where possible.

PLEASE NOTE - we will not routinely write to patients to remind them as we have done in the past. If you would like a vaccine and think you are eligible please contact the surgery as soon as possible to book in for this.

DNAS (DID NOT ATTENDS)

■ In September, there were a total of 108 appointments that patients did not attend for. This was made up of 45 doctors' appointments and 63 nurses' appointments totalling 18 hours of clinical time.

We appreciate that at times patients may forget an appointment or have an emergency that prevents them from attending however; we would appreciate it if you could let us know if you are unable to attend so that someone else can make use of the appointment.

DISPENSARY

■ A reminder that it is possible to order repeat prescriptions online, 24 hours a day. If you do not currently take advantage of this service please see Reception for more details on how to sign up.

As stated in last month's newsletter, the Dispensary hatch will now close between 1pm and 2pm, but the usual opening / closing times will remain the same.

MENINGOCOCCAL B VACCINATION

■ From September 1, 2015 the Meningitis B vaccination has been added to the Childhood Immunisation Programme in England. The programme is for all infants born ON or AFTER 1st May 2015 and consists of three doses at 2, 4 and 12-13 months. If your child fits these criteria, please contact Reception to book an appointment with one of our nurses.

GP REGISTRARS

■ We are pleased to say that we currently have two GP Registrars with us in the practice, Dr Cheryl Mensah and Dr Maryam Tukur.
