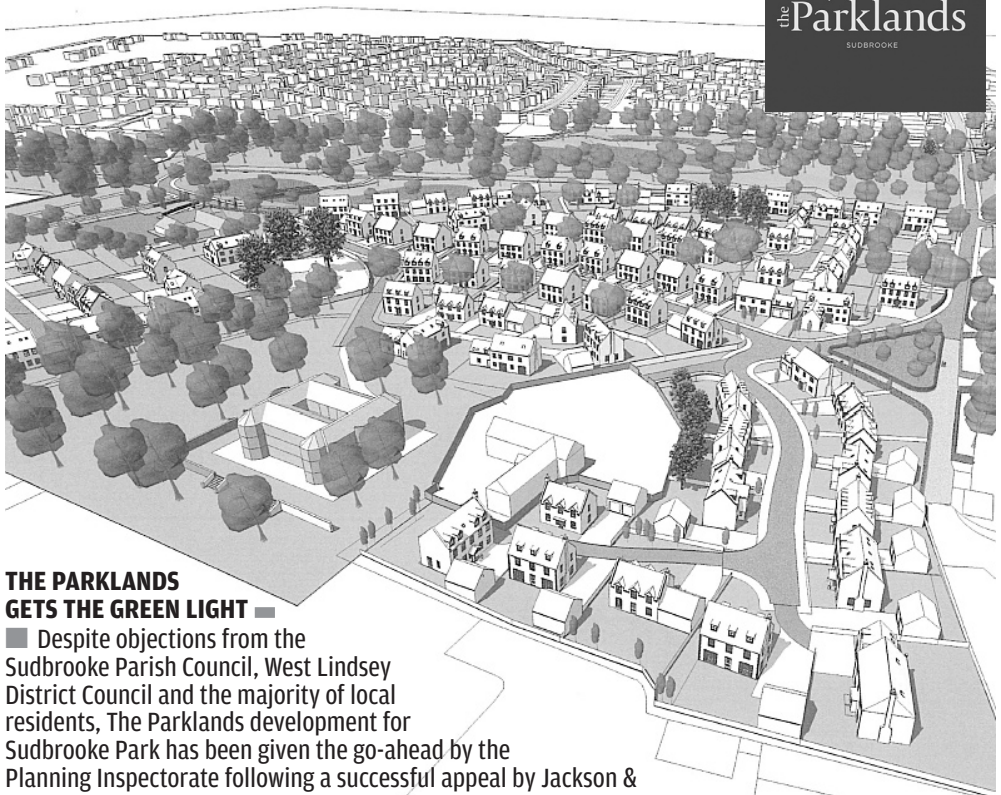

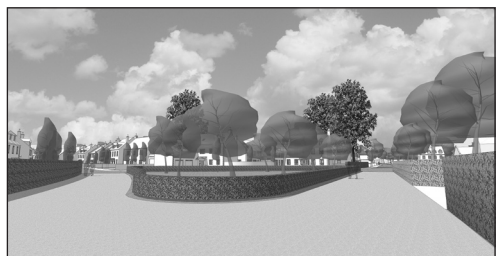
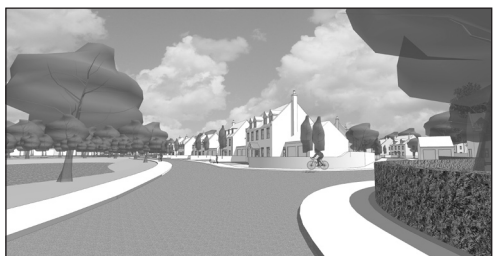


THE PARKLANDS GETS THE GREEN LIGHT

■ Despite objections from the Sudbrooke Parish Council, West Lindsey District Council and the majority of local residents, The Parklands development for Sudbrooke Park has been given the go-ahead by the Planning Inspectorate following a successful appeal by Jackson & Jackson Developments and Globe Consultants.

An initial plan of 140 homes – since reduced to 130 – and 25 retirement apartments, as part of a new Sudbrooke Holme complex, along with a pub/restaurant, allotments, and the creation of new footpaths and access roads, has been handed the green light, although work on the project is not expected to be undertaken for a few months yet.

The developers appealed to the Planning Inspectorate after they claimed the WLDC had not made a decision within the statutory timescale and now they are ready to put their plans into action.

STATEMENT FROM DEVELOPER DOMINIK JACKSON

■ It's early days in the process and we'll have a clearer plan over the coming one-two months. However, our attitude will not be changing with regards to:

Village Communications: Since last week's planning decision, we have already met with members of the Parish Council to reiterate that we're here to see the site through. As part of this process, we value the local communications and will look to the Parish for steer on items which are open to discussion, e.g. whether there's a demand for bungalows, if so how many bedrooms? What type of gym equipment people would find most useful for the outdoor gym set-up, etc...?

Trees: We assigned a specialist in Delta Simons to ensure as many trees as possible remain, the instruction is to keep removals to an absolute bare minimum. We share the village's view that the environment should be disturbed as little as possible. On this subject, we're appointing an award-winning landscaper for the site.

Construction Access: We're discussing access routes for deliveries with the surrounding landowners to reduce/remove any disturbance to the village.

Poultry Sheds: We're working towards the schedule for their removal.

Woodland Access: We will be standing by our original proposal and attitude towards the woodland, ensuring that the pathways and access points are started in the first portion of any works.

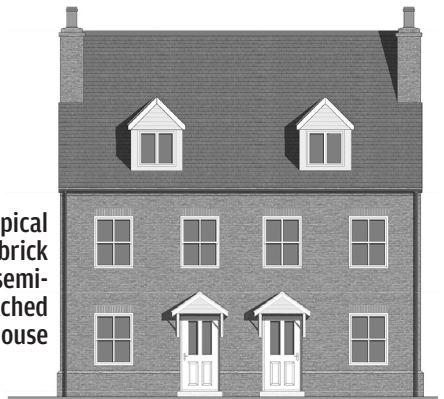
Retirement Dwellings: We'd like to work with the village in terms of how any possible over-55 units are offered to the market, ensuring that any local interest is dealt with first.

Starter Homes: We want to ensure that the affordable housing provided responds to local needs and that the housing is for local people. We understand that the biggest need is for starter homes and the scheme will offer opportunities for people to make that all important first step on the property ladder by delivering a number of properties at reduced prices. These properties will be available exclusively to people aged 23-40, with preference given to those who live or who grew up in Sudbrooke. These homes will form a key part of discussions with West Lindsey and the local community moving forwards.

This is a very early view, however, we felt it was important to ensure all that this will be a different situation versus a national/faceless house builder.

STATEMENT FROM WEST LINDSEY DISTRICT COUNCILLOR STUART CURTIS

■ I was devastated by the fact that the Government Planning Inspectorate has granted on appeal residential development in Sudbrooke Park.

Our views on the harmful impacts of this proposal on the parkland, including the loss of hundreds of trees and damage to the historic natural environment have not been given the sufficient weight that we feel they deserved. Our view strongly remains that the adverse impacts of development would significantly and demonstrably outweigh the benefits of development and does not meet the National Planning Policy Framework (NPPF) presumption in favour of sustainable development.

I am also deeply concerned that no objections to the proposed development were made by our main Statutory Consultees - Highways Authority, NHS (England), LCC (Education) and the Environmental Agency (apart from asking for minor conditions).

All planning applications are determined on existing Planning Policies (West Lindsey Local Plan, Central Lincolnshire Local Plan and the NPPF) and also on material considerations which include highway safety, traffic generation, loss of trees (protected or otherwise), nature conservation, biodiversity, archaeology and sustainable impact on the local community.

The West Lindsey Planning Committee unanimously rejected the application on sound planning policy reasons and the Parish Council and local residents objected on material considerations all of which were sufficient reasons to refuse.

So much therefore for the Localism Act!

STATEMENT FROM SUSBROOKE PARISH COUNCIL CHAIRMAN PETER HEATH

■ I was hopeful that the Planning Appeal would be rejected and the park would be safe from the scale of the development that is proposed. Unfortunately that hope has been dashed.

The Parish Council sought to work with the developers to reduce the scale of their project, but we were rebuffed.

The Inspector has justified his decision on the grounds that the developing Central Lincolnshire Plan has not been tested to provide the volume of housing required by the government. We have also been sidelined by the local authorities of Health and Education; they raised no objections to the plan on the grounds that there are sufficient resources available and they'll get a large payment from the developer.

Our objections to the increase in traffic were undermined by Highways "no objection" in spite of an initial informal approach that they would object.

The loss of open space, woodland and historic site has been compromised by the developers' changes to their initial plan in reducing the number of houses and water run-off areas. These changes are insignificant in the greater scheme of things and will still lead to the loss a natural resource which does not seem to have been taken into account.

My overwhelming feeling when I read the news was what is the point of local government when central government simply brushes aside the wishes of local people and imposes their unfeeling will on a community regardless of the long-term consequences?



PARISH COUNCIL MINUTES

May 2016

Notes of the monthly meeting of Sudbrooke Parish Council held on Thursday 12 May in Sudbrooke Village Hall.

17) Election of Chairman / Signature of Declaration of Acceptance of Office

Proposed by Councillor Paul Rignall, seconded by Councillor Stuart Curtis and Resolved that Councillor Peter Heath be elected Chairman of Sudbrooke Parish Council for the 2016/17 year. Councillor Heath duly signed the Declaration of Acceptance of Office.

18) Election of Vice-Chairman

Proposed by Councillor Paul Rignall, seconded by Councillor Stuart Curtis and Resolved that Councillor Bob Waller be appointed Vice Chairman for the ensuing year.

Due to Councillor Waller not being present at this meeting, the Declaration of Acceptance of Office of Vice Chairman would be signed at the next meeting of the Parish Council.

19) Parishioners' Items

A parishioner reported dying trees on his property which were protected by a TPO and sought advice on who to contact. The resident was advised to speak to the Trees Officer at West Lindsey District Council.

It was noted that five trees had been felled by LCC Highways on St Edward's Drive, but the workmen had no instruction for works to the dead/dying trees on the opposite side of the road. The Clerk would contact LCC Highways regarding this matter.

Report of poor condition of footway on Scothern Lane. It was noted that this section of footway was due to be slurry sealed in the next programme of works.

Complaint of late deliveries of **Sudbrooke News** - it was noted that this was possibly due to a distributor being on holiday. A request would be put in the next **Sudbrooke News** for relief distributors to cover holiday periods of permanent distributors.

Boards had again been vandalised on the tennis courts.

20) Apologies

Apologies received from Councillors Bob Waller, Miss Rose Dobbs, Andy Cottam and Ian Russell. That the reasons given be accepted proposed by Councillor Paul Rignall, seconded by Councillor Stuart Curtis and Resolved.

21) Declarations Of Interest

None declared.

PARISH COUNCIL MINUTES

22) Police Matters

■ Police Community Panel Meeting April 20, 2016 attended by Miss Rose Dobbs - A report from Councillor Dobbs had been received, circulated to all members and read out at the meeting.

23) County Councillor's Report

■ CC Mrs Sue Rawlins spoke of the withdrawal of funds from Lincolnshire County Council for amenity grass cutting, wef April 2017.

It was also understood that grass verges would cease to be cut except at junctions and on dangerous corners.

Further cuts were required to be made by LCC and street lighting would be reduced in residential areas with switch off of lights taking place at 10pm or midnight.

Members felt that a 10pm switch off was unacceptable for safety of persons dog walking or returning from work. CC Mrs Rawlins offered to pass on the comments of the Parish Council to LCC, but felt that the cuts were inevitable to attain the level of savings required.

24) District Councillor's Report

■ DC Stuart Curtis reported that the full WLDC Council would be held later in the month.

25) Reports on Matters Outstanding

■ **a) Footpaths 816/817** - Laying of woodchips arranged for 1pm Saturday 11, June. Resident kindly offered to loan some barrows. Notice to be put in **Sudbrooke News** for assistance in moving and laying.

■ **b) Damage caused by horse riders to footways not designated as bridleways** - LCC Footpaths Officer had ordered signage requesting no horse riding on footways. A resident had also reported horses riding to the rear of Maple Drive, which was not a designated bridleway. LCC Highways would be notified and asked to site signage in this area.

■ **c) Footway and verge near to Church Court** - LCC Highways Officer had inspected the footway and stated that although there is some crazing it would not warrant intervention.

With regards to the grass verge, the Officer had stated that there did not appear to be any rutting or structural defect on the verge and that utilities should all be at sufficient depth not to be affected.

■ **d) Litter Pick - April 9** - Report received from organiser Mr Mike Halliday which was read to the meeting. A successful pick with many bags of rubbish collected.

■ **e) Consideration of donation to Lincoln Rapid Response Team** - The Team had provided first aid cover for the litter pick. Members considered a donation as acknowledgement. That a donation of £25 be made to the Lincoln Rapid Response Team proposed by Councillor Peter Heath, seconded by Councillor Paul Rignall and Resolved.

26) Sudbrooke Sports Day

■ Resident Mrs Emma Chapman had offered to organise the event on behalf of the Parish Council on Sunday 4 September. Some Councillors would be in attendance to offer assistance. It was noted that £250 had been allocated in the Precept for this event. Resolved unanimously that the event go ahead.

27) Highway Grass Cutting

■ Letter received from LCC Highways stating 12 months notice to terminate the agreement. It was noted that Sudbrooke Parish Council currently receives over £2,000 annual contribution towards grass cutting in the village.

Members discussed this and felt that residents must be made aware that if the current level of cutting was to continue this amount would result in an increase in the precept for the next financial year.

Further information would be obtained from LCC Highways and discussed at the next Parish Council meeting.

28) Review of Parish Council Complaints Procedure

■ This was reviewed and amended. That it be adopted proposed by Councillor Peter Heath, seconded by Councillor Paul Rignall and Resolved.

29) Finance

■ A) Parish Council Insurance

i Annual renewal schedule for payment - The renewal schedule had been copied to all members. Resolved unanimously that it be accepted.

ii Review/Consideration of insuring play equipment against vandalism - Following consideration, members Resolved unanimously not to go ahead with this option.

■ **B) Approval of payment to Clerk for training expenses incurred on attaining the Certificate in Local Council Administration** - The Treasurer informed the members that the Clerk had successfully attained this certificate and that agreement had been made previously for part payment of the cost of the training which amounted to £190.50. Members Resolved unanimously that this payment incurred by the Clerk be reimbursed.

30) Planning Matters

■ A) Sudbrooke Neighbourhood Plan:

I. Report on progress to date - A written report had been issued to Councillors present. It was also added that a call for land for potential sites for development had received a good response from local landowners.

II. Agreement and Signing of Professional Services contract for Character assessment of village - This was deferred.

III. Application for Lottery Funding for Neighbourhood Plan - That an application be made proposed by Councillor Peter Heath, seconded by Councillor Paul Rignall.

■ **B) Scothern Neighbourhood Plan- Pre-submission Consultation** - Resolved unanimously that no comments be made.

■ C) Applications:

I. 106 Wragby Road - 134348 - vary condition five of planning permission 126872 granted 25 May 2011 - No objections

II. 16 Scothern Lane - 134229 - Erect one dwelling - revised proposals for plot 1 planning application 122916 - Comments submitted to WLDC

Available members of Sudbrooke Parish Council have viewed the above planning application and under delegated authority I submit the following comments:

- The revised plans would appear to be in keeping and similar to the adjoining new property on the east but not yet occupied.
- There are no objections to the erection of the dwelling other than previous planning conditions should remain, in particular a passing bay to be provided along the narrow private driveway.'

III. Lincoln District Scout Camp site, West Drive - 134198 - proposed replacement single storey storage building - no objections. That the above comments having been sent or be sent to WLDC Planning Department Resolved unanimously.

■ The Chair reported that it had been suggested that there may be buildings/properties in the village which should be considered for Listing - agenda item for next meeting of the Parish Council.

Hedges overgrowing onto footpaths had been raised again and the Chair respectfully requested that residents cut back any shrubbery that was growing onto footways.

33) Correspondence

■ Letter from resident expressing concern about the condition of Sudbrooke/Nettleham Lane and that he considered it unsafe for pedestrians. The Chair stressed that the provision of a footpath along this lane had long been the aim of this Parish Council.

Further request by resident for dropped kerbs near to the village hall - this would be an agenda item for the next Parish Council meeting.

Email from resident reporting horse riding to the rear of Maple Drive.

34) Date of Next Meeting

■ Resolved unanimously that Parish Council meetings be held on the first Thursday of a month (whenever possible) excluding August.

35) Closed Session to discuss Confidentialia Items

■ Relating to staffing matters and CCTV at the Village Hall - It was agreed unanimously and the residents and County Councillor left the meeting.

PARISH COUNCIL REPORT

Brief report of meeting held on June 2, 2016

■ **Billboards displayed in Sudbrooke Park** - A resident had complained of the billboards displayed in Sudbrooke Park. The Parish Council discussed this and felt that the information on the boards is deceptive, not reflecting accurately the views of parishioners and the Planning Officer would be advised accordingly.

■ **Amenity Grass cutting** - From April 2017, the County Council will not be making any financial contribution to the grass cutting in villages - this is a substantial amount for Sudbrooke, £2,400. This amount will need to be put on the Precept and borne by Council tax payers in the parish. Members discussed this in detail and Resolved to reduce the cuts from 13 to 10 per year to make some saving.

The County Councils new policy also includes the withdrawal of verge cutting on other roads except on dangerous corners and at junctions, this also being effective from April 2017.

■ **First Aid training** - A local company has kindly offered to undertake First Aid training for members of the Parish Council. Other local organisations are invited to fill spare places with representatives at a cost of £10 per person. Please be in touch with the Clerk to the Council on sudbrookeparishcouncil@gmail.com

■ **Vandalism in the village** - Boards have again been kicked in at the tennis courts and the bus shelter by the Cherry Tree Café has suffered vandalism. The Police are aware.

JUNE WALK

■ Eight walkers set out from South Elkington passing through Cow Pasture Wood and surrounding fields towards Hubbards Hills in Louth.

Interesting to see the improvements to the parklands in Hubbards Hills especially to the stream banks which were a magnet for a childrens outing.

We then climbed steadily to Hallington Top before descending to Welton Vale woods at which time the sun was shining to brighten up a wonderful display of wild woodland flowers.

The woodland track was formerly the main entrance to South Elkington Hall and has at the end a large whalebone arc.

JULY WALK

■ A seven-mile walk through Tennyson country visiting Bag Enderby, Tetford and Somersby.

Well worthwhile visiting the small churches in these villages. There is one short significant hill climb outside Bag Enderby otherwise the walk is on fairly level ground.

PROGRESS TOWARDS OUR NEIGHBOURHOOD PLAN

The village Survey was completed in March and provided an excellent 30 per cent response rate. The responses were analysed in detail during April and they included over 1250 comments on top of the thousands of multiple choice question results.

This information, in addition to the Village Hall open event inputs, provided a solid basis for advancement to the current stage: preparation of a Draft Neighbourhood Plan with a series of policy proposals based on the results obtained. The Draft is built around 10 community evidence-based themes as follows:

- Location of future housing
- Numbers and type of future housing
- The protection of open spaces, biodiversity and the environment
- The design of new developments
- The protection and enhancement of the historic environment
- Flooding and drainage
- Protection and enhancement of community facilities
- Protection and enhancement of public rights of way
- The provision of improved infrastructure including health, education and transport
- Community aspirations – future vision

Each theme Draft is being prepared by a sub group within the team and we are about 75 per cent complete. We then have to agree the policy proposals between us and with the Parish Council to make sure that they reflect the evidence obtained and align with the current WLDC Local Plan and the emerging Central Lincolnshire Local Plan,

expected to be adopted at the end of the year.

This will take some time but we aim to present the proposals to the village at an open day event in late summer.

Comments will be requested and a consultation statement prepared later, identifying all responses received and actions taken.

By that time we will also have the Character Assessment and the Sustainability Scoping Report in hand (Character Assessment expected in early July), which are essential parts of the Neighbourhood Plan.

The results of the Call for Land letter, which every household and local landowner received, will also be on display and you will be asked for your comments regarding the possible development of each parcel of land identified.

These land parcels will then have to be appraised according to a prescriptive process as to suitability for development. This will lead to a Consultation Summary Report showing how the community was involved in the process of land selection and a Sustainability Appraisal Report, once the sites are known.

Other processes will add to the overall Plan Proposal before it finally goes forward to the local planning authority and an independent examiner for approval and the final Village Referendum and registration as a "Made Plan".

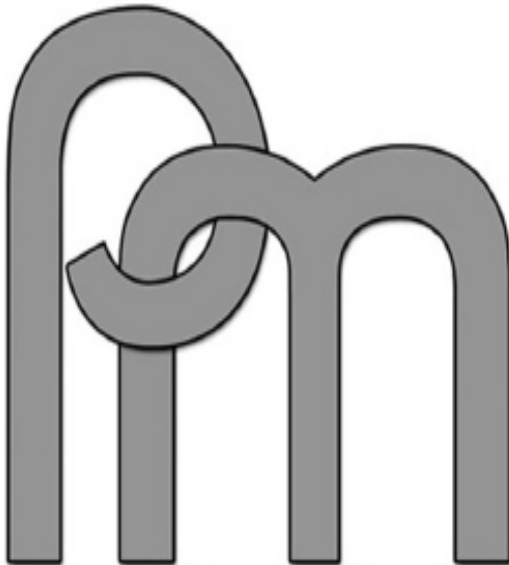

VOLUNTEERING STARS

■ Over the last week I have been thinking about the many people who give time and energy to their communities by volunteering.

This was prompted by the award of an honour in the Queen's Birthday Honours list to a lady living locally to me, who has given hours of time in service to various organisations, charities and local government.

This reminds me that right across our communities there is a whole host of people who are giving their time and energy to voluntary organisations that would not function without unpaid support.

Charities founded on selfless giving, where no-one asks for reward; people who give of themselves because they are passionate about their community, or about an issue that has touched their life in some way.

As I write this, the Queen's birthday celebrations have just come to an end with a celebration on the Mall involving the 600 charitable organisations of which the Queen is patron - people happy to be there to celebrate the occasion, but also happy to give the gifts they have to serve others.

That gives me an opportunity to say thank you to the many who support our communities in volunteering - to those who take part in sponsored activities to raise funds, to support our hospitals and hospices and nursing homes, serve on councils, work with the homeless, produce our newsletters, work with people young and old, visit neighbours and generally oil the wheels of our communities which are great places to live because of the support we offer to one another.

Many go unnoticed - but thank you!

Here is a story about going unnoticed.... There was a town in the Alps that straddled the banks of a beautiful stream. The water in the stream was as clear as crystal. Children played in it, the swans and geese swam on it.

You could see the rocks and the sand and the rainbow trout that swarmed in it.

High in the hills, out of anyone's way, lived an old man who served as the Keeper of the Springs. He had volunteered so long ago that no-one could remember a time when he wasn't there.

He would travel from one spring to another removing branches or fallen leaves or debris that might pollute the water. The work was unseen.

One day, however the man took ill and for weeks he was too ill to do his work. High in the mountains the springs went untended, twigs and branches and worse muddied the water, mud and silt compacted the stream bed; farm waste turned parts of the stream into stagnant bogs.

For a time, no-one in the village noticed the man was ill, and no-one noticed that the work was not done. But after a while the water was not the same. The swans flew away to live elsewhere, the water no longer was crisp and clear. All noticed the loss of sparkling beauty that used to flow below between the banks of the streams that fed the town.

The life of the village depended on the stream, and the life of the stream depended on the keeper of the stream - who had gone unnoticed.... volunteering oils the wheels of communities

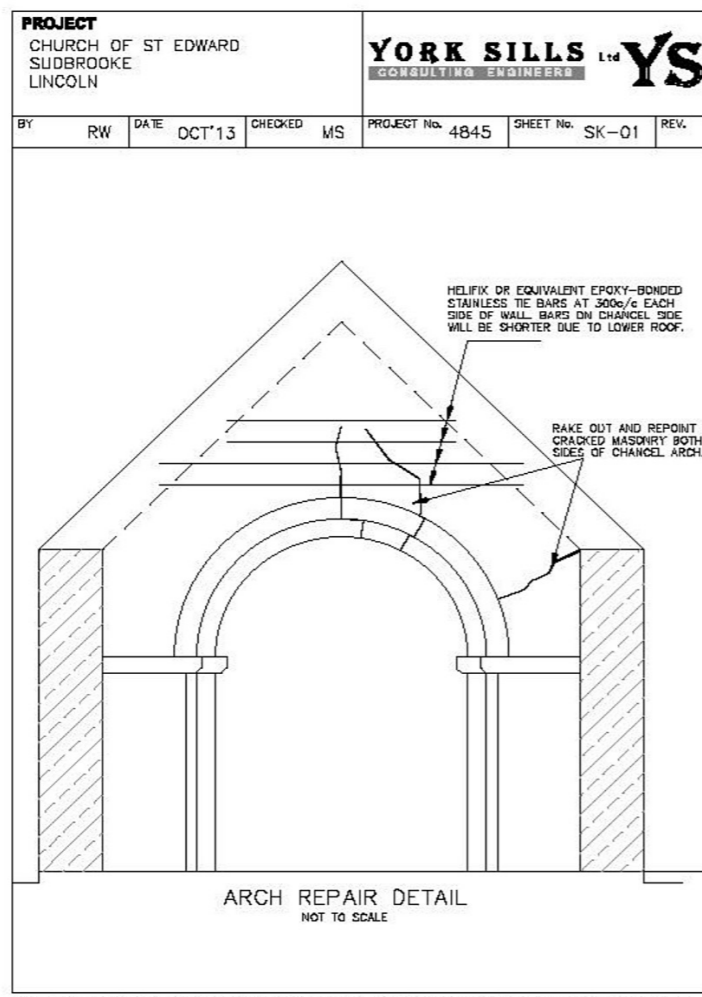

Can you help us to secure St Edwards' future?

The Background: Church appeals for funds, to restore, maintain and in this case save a building, are something that are common and attract many negative comments. We often hear the comment 'oh it's the church asking for money again!' But what many people fail to realise is that the **Church of England has in its care approximately 85% of our nation's listed buildings.** These are buildings which we are legally and duty bound to protect and maintain, for no other reason than they are regarded as national treasures, by organisations outside the church, such as English Heritage, The Victorian Society, The Georgian Society etc. The regular maintenance of St Edwards is funded solely from within the small band of regular worshippers, who give most generously of their time and money to 'Keep it Going'. There is no great pot of cash for us to dip into when major issues strike us, other than the money carefully put aside by the local team. So when a serious issue strikes, as the one we currently face, we need to ask for help. We are of course busy applying for small grants, but we know even with that help we will still have a major shortfall in funds, for the serious repair problems we currently face.



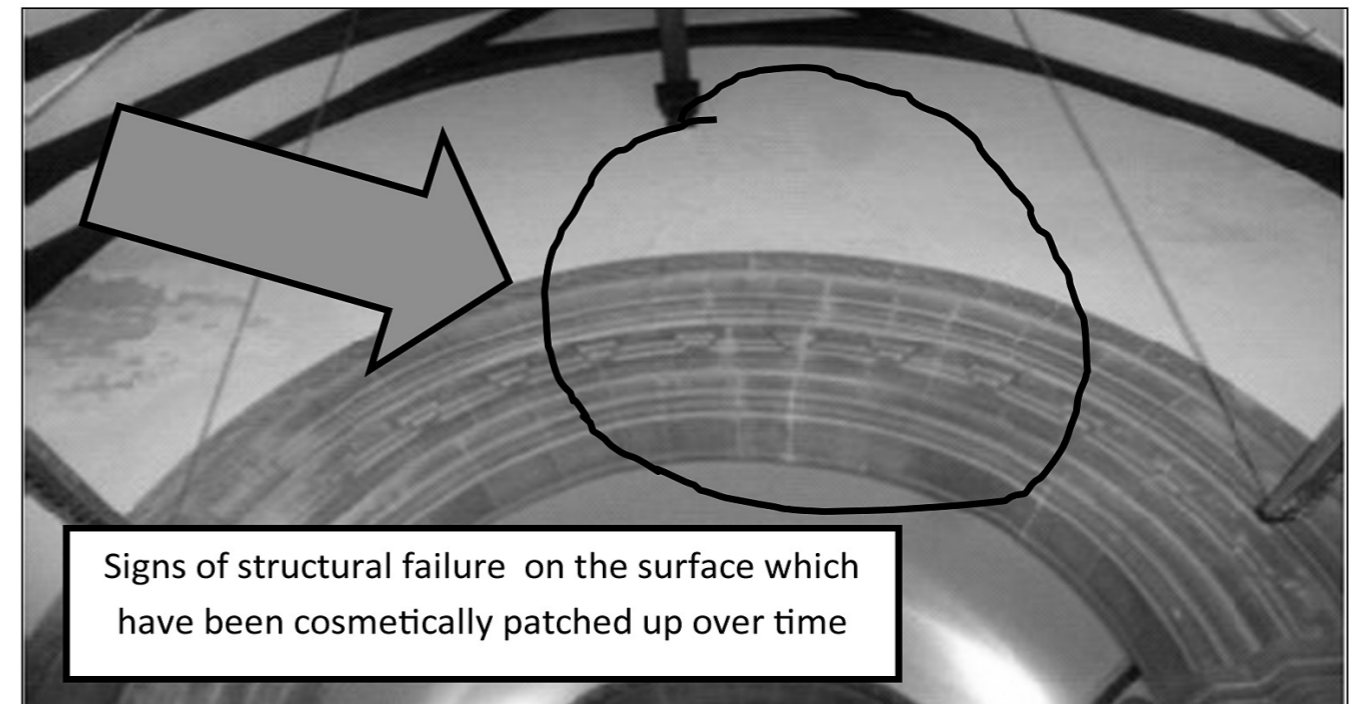
The Problem: The Chancel Arch has deep structural cracks which will unless repaired eventually lead to the arch being unsafe and possibly collapsing. We have had architects and engineers reports and advice. A suggestion has now been agreed upon to mechanically repair the arch and stabilise it. All the work to date has been funded from within the local churches own resources, but we now have only £4500 available toward carrying out this project, which will cost in the order of £20,000. The pictures and diagram hopefully indicate the problem and the proposed solution. Major grant funding for internal repairs, structural or not, is not really available. Whereas the £60,000 we will need to spend on the roof over the next two or three years (high level exterior repairs) probably is to a large extent.

Our Task: To raise £15000, to go solely towards the repair of the St Edward's Church your villages only Grade II* listed building. (This actually is only £12,000 if donations are gift aided as we can claim the tax paid back from HMRC.) We need to raise this money and start the work by November 2016, as at that time, our current permissions to complete the task expire.

An Invitation To Our Open Evening: As well as the church now being open each day during day light hours, we are having an open evening to allow villagers to come and discuss / see the issues for themselves, and also enjoy a glass of wine and nibbles too.

The open evening is from **6.30pm to 9pm on Tuesday 12th July.** Please come along if you are interested in helping, donating, fundraising in anyway for us or possibly just curious. You are most welcome.

REFLECTION CORNER

Where Sudbrooke residents can share their thoughts on life and living

ALEC C. CARROTTE ON LIFE TRANSITIONS

DURING our lives we will most likely experience many transitions, but they generally fall into two categories. Primary Transitions include birth, babyhood, childhood, adolescence, adulthood, parenthood, middle age, third age, old age, death, whilst Secondary Transitions include:

- Leaving the safe home environment and starting school
- Moving from Infant school to Junior school and thence to Senior school
- Leaving home to start at University
- Moving from education into the world of employment
- From living with parents to setting up our own home
- From being single to living with a partner
- From marriage to divorce
- From a low status job to a promotion OR unemployment to employment
- From employment to retirement
- From ill-health to illness or infirmity

Such transitions as those described above (Primary or Secondary) will quite often involve either a loss or a gain for a person, sometimes both (eg) promotion at work, birth of a child (ie) leaving the old way of life behind (however pleasant) and exchanging it for a newer more pleasant existence

Normally we go about our lives in a fairly steady state and 'grieve' quite easily over minor changes. However, it is in the realm of unpleasant or unwelcome or enforced changes that we sometimes struggle to cope (eg) parting from a love one, whether it be 'the empty nest syndrome' when children leave home (eventually!) or a bereavement.

If we are able to successfully grieve any loss that has occurred and accept the change this brings, then we are changed ourselves in the process of dealing with

these transitions and this can lead us to a higher state of functioning. However, if we do not grieve, postpone our grieving, or deal with our loss inappropriately, (mask it by a variety of defence mechanisms – psychological or material) then we will settle down to a level of functioning that is lower than that prior to the event. Consequently, the way we deal with changes in the 'here and now' (positive or negative or both simultaneously) affects how we deal with future changes.

Thus in order to move forward, we have to deal with what we are leaving behind. Just because something has ended, it is not finally ended until we have dealt with it psychologically and emotionally, and that dealing with such endings, is a pre-condition for our renewal. It is simply not enough to say: "I don't want to talk about it", "What is done is done", etc...

Such an approach leaves us with unfinished business, which can have negative effects on our future functioning (ie) relationships, and contentment with ourselves. The defence mechanism of 'denial' is well illustrated by Dickens in his novel 'Great Expectations', where we find Miss Haversham, who after being jilted on her wedding day, immediately adopted a state of 'denial' by continuing to wear her wedding dress in her daily life, in the vain belief that things were as normal. We all have to deal with our transitions in life, good or bad. Sometimes, it's good to talk.

You **MUST NOT** leave your vehicle or trailer in a dangerous position or where it causes any unnecessary obstruction of the road.

Laws RTA 1988, sect 22 & CUR reg 103

DO NOT stop or park

- near a school entrance
- anywhere you would prevent access for Emergency Services
- at or near a bus or tram stop or taxi rank
- on the approach to a level crossing/tramway crossing
- opposite or within 10 metres (32 feet) of a junction, except in an authorised parking space
- near the brow of a hill or hump bridge

- opposite a traffic island or (if this would cause an obstruction) another parked vehicle
- where you would force other traffic to enter a tram lane
- where the kerb has been lowered to help wheelchair users and powered mobility vehicles
- in front of an entrance to a property
- on a bend
- where you would obstruct cyclists' use of cycle facilities except when forced to do so by stationary traffic.
- Parking on the pavement can obstruct and seriously inconvenience pedestrians, people in wheelchairs or with visual impairments and people with prams or pushchairs.

You **MUST NOT** park on a road at night facing against the direction of the traffic flow unless in a recognised parking space. Laws CUR reg 101 & RVLr reg 24

You are currently responsible if anything goes wrong but the good news is that from October 2016 we will take responsibility for many private pumping stations in our region. TRAVEL VACCINATIONS

■ It's the time of year when a lot of patients are thinking about their summer holidays.

If you are travelling abroad, you are advised to find out if any vaccinations are recommended prior to travel. If they are, we ask patients to complete a travel vaccination questionnaire which can be obtained by popping into the practice or by downloading from the practice website.

Once completed, the questionnaire needs returning to the practice and you need to book a convenient appointment with a nurse to administer the vaccines.

Please do not leave it to the last minute as to get the most benefit from the immunisation it is advisable that they are given at least four weeks before travel.
