■ 120 PARISHIONERS' ITEMS

▶ Two residents of West Drive attended the meeting to express their concern about the use by vehicles of PF158/unadopted road at the entrance from Scothern Lane.

The vehicles often were using speed which produced concern to those residents reversing from their driveways and the safety aspect to parents and children using the footpath en route to and from school. It was noted that Jackson and Jackson had previously suggested various methods to remedy this situation. Unanimously Resolved that the Parish Council approach Jackson and Jackson Developments Ltd to ask them to erect some form of barrier or bollard to prevent unauthorised use.

A lot of work has been done already and resources have been made available to identify and tackle these issues through a strong partnership with the Police, PCC, Lincolnshire County Council and all of the seven District Councils.

It is being driven more through members than officers at the councils and it is anticipated that there will involvement at Parish Council level in the not too distant future, with the Chair and Vice Chair of the PCs being consulted.

- ▶ c) To consider quotation for play equipment repairs: The detailed quotation received from EKM Ltd for the required works to both play areas in accordance with recommendations received from the RoSPA annual report was discussed in depth. The works to the Northfield Play area quoted as £1395.60, the Village Hall play area £2,260. It was noted that EKM were a local reputable company with vast

experience in installing/repairs to play equipment and used by other parish councils and schools in the area. Unanimously Resolved that the quotations be accepted from EKM Ltd.

- d) Communication with parishioners:Deferred until next meeting of the Council.
- e) Grass cutting, Church Lane/Nettleham Lane: It was reported that works to this area were still not up to the required standard. The Clerk was instructed to contact the contractors again.
- f) Litter Pick October 20, 2018: It was noted that 16 residents attended the Litter Pick and had collected a considerable amount of rubbish including cans, fast food containers, plastic bottles, a significant number of party balloons as well as left over equipment from recent roadworks. Thanks were extended to Mr Lee Coulson for organising the Litter Pick.
- g) Jubilee Garden any further works required: It was noted that the wild flower area had now been cut back and a resident would be moving some shrubs to more suitable positions. To be an agenda item for the next PC meeting.

■ a) Park Development - Traffic Management Plan: Since the last meeting of the Parish Council, a log recording the use of West Drive by 12 heavy lorries in one hour had been sent to the Enforcement Officers at WLDC.

A reply had been made by the Development Management Officer at LCC which stated that directional signs would be checked on a weekly basis and that signage had been sited at both ends of the private section of West Drive.

Copies of the access delivery routes, as agreed at planning, for the different types of delivery lorries had been provided to their various suppliers. Further monitoring would be made by the Site Manager.

Description Councillor Paul Rignall outlined the proposals for new toilets in the first instance. It was hoped future alterations to the hall could include the building of an additional room on the patio area at the rear of the hall.

Members welcomed the proposals and approved the refurbishment of the toilets.

CHAIRMAN'S COMMENT

PETER HEATH ON THE THORNY ISSUE OF OVERGROWN HEDGES

SUBURBAN PROBLEM

Well a new year. but still the same old problems. No I don't mean Brexit, as I write it's no further forward than at any other time,

however. the subject of Hedges has raised its head again.

The Phantom Hedge Cutter of old Sudbrooke Town may have raised a smile for some, but it still resonates. The problem we have is that too many hedges have been allowed to grow out over our footpaths with the result that some are impassable.

As a rule of thumb, two people should be able to walk side by side along a path or at least pass one another without having to step into the road.

There are some beautifully trimmed hedges in the village, but when looked at objectively they fail the two-person test. Ideally your hedge should be trimmed back to your property boundary and allowed to grow no further over the footpath.

Most hedges will take a severe cut back, but I recognise that some will not recover from such. A Leylandii hedge will survive a cut back provided you leave some green leaves on every branch, over the course of several growing seasons it will fill in the gaps, but trim regularly. For most others the following is good advice:

▶ Some conifers like red Western cedar can be cut hard... chop a branch where you cannot see it and see what happens if you do not know what your conifer is.

▶ Beech usually pruned in August, but to renovate an overgrown beech hedge, cut it

back hard in February while still dormant but delay if the weather is very cold. Leave one side uncut for a year if cutting back more than 50 per cent.

Prunus/laurel can be cut back hard when it is dormant in late winter or prune in late spring /early summer. Best not to cut evergreens in late summer as new growth does not like the frost/ cold weather.

Privet - cut whenever it has put on about a foot of growth but avoid cutting after

late summer as new growth can be damaged by frost. Can be cut back hard in late winter.

- ▶ Holly severe prune in late winter will even grow back from a stump! or prune spring to late summer.
- ▶ Yew can be hard/severely pruned in late winter or early spring before new growth begins. Yearly pruning in mid summer, avoid Autumn pruning as new growth can be killed by frost.

Next time you leave the house take a good look at your hedge and use the above as a measure then consider how you can comply with it. The growing season is nearly here and hedges left unchecked will simply become more of an antisocial problem.

▶ A resident attended the meeting regarding his concern about overgrown hedges in the village and recent publicity afforded to the unauthorised cutting of a residents' hedge – a matter which was due to be discussed as a complaint in closed session.

The resident agreed that the matter could be discussed openly at this time. The Chairman pointed out that the Parish Council from time to time raise the awareness of overhanging hedges by bringing it to the attention of residents in **Sudbrooke News**, but that the Parish Council nor the County Council have any legal right to undertake the cutting back of residents hedges.

County Councillor Mrs Sue Rawlins updated the meeting regarding issues raised over many months about an overgrown hedge in St Edward's Drive. A resident attending the meeting outlined plans of a proposed extension to his property which were noted.

- Concern was raised about the excavation of the lake to the rear of Wragby Road.
- A resident had drawn attention to lighting on Scothern Lane stating that it is was unsatisfactory. The Clerk would enquire with LCC Highways as to when the lighting would be upgraded to LED.

 e) Unadopted stretch of West Drive request to JJDL to erect barrier: A reply
 received from the developers read as
 follows: "We have checked back through
 correspondence with regards to this
 section of West Drive and we agree that
 the possibility of installing bollards was
 discussed at a meeting that took place
 prior to making the planning application
 for our development. This item was not
 included in the application as our
 solicitors advised us that we could not

carry out the work as the land is unregistered. We consider that we have done all we can by installing signage confirming no entry to construction traffic.

It should also be remembered that we did have directional signage put up through the village to ensure all deliveries followed the approved route but all these signs were removed."

Members discussed the matter at length, taking into account some objections received from residents living on Main Drive who had legal access along that stretch. It was considered that the matter had been taken as far as possible and that the Parish Council could take no further action.

However, suggestions to residents living on the unadopted stretch was that they could erect some permanent signage requesting that those using it drive with consideration for residents or signage indicating 'Private road, authorised access only'. Unanimously Resolved as above.

THE YEAR AHEAD

I hope that you all had a happy and enjoyable time over the festive period. We are now entering a new year heralding some major changes ahead that will affect us all, as prepare to leave the European Union.

But what about local issues and changes? Local elections will take place in May 2019 where all District Councillors and Parish Councillors are up for re-election. At the time of writing WLDC consists of 36 councillors representing 20 Wards.

Councillors can combine into political groups. The make up of the groups on the council is currently: Conservative 24, Liberal Democrat seven, Labour three and two Independent Primarily councillors elected by their residents have a duty

- Provide a 'critical friend' challenge to decision-makers
 - Reflect the public voice
 - Take the lead and own the scrutiny process
 - Make an impact on service delivery

The council recently carried out a review of its priorities for 2016-2020 considering all the evidence they have including national and regional priorities and local views and taking into account what our residents consider important. Here are the things we can see a greater focus on:

- People First ease and convenience of access to a range of public services offered by the council and partner organisations
- Asset Management to develop and maximise the return on, and value of, our land and property
- Partnership/Devolution work in partnership to explore opportunities to deliver improvements in housing, infrastructure, agri-food, manufacturing and engineering, visitor economy, skills, water management, health and public protection
- Central Lincolnshire Local Plan make sure the Local Plan is adopted
- Excellent Value for Money Services explore alternative delivery models to ensure effective use of resources
- Open for Business to attract inward investment

Included in the above are our constant challenges such as road repairs (pot holes) and fly tipping, just to mention two. The Government has given Lincolnshire County Council £13,747,000 extra to repair our roads. This money must be spent before the end of the current financial year. I am lobbying to get our share and help to make sure our roads are "fit for purpose". Finally, both Parish Councils in our ward have vacancies – why not stand for election in May and help make a difference?

MAKING A START

Well, here we are already in the second month of 2019 and pleasingly there are signs in our gardens of Spring being just round the corner - in fact we noticed some snowdrops and a few crocus in flower in a village garden prior to Christmas. What joy!

Once again the hellebore flowers are a welcome sight and if you remove the old foliage when the flower buds appear this reveals the flowers to their best advantage. If you expose the blooms in this way it helps insects to pollinate them should you wish to grow on your own seedlings. Getting rid of old leaves before fresh foliage emerges also helps reduce infection by leaf spot diseases and cover for bud-eating rodents such as mice.

Now is a good time to hard prune hedges such as beech, prunus/laurel, yews and holly. If you are cutting back more than half, then leave one side of the hedge unpruned this year.

■ PROCEDURES. PROCEDURES...

Less of a blog this month, more of a 'flagging up' of a procedure that we have to go through as a Church of England Church, once every six years, and that I wish people in the wider community to be aware of ...

Every Church of England church has to keep an Electoral Roll (which is different to the Civil Electoral Roll).

Every six years the existing roll is 'wiped clean' and we start again - everyone who wishes to be on the Roll has to complete a form and submit it by a certain date.

Who can be on it?

The Roll is open to anyone who:

- a) is a 'lay person' (ie not Clergy) and over 16 b) is baptised
- c) has completed and signed an application for enrolment

and either

is resident in the Parish (of Sudbrooke) and a member of the Church of England (ie were baptised in a Church of England Church) or of a Church in Communion with the Church of England.

or if not resident

has habitually attended the church for a

period of more than six months prior to enrolment

Why be on it?

It enables you to have a say and be a part of your local church, to attend meetings and vote in the Annual Meeting.

The number on the Electoral Roll also determines the representation of the local Church on other Church Bodies.

What do I need to do?

If you are on the current Electoral Roll we will write to you, enclosing a Form and asking you to complete it by a given date.

If you are not on the current Electoral Roll and wish to be in the future:

Pick a form up in Church or ring 01522 595596 or email slboffice@virginmendia.com giving us your name and address and we will ensure that a form is sent to you. The form must be returned by April 1, 2019.

I am just writing to recommend the Active Seniors Programme. It is a very low impact exercise programme specifically designed for us seniors and is very sympathetically run by Matt Snee, the Active Communities Manager from West Lindsey.

I use the word sympathetically because he is well used to running activity programmes for senior residents and knows our limitations. The sessions are designed to not only improve your mobility, but also to encourage a social atmosphere. We have made several new friends since going. If you are tied to the house a lot, this gives you a lovely chance to get out and have some real fun with new friends for an hour. It has been running reasonably successfully since September 2018, but tailed off a bit before Christmas, as you might expect.

The sessions consist of two consecutive periods starting at 10am. first at Sudbrooke and then at 11am at Scothern village halls. Each lasts for 45 minutes with numerous breaks for a rest. If you need to drop out for an extra rest then that's no problem, but the activities are tailored to our age group so you should be fine! The activities at Sudbrooke are walking netball, walking football and pickleball (a sort of tennis with soft sponge balls) alternating on a weekly basis.

If you wish, you can then commute up to Scothern for 11am where the activities are also extremely low impact and all done seated. Here the games are Boccia (a cross between bowling and boules using soft leather balls), seated hockey and occasionally a seated cricket game (using the same soft sponge balls), again alternating on a weekly basis.

You can come along to both sessions or just one, whatever fits in with your life. All you

need is some loose comfortable clothing, appropriate footwear and if you wish, a small bottle of water.

Each session is £2, which is excellent value and less than the price of a coffee in town! Please come along and give it a try. You will be surprised at how much fun and laughter there is.


