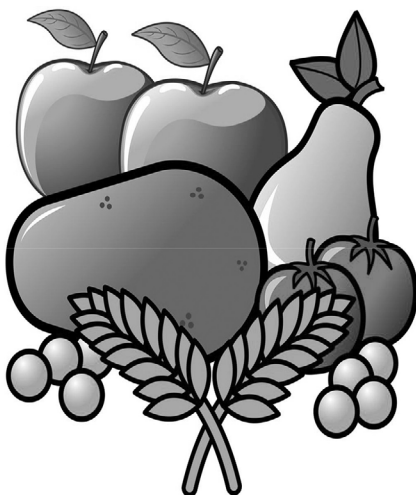

- ✿ Overgrown public footpath Main Drive - Scothern - Clerk notified grass cutting contractors
- ✿ Concern about overgrown tributary rear of Maple/Holme Drive - Witham Third Internal Drainage Board had confirmed they would be cutting during July.

57) Reports on Matters Outstanding

■ **a) i: New sportsfield/tennis courts tidying by NCS Action** - Confirmation received that a team would be available to undertake the project of tidying tennis courts/cabin/exterior of hall during the period July31-Aug 10, 2017. The Team would not be able to cut back shrubs. Chairman of Village Hall had confirmed that the Team could have use of the Village Hall during that period at no cost.

ii: Cutting back of shrubs at Tennis Courts – consideration of quotations - As the NCS Team were unable to cut back the overhanging branches into the tennis court quotations had been received in the sums of £110.00 and £90.00. That the quotation for £90.00 from Arborez be accepted Resolved unanimously.

■ **b) i: Highway matters - LCC Highway amenity grass cutting in village** - This had been received and required signature as undertaking that the Parish Council had agreed to continue with the amenity cutting previously undertaken by its contractors. Resolved unanimously that the Chairman sign the agreement on behalf of the Parish.

ii) Quotation for consideration for cutting of verge fronting properties on Wragby Road - This had been received in the sum of £39.00 per cut. It was noted that the majority of residents were cutting their frontage, therefore this be left in abeyance Resolved unanimously.

48) Planning Matters

■ **a) Report to date on grant repayment:** This had now been finalised and the repayment amount authorised. A further application would be required to be made for grant funding in this financial year. Steering Group to discuss with WLDC, Treasurer and Clerk.

■ **b) i. Section 106 Agreement, Poachers Lane:** This had been checked by the Parish Council Solicitors and confirmed as a Deed of Variation to bind the new planning permission in respect of Plot 6 of the development only to the original Section 106 Agreement. Five copies required signing by two members of the Parish Council for return to the Solicitors. It was Resolved that Councillors Peter Heath and Paul Rignall sign the documents on behalf of the Parish Council.

ii. Authority for Clerk to complete on behalf of Parish Council - It was Resolved that the Clerk be given authority to complete

■ **c) Main Drive Access:** Response from Developer to request to survey residents in The Park - A reply was awaited from the Developers.

■ **d) TPO Application 039849 - 12 Broad Dale Close, Sudbrooke:** Circulated between Councillors and the following comments submitted to WLDC:

“Sudbrooke Parish Council strongly objects to this application for the following reasons:

1) The beech appears a large healthy mature specimen. The trunk is approximately five metres away from the property. A number of large lower limbs have previously been removed. No branches overhang the property. The two sycamores are further away from property, behind the beech, seemingly causing very little threat to the property. Safety risk from the three trees therefore appears very low.

2) The Parish Council does not accept that shading the property is a valid reason for TPO tree work.

3) The application states that “amenity value would not be affected greatly because the trees are barely visible from the road”. This is clearly not the case. The trees form a positive backdrop to this row of properties, forming part of the woodland setting. Tops of trees are visible from the road. Application also fails to recognise that this area of woodland, including these three trees, is shortly to become Public Open Space as part of the conditions for the recently approved major Park Development. The trees are therefore of considerable amenity benefit. Sudbrooke Parish Council recommends that a site visit by the Tree Officer is essential.”

■ **e) TPO - Fell one yew tree - 28 Scothern Lane:** Circulated between Councillors and no objections made to the removal of the tree.

SEPTEMBER WALK

■ The walk was led by John and Iris Whitaker and began by taking us along the coastal marsh path where we were able to spot Egrets and Redshanks, as well as other waders, while walking past the Samphire beds heading towards Saltfleet Haven.

We then followed the river back into the village before returning to the coastal path and walking into Rimac Reserve.

En route we were lucky to observe closely a young Natterjack toad which is a speciality of the area.

Other sightings included dragonflies and damselflies as well as many butterflies.

Upon our return walk to Saltfleet through the dunes, we came across a female sand lizard.

This walk is approximately six miles, fairly easy going with plenty to observe and delight the eye.

Talking of delight, at the little fish and chip shop in Sea Lane, we were able to enjoy freshly cooked fish and chips and a very welcome drink.

OCTOBER WALK

■ Our We shall be doing the “Hag Bag” walk in Tennyson country. The walk is around seven miles if we detour to Somersby, *below*, which is Tennyson’s birthplace.

There are good Tennyson exhibitions at the churches in both Somersby and Bag Enderby.

We start at Bag Enderby and pass through Hagworthingham and Stainsby.

The terrain is a mixture of footpaths, bridleways and quiet lanes - it may be muddy in places.

Walkers should meet at the village hall at 9.30am and are advised to take a waterproof coat, wear suitable footwear, bring a snack and a drink.

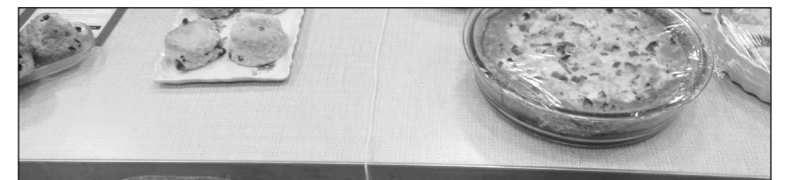

STORMY WEATHER

■ I have just been woken by the high winds that swept through the country from storm Aileen last night.

Winds of 50-60 miles per hour can be quite disturbing. I can't imagine what it is like to sit through a hurricane and then deal with the aftermath of destruction.

To see Caribbean islands laid waste by wind and rain and flood from Hurricanes Harvey and Irma has been shocking, and for many it will mean a change of home, displacement and a forbidding sense of loss.

It's the same in Bangladesh and Nepal, India and Pakistan, but from flood, with 41 million people affected over July, August and September.

Many people have been displaced and we can see before our eyes that the world is changing; climate is changing and our relationships one with another are changing.

I am not a great lover of storms - I know that some people deliberately head into them, but I don't like the disruption they

cause, nor the loudness, nor the power they exert, but they are part of our natural world. Nine thousand years ago Elijah was in the middle of a storm in his life.

He was literally running for his life, he took refuge in the desert and then took 40 days and nights to move to Mount Horeb where he sought God.

The Bible tells us that while he was on the mountain, a powerful wind came, but the Lord was not in the wind; then an earthquake came and the Lord wasn't there either; then the fire came and finally it was still, and there was the soft whisper of God telling Elijah what to do and in what direction he should travel.

Sometimes life is stormy. Things don't go the way we want them and it is at those times we are tempted to believe that God will scream the answer to us.

My experience is that in those times, the important thing to do is to stop, be still and listen - and who knows, in the quietness we might hear the gentle whisper of God.

Frequently Asked Questions

Why are we considering charging for garden waste?

Central government have cut funding to all local councils. This means tough choices have to be made (including charging for collecting garden waste.) More than half of councils in the UK now charge for collection of garden waste.

When would the charges start?

The new service is planned to start from April 2018.

How much is the new service proposed to cost?

The cost of the new service is proposed at £35 per year per green bin. Additional bins at the same property will incur an additional annual cost of £30 per bin. You have the opportunity to influence this during the consultation with options to increase the number of collections, or reduce them if our residents want to pay less for fewer collections.

How would I sign up and pay for the new charged garden waste collection service?

You would be able to sign up and pay online or over the phone by debit or credit card from the end of 2017. We are looking into the option of paying by cash or cheque at Post Offices and Paypoint locations.

When would I have to pay by?

The proposal is that you can sign up and pay any time from the end of 2017.

How would the proposed changes affect me?

To have your garden waste collected after March 2018 you would need to pay a fee to cover the collection cost. This is optional; you would only pay if you wanted to use the service. Those who do not want to pay for the service can use the county council's household waste recycling centres for free or compost at home (details of home composters are available at www.getcomposting.com or by phoning 0844 5714444, quoting LWP10L.)

Would my collection day change?

Changes to collection days would be unlikely during the first year. We may review this in the future as we look to make the service as efficient and cost effective as possible

How would I opt out?

You would not need to contact us to opt-out. If you did not sign up and pay for the service, your bin would not be collected when the service starts in April 2018. If you did not want to sign up, you could keep your bin but we would not empty it. If, at a later date, you chose to sign up, you could use your existing bin (providing it is serviceable.)

Could I have more than one bin and would additional bins be charged at the same rate?

Yes, as is the case now, properties can have more than one garden waste bin (providing there is suitable storage and a suitable collection point.) The proposal is that there will be a discount for additional bins.

How would you know if I have paid for the service?

We would send identification stickers to those who sign up and pay to place on their bin(s). Our crews would also hold information inside their cabs to identify those who have paid.

Could residents share a bin?

Yes. The bin would be charged to one resident and would be collected from that property only.

What would happen if I signed up part way through the year? Would I have to pay the full annual charge?

The proposal is that you can sign up to the service at any point during the year. The annual charge would run from 1 April until 31 March each year. If you were to sign up part way through the year, you would be charged for the full year.

I don't currently have a bin, could I still sign up for the service?

Yes, the proposal is that you can sign up and pay for the service at any time. Once you have paid for the service the council will arrange for the delivery of a garden waste bin. The usual council delivery charge will apply to all new bins.

Don't I already pay for a garden waste collection through my council tax?

Council tax contributes towards the cost of running Council services but changes to Government Funding means that we can no longer afford to offer this service free of charge.

Alternatives to paying for garden waste collection

Would home composters still be available?

Yes, we will continue to offer cost-price compost bins. This is a good alternative to paying for a collection or taking garden waste to your local household waste recycling centre. You will also produce great compost to use at home. These are available at www.getcomposting.com or by ringing 0800 5714444

Would I still be able to take garden waste to my local Household Waste Recycling Centre?

Yes, you can continue to take your garden waste to any of Lincolnshire County Council's Household Waste Recycling Centres free of charge.

What would happen if I couldn't get to a household waste recycling centre (HWRC)?

You could investigate the possibility of sharing a bin with a neighbour or the council offers compost bins which are available as a subsidised rate. This is a good alternative to taking garden waste to the HWRC. You will also create great compost to use at home. These are available at www.getcomposting.com or by phoning 0800 316 4454.

Charging

Would there be help for residents without the means to pay or who are in receipt of benefits for a bin?

The service is designed to be fairer than the current system; only those that require the service would fund it, rather than everyone paying for it through their council tax. No concessions are planned, but an equality impact assessment will be added to as we receive your feedback and the consultation results are analysed. Councillors will make a final decision in December.

Why are you considering a charge of £35 when other councils charge less?

The collection charge is less than the Lincolnshire average. It proposed at this level based on the experience of other authorities and is created to cover the costs of the service. No profit is made from the service. The charge in future years would reflect the costs and could go up or down according to the number of people who sign up to the service. Authorities across the country charge similar amounts per year for the kerbside collection of garden waste. Collecting waste in rural areas like West Lindsey can be more expensive and we think £35 is good value for money.

Why is the council considering charging for garden waste collections now after it has been a free service for nearly 10 years?

Central government has changed the way funding is provided to all local councils over recent years. This means the council has to make tough choices, including charging those who use the garden waste service.

I won't put my bin out every fortnight, could I have a discount?

No. The collection crews would visit your property regardless of whether you put your bin out for collection or not. You could talk to your neighbours about the possibility of sharing the cost and a bin.

Could I have the £35 charge discounted from my council tax?

No. Council tax is collected and distributed to Lincolnshire County Council, fire and police services and others. Of the £1,580 or so paid in council tax by a band D property, only around £200 goes to West Lindsey District Council. In the past, council tax has contributed to the cost of running this service, and all other services, but the council can no longer afford to offer this service free of charge.

Would charging for garden waste mean more fly tipping?

In line with the experience of other areas, we expect customers will either pay for the service, compost at home or take their garden waste to their nearest household waste recycling centre. The council will continually monitor the number and nature of fly tipping cases to assess whether charging for garden waste increases fly tipping, but we do not expect a significant increase and will continue to prosecute offenders.

How would I be charged in future years?

The plan is that you would be charged from 1st April each year. You would receive an annual reminder to renew your contract when we deliver calendars each year. You could opt out of the service at any time, but you would not be entitled to a refund.

What would happen if I paid for the service but my bin gets stolen?

If your bin is stolen, it would be replaced in line with existing policies.

Would I have to pay for the service if I don't want it?

No, this is an optional service; you would only pay if you would like to receive a fortnightly garden waste collection.

Bins and collections

Would there be a ban on garden waste in household waste bins?

Yes. As is the case now, garden waste cannot be placed in your household waste (black) bin. Additional waste placed next to your household waste bin will not be collected. If you choose not to receive the kerbside garden waste collection service, you could compost at home or take your garden waste to any of the Lincolnshire County Council's household waste recycling centres at no charge. Household waste bins containing garden waste could be refused and result in enforcement action.

Would you take extra garden waste placed beside the bin?

No, the current service will be maintained and all garden waste must be contained within the bin with the bin lid closed. However, the proposal does allow for customers to subscribe to additional bins should there be a need.

Who owns the bins?

The council will continue to own the bins.

Would I have to pay to replace my broken or lost garden waste bins?

Just as is the case now, we would replace or repair bins which have been damaged or lost by the council. Where the damage is deliberate or negligent then a charge for the replacement could be made.

If I move house, could I take my garden waste bin with me?

The proposal is that if you move within West Lindsey, we would transfer your contract to your new property where your service will continue. We would like you to let us know if you are moving house so that we can alter our records. When you move house all bins should be left at the property. This would ensure that the bin is available for the new occupier to continue with the subscription if they wish. If you are moving outside of West Lindsey or would like to cancel your contract you could do so, but you would not be entitled to a refund.

Could I keep my garden waste bin for storage etc., if I didn't want to pay for the collection service?

Yes, although your bin would not be emptied from April 2018. If, at a later date, you chose to sign up, you could use your existing bin (providing it was serviceable.)

How would you stop residents without bins putting garden waste in my paid-for bin?

You should ensure that your property name or number is clearly marked on the garden waste sticker that we would provide you with. Your bin should be placed in a location that is difficult for others to put waste into (unless you choose to share this with them.) Retrieving your bin from the kerbside soon after it is emptied would also help to ensure that others did not use your bin.

I do not want to keep my bin. Would I be able to opt back in if I want to?

The proposal is that you can sign up to receive the service at any point during the year. The annual charge would run from 1 April to 31 March each year. If you were to sign up part way through the year you would be charged the full amount. A bin delivery charge would apply if we were to re-deliver your bin.

When would my bin be removed?

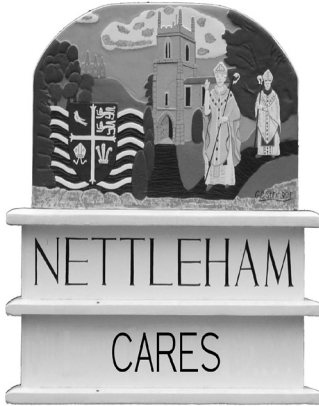
It is proposed that if you do not want to pay to sign up to the service, you could keep your bin but we would not empty it. If you chose to sign up at a later date, you could use your existing bin (providing it was serviceable.) The council would collect all unwanted bins in a phased manner.

Could I give my bin away or sell it?

Although the bin would remain at your property, the council remains the owner and you would not be allowed to sell or give your bin away. Those who are certain they will not use the garden waste collection service can arrange collection of their bin by contacting us.

Would there be delivery charges if I decided I did want a bin, having given it back?

If you were to return your bin and then decide to sign up for the chargeable service afterwards, the usual bin delivery charge for a bin would apply.



ZERO TOLERANCE

■ I feel disappointed to have to make this the first part of our newsletter this month, but after a few examples of rude and abusive behaviour from a very small number of patients, I am now required to remind those few that this behaviour is unacceptable and will not be tolerated.

We expect that you treat our staff with courtesy at all times. The staff work very hard on behalf of our patients and therefore we expect that they have the right to work in a safe environment. For this reason, Welton Surgery is committed to the NHS Zero Tolerance Policy. No form of violence or abuse is acceptable whether it be towards the staff or any other person on practice premises.

If a patient commits an act of violence against any doctor, member of staff, patient, or any other person present either in the surgery or on another premises where he/she is being treated, or behaves in such a way that any of these fear for their safety, this may result in further action.

INFLUENZA VACCINES

A reminder for those that haven't already attended, we now have our flu vaccinations in stock and our final Saturday morning (*ADULTS ONLY*) drop-in clinic will be held on Saturday 7 October, 2017, between 9am and 11am.

Annual seasonal influenza immunisation is recommended for people in the following groups, who are more at risk of the complications of influenza, including:

- All people aged 65 years and older (including all those aged 65 years on or before March 31, 2017).
- All people aged six months to under 65 years in the following clinical risk groups:
 - ▶ Chronic respiratory disease
 - ▶ Chronic heart disease
 - ▶ Chronic liver disease
 - ▶ Chronic neurological disease
 - ▶ Diabetes mellitus
 - ▶ Immunosuppression
 - ▶ Asplenia or splenic dysfunction
 - ▶ Pregnant women
 - ▶ Morbid obesity (BMI 40+)

Seasonal influenza immunization is recommended

in certain healthy people to reduce the risk of transmission to vulnerable groups, including:

- ▶ Children aged 2 years to under 8 years old on 31 August 2016 (including children of appropriate age for school years 1, 2, and 3), as part of the national childhood influenza immunisation programme.
- ▶ People living in long-stay residential and nursing homes or other long-stay care facilities (not including prisons, young offender's institutions, or university halls of residence).
- ▶ Household contacts of immunocompromised people, including carers (people who expect to share living accommodation on most days over the winter).
- ▶ People in receipt of a carer's allowance, or those who are the main carer of an elderly or disabled person whose welfare may be at risk if the carer falls ill. This should be considered on an individual basis, at the healthcare professional's discretion, and may include children who are carers.

Further dates for influenza clinics and children's vaccines to be announced (Children's vaccines not in stock as yet). If you are unsure if you are eligible please check at Reception.
