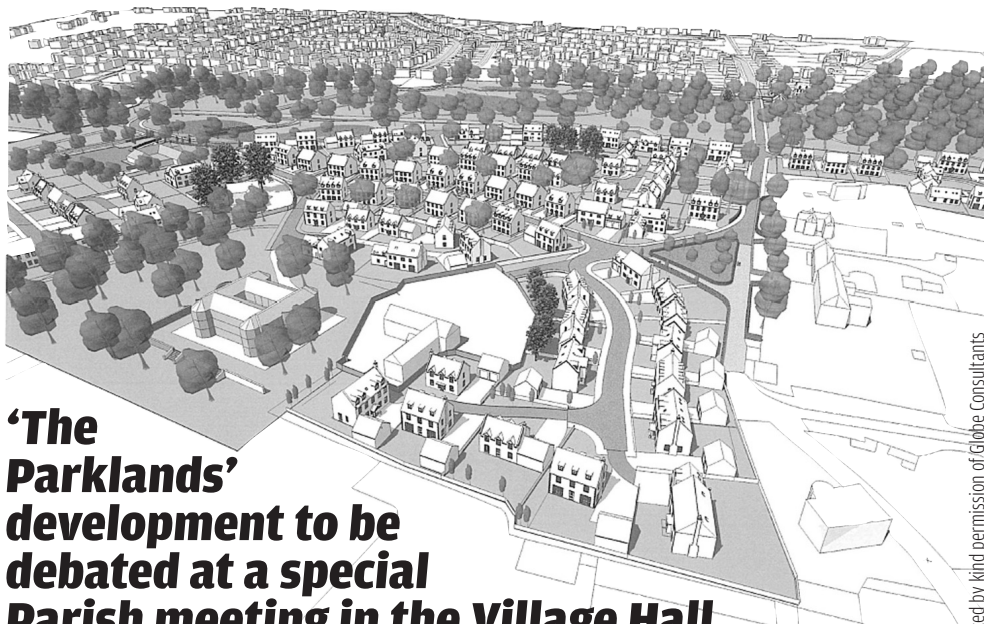

# SUDBROOKE DEVELOPMENT THE LATEST NEWS



## THE LOWDOWN

So, hybrid planning application 133284 was finally submitted to West Lindsey District Council on August 12, 2015, with 140 homes and 25 retirement apartments, as part of a new Sudbrooke Holme complex, mooted for Sudbrooke Park, which is to be called 'The Parklands'.

A new pub/restaurant has also been included in the plans, along with new allotments, and the creation of new footpaths and access roads.

It has taken months of planning, design work and surveys to get to this point, with builders Jackson & Jackson working with Lincoln firm Globe Consultants to come up with a very detailed plan for the new development,

Globe Consultants have produced a 35-page Integrated Planning Statement outlining the proposals, with in-depth details of the actual proposed development, planning policy considerations and a consultation overview, along with technical considerations.

In there are detailed drawings of how the development will look, the appearance of the houses to be built (some included below), along with results of several surveys carried out, including Highways, Trees, Ecology and Flood Risk.

Anyone wishing to object to the plans have to contact West Lindsey District Council's Planning Department by September 2 (21 days from the initial application), while there is a meeting at the Village Hall about the proposals on the same day, with matters expected to get fairly heated.

# PARISH COUNCIL MINUTES

June 2015

## Notes of the monthly meeting of Sudbrooke Parish Council held on Thursday 4 June in Sudbrooke Village Hall.

### COUNCILLORS PRESENT:

Councillors Peter Heath (Chairman), Stuart Curtis, Paul Rignall, Mrs Lyn Etheridge, Andy Cottam, County Councillor Mrs Sue Rawlins, Mrs C Myers (Clerk), Mrs B Solly (Treasurer)

### ALSO PRESENT:

Mr Dominik Jackson, Jackson and Jackson Development, Mr James Rigby, Globe Consultants, and in excess of 120 residents

## 48) 15/16 Proposals for Developing Sudbrooke Park

■ The Chair opened the meeting by stating that the Parish Council wanted to take in the opinion of residents of the village with regard to proposals of a residential development in Sudbrooke Park by Jackson and Jackson Developers. He suspended Standing Orders in order to allow residents to take part for a limited time and ask questions of Messrs Jackson and Rigby.

The Chair stated that meetings of the Parish Council had not been held 'in secret' with developers. However, it would come back to the Parish Council to make judgments in the best interests of the village, hence some questions had been put to the developers in advance of this meeting and it was hoped that they could be answered for clarification.

District Councillor Stuart Curtis gave an update on the emerging Central Lincolnshire Local Plan relating to proposals for future development in the area and also gave general advice on existing planning policies under which present planning applications are determined by West Lindsey District Council.

Mr Jackson and Mr Rigsby stated that they were interested in working with everyone. They answered the questions previously put to them written in italics.

### Amenity Area

Will a commuted sum be provided for future maintenance of that part of the Amenity Area to be designated to the Parish Council?

What extent of potential amenity area would be accessible to the village compared to that under development? What is the total extent of the development and is it to be solely residential?

*A commuted sum would be made for rolling maintenance. There would be long-term maintenance of the amenity area, building on the existing footpaths, surfacing to the highest quality. There would be new footpaths into the woodland, additional benches and outdoor gym equipment, walkways around the water. This will be gifted to the village. There is also a proposed extension into the Ten Acre Covert.*

*The Woodland Trust was interested in taking over the woodlands.*

*The proposed development was for up to 140 houses.*

# PARISH COUNCIL MINUTES

## Highway Matters

(a) What steps will be taken to safeguard or remove the legal right of access to the park gates on Main drive by those who currently enjoy that access. Is there an intention to block road access to the gates from the bridge on Main Drive?

*The current access on the A158 would not be taken away. New residents would be discouraged from using this route as a short cut. There would be a change in the surface treatment of Main Drive. Consideration would be made to putting covenants on the sale of properties so that new owners cannot change access.*

(b) Would financial contributions be available in the event of the Highway Authority agreeing to provide traffic lights at peak time periods at the A158 junction and additional passing bays along Nettleham Lane?

*An independent consultant in Leeds had carried out an assessment which would be submitted with any planning application. LCC Highways would have the opportunity to agree or object at that time.*

## Retirement Homes

(a) What would be the total number of apartments within the proposed building?

(b) Would local residents have priority over those people outside the area?

(c) On the basis that the apartments would be leasehold, what plans do you have to form a Management Company to maintain the building and communal areas?

*There would be 25 retirement homes - proposal to rebuild Sudbrooke Holme  
Local residents would be given priority. This would have to be written into the planning application.  
They would be leasehold with a management fee.  
There would also be a small number of two-bedroom bungalows.*

## Protected Trees

What significance is the developer giving to protected trees? How can the scale of development proposed take place without major destruction of the amenity and wildlife value of the trees - the reason for which they were initially given TPO status?

*There will be a need to fell trees to facilitate access. Compensatory tree planting will be carried out within the development. Developers willing to work with WLDC to ensure trees are planted early and are of an acceptable age. The Developer would look at which trees required to be removed for access.*

## Protected Wildlife

What ecological surveys have taken place and what were the results?

In addition to the impact on wildlife and ecosystems generally, how will the environment for known protected species be managed or enhanced?

*A site survey was carried out last summer - these show no protected species had been found on site. Badger and bat surveys are being carried out. The developers would look at the wildlife plan for the area. Wildlife will not be recklessly endangered. Poultry sheds within the woods would be removed.*

## Drainage

Will additional storage facilities be required to manage increased run-off from development - if so where and how big will this be? Who will maintain and fund this long term?

*Additional storage facilities would need to be created, as shown on the plan local engineers have carried out a drainage survey, Greenfield run off rates will be achieved. Drainage will not increase flood risks elsewhere or result in localized drainage issues. An additional pond would be made.*

Discussion/questions ensued at each point, with residents expressing extreme concern about any proposed development in the Park area; there being an obvious increase of vehicular traffic at Scothern Lane junction and on Nettleham Lane, this being a single track road; the ingress/egress onto the A158 via Main Drive/Park Gates which in its present form could not be adopted by Highways - the entrance at the Park Gates being of insufficient width; the increase on medical services in the area; the increase in numbers of pupils for schools; the destruction of woodland and the effect it would have on protected species that do exist in the woods - this was argued with Messrs Jackson and Rigsby.

The Chair drew the Public Forum to a close at 8.45pm. Residents continued to view the drawings of proposals.

Standing Orders resumed at 8.55pm and the Parish Council meeting continued in the Bramham lounge with one resident present.

## 49) 15/16 Any other Parishioners Items

■ A further complaint had been made about the condition of the footpath between Main Drive and Fox Covert. Members agreed to discuss this again at the end of the required six-month period at the September meeting of the Parish Council.

A resident had brought to the attention of the Clerk that the grass cutting in the vicinity of Courtfield Close was poor. It was noted that the daffodil foliage had prevented cutting back, but that this would soon have died back completely allowing full cutting.

Copy letter received from resident of Wragby Road sent to Staying Alive at Lincolnshire concerning cars parked in slip road at junction of Scothern Lane/A158 when dropping children off at the bus stop. Agenda item for next meeting of the Council.

## 54) 15/16 County Councillor's Report

CC Mrs Sue Rawlins stated that the initial review of the proposed library closures was into the second round.

Boundary Review - CC Mrs Sue Rawlins explained that the County Council is aiming to reduce the number of Councillors from 77 to 71 so some electoral boundaries would be changing. It is unlikely that this would affect Sudbrooke.

## 55) 15/16 District Councillor's Report

DC Stuart Curtis reported on a planning application for 200 homes in Nettleham on land to the rear of Larch Close.

## 56) 15/16 Report on Matters Outstanding

**a) Installation of CCTV at Village Hall:** This had now been completed and handed over by the installers to Alan McCrone, Chair of Village Hall Committee and Councillor Stuart Curtis, by Councillor Mrs Lyn Etheridge and Resolved to go forward as above.

**b) Siting of notice boards - update:** The posts had been delivered and it was hoped that the notice board would be sited within the next two weeks.

**c) Tree Preservation Orders in Village:** Nothing further to report.

**d) Strimming of footpaths in village:** A price for strimming was awaited from the grass cutting contractors prior to a grant application form being submitted.

Proposed by Councillor Paul Rignall, seconded by Mrs Lyn Etheridge and Resolved that the grant application be submitted to LCC when pricing was received.

**e) Notification of street lighting replacements - St Edward's Drive:** Notification received from LCC Highways that the replacement lighting scheme would commence in July 2015 and take duration of four weeks to complete.

## 58) 15/16 Weed Treatment in Village - Quotations Received

■ Two quotations for weed treatment had been received. Quotation (A) in the sum of £184.00 for the season (three sprays). Quotation B in the sum of £180.00.

Following consideration of the quotations it was decided that the current contractor continue to carry out the weed spraying in the village - Quotation A - West Lindsey District Council.

Proposed by Councillor Andy Cottam, seconded by Mrs Lyn Etheridge and Resolved that the Clerk purchase a replacement First-Aid Box up the cost of £40.00.

## 61) 15/16 Planning Matters

■ The meeting earlier in the evening with Jackson and Jackson Developments was discussed.

Members were disappointed that they had not had the opportunity to view the suggested proposals on the documents brought by Mr Jackson.

The public part of the meeting was discussed and it was felt that due to the strong reaction of residents, the Parish Council needed to meet Mr Jackson in a non-public meeting to understand what is being offered to the village through a Section 106 Agreement in his proposed planning application, emphasising that should an application be granted planning permission, the village needed to be able to gain the maximum benefit.

It was agreed that a letter be sent to Mr Jackson asking that he hold a Public meeting to address all the concerns that parishioners had raised earlier in the evening.

■ The Chair expressed concern about recent unpleasant letters sent to the Parish Council from residents. He emphasised that members seek to work for the entire community and the comments made were unjustified.

■ Three letters from residents in Sudbrooke Park which received replies accordingly.

Although verbal confirmation had been given, written confirmation had not been received from the landowner for permission to place a seat/bench on Beech Tree Corner. The Clerk had therefore written to the landowner on June 3 advising that unless the Parish Council heard to the contrary within 14 days, arrangements would be made for the seat to be fitted.

## Brief report of meeting held on July 2, 2015

■ **Jubilee Garden:** A letter had been received from a resident expressing concern about the untidy state of the Jubilee Garden. Members instructed the Clerk to request that the grass cutting contractors cut the shrubbed area to a shorter height. Since the meeting, residents Bernard Bartram, Dave Marshall and Stuart Curtis have pulled out the weeds/grass growing through the shrubs to prevent them from being 'choked' and give the area a better appearance.

PCSO Payne was in attendance to speak about the recent anti-social behaviour in the village, which had resulted in vandalism in the Holme Drive area and broken glass in the Northfield Park play area, resulting in a special 'sharps clean' of the area by a contractor.

## Dear Residents of Sudbrooke

I have been asked by the Parish Council to raise your awareness to the dangers of parking on the slipway of the A158 opposite Cherry Tree Cafe. It is convenient when waiting for bus passengers to stop either on Scothern Lane or if congested then the slipway itself. The dangers of doing so need to be emphasised.

In parking there you block the slipway forcing eastbound vehicles to go around you on to the A158 i.e. directly onto the busy road without the the streaming affect of the slip road. By parking there you also block the vision of westbound traffic to emerging vehicles.

If you must wait at the junction of Scothern Lane and Wragby Road then wait on Scothern Lane well away from the actual junction and accept that your passenger may have to walk a short way to the bus stop.

One of the reasons for repositioning the Parish Notice Board from there to the Park gates was the difficulty of parking for the Clerk, and the dangers she faced when updating the notices by having to operate close to such a busy junction.

Please park sensibly and don't be a danger to yourself or anyone else.

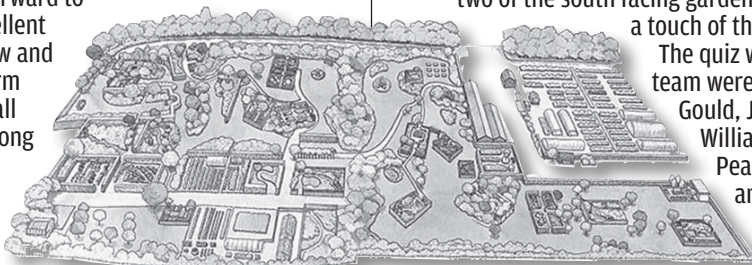

# ARE YOU FED UP WITH THE OVER-DEVELOPMENT OF THE LINCOLN FRINGE VILLAGES? [www.SaveOurSudbrooke.uk](http://www.SaveOurSudbrooke.uk)

## A MESSAGE FROM THE SUDBROOKE PARK RESIDENTS ACTION GROUP

■ Doesn't it seem to you that the Lincoln fringe villages - Nettleham, Scothern, Welton, Dunholme and North Greetwell, to name just a few, are having to put up with more than their fair share of development, whilst getting precious little in return in the form of the much-vaunted "Section 106 agreements", whereby developers are supposed to contribute to the local infrastructure or amenities in some way?

This is amply demonstrated in the case of Sudbrooke Park, with the application by developers for a "sympathetic" scheme of 140 houses, plus retirement apartments. There are many people in the surrounding villages and in Lincoln itself who enjoy walking, cycling and horse riding in Sudbrooke, and have done so for years.

But not for much longer. Visit the developers' website at [www.parklands-sudbrooke.co.uk](http://www.parklands-sudbrooke.co.uk) and take a look at all the plans and other documents. You'll see from page 35 of the Tree Survey that vast swathes of the historic woodland and wildlife habitat will be lost, and what are now public footpaths through woods and fields will become public footpaths along new roads lined with housing. The walkers and cyclists will just have to go elsewhere - with the wildlife hot on their heels.

And what will Sudbrooke get in exchange for all this? A new pub/restaurant, an outdoor gym (yes, really!), and a new "lake" (which isn't for our benefit, but necessary to accommodate the run-off water from the site), a few allotments, a derisory extra path or so in the form of a sanitised woodland walkway - not to mention the "community orchard"!

Most people aren't interested in any of these and with the possible exception of allotments, very few people, if any at all, have asked for them. What people in Sudbrooke are interested in, is where they're going to educate the new residents in the developments going on in all these villages which share the same local facilities, and what enhancement of medical services will they provide?

Will there be an increase in GP surgeries? This is only the tip of the iceberg - what about hospital and specialist facilities, as well as out-of-hours and ambulance resources, which are stretched well beyond capacity already? Then there are the roads.

There's no clear proposal of how to deal with the growth in traffic on the A158 or A46, let alone the greater volume travelling through Sudbrooke, Scothern and Nettleham, all trying to access the roads via the same junctions, and often at the same time.

If 140 houses are built at Sudbrooke, for example, even at only two cars per household, that's another 280 cars minimum trying to access the A158 (which is a "red route"!) maybe at least twice a day - apart from commercial traffic.

The Transport Assessment you'll find on the "Parklands" website won't cut it - and let's remember, all these surveys in the supporting documentation have been commissioned and paid for by the developers.

The concerns of Sudbrooke residents are exactly the same concerns as people in the other local villages have - whilst West Lindsey District Council's Planning Committee insists on considering each development application on its own merits, and fails to take account of the overall picture and the cumulative effects of the same scenario being repeated time after time in all the surrounding villages.

So although you may think the Sudbrooke development will only impinge on people living there, you can see that it will have a knock-on effect on all the other villages as well.

The planning application for Sudbrooke would therefore be an ideal opportunity for anyone concerned with the future quality of life in this area to make their views known to West Lindsey District Council, by post to:

There are only 21 days allowed for this from the date of "The Parklands" planning application, so if you want to comment, in the interests of your own village too, make sure you don't miss the deadline, or your views will be ignored!

### Dear Editor,

I have seen the publicity put out by the Park Residents group and feel that the full story is not being revealed.

The Group has failed to state that the land in question is Private land to which we, as villagers, have NO right of access, apart from Public footpaths, and that if the application succeeds the village would get ownership of those very same woods.

Such ownership would allow complete access not simply through new constructed paths.

The woods and walks in question have been closed to us since just before the change of ownership and caused outrage from those who had enjoyed walking there.

However, it was only the indifferent attitude of the then land owner that allowed this to happen. This anger led the PC to start the process of requesting the adoption of further footpaths which would affect the areas proposed for development.

The County Council control the procedure for adopting footpaths and I believe that the WLDC should note of the routes that may be adopted when making their decision on the application.

I have not made up my mind about the development and want to see the full plans in detail, but I have to acknowledge the owner's right to use his land as he wants and within the law. However, at the moment I feel it's like telling your next-door neighbour he can't lay a patio because you like the shrubs in his garden!

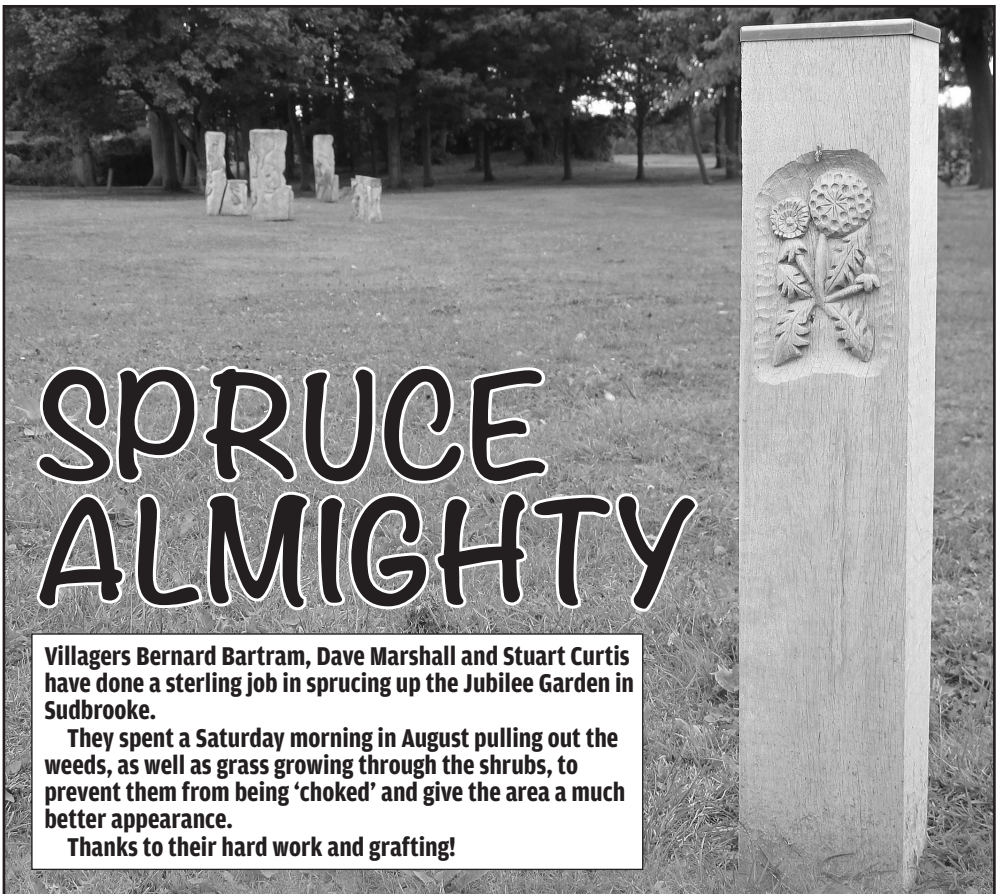

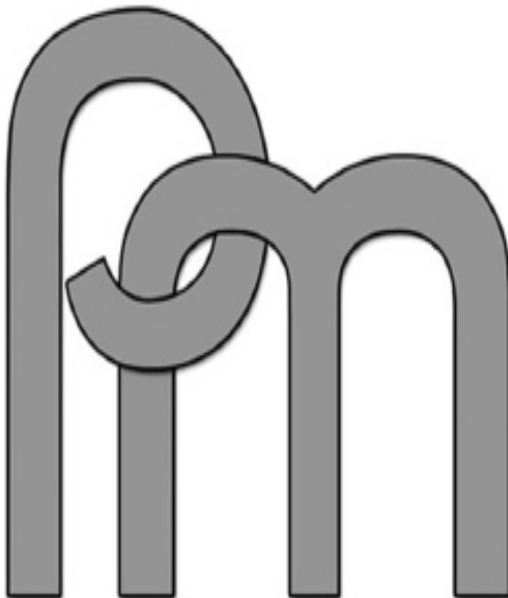

### FLU CLINICS

■ It's that time of year again when the practice once again start to plan the annual flu clinics.

We are pleased to announce that our flu vaccination clinics will commence at the beginning of October and run periodically until the middle of November.

Influenza is a virus causing a lung or respiratory infection. While for most people it is only an unpleasant illness that should pass in about a week, it can cause serious complications, particularly in young children and older adults.

Getting a flu vaccination is the most effective way to stop you catching flu and passing it on to others.

Vaccination is available for patients who fit one of the criteria listed below:

- Pregnant (at any stage of the pregnancy)
- Children aged 2, 3 or 4 years of age (the vaccination is delivered via nasal spray rather than injection)

• A Carer (If you are the main carer for an elderly or disabled person, their well-being could be placed at risk should you fall ill)

• Aged 65 years or over  
• Aged 6 months and over and suffer from any of the following conditions:

- ▶ Chronic respiratory disease
- ▶ Chronic heart disease
- ▶ Chronic kidney disease
- ▶ Chronic liver disease
- ▶ Chronic neurological disease
- ▶ Diabetes
- ▶ Immunosuppression

## INFLUENZA VACCINATIONS

■ By the time you read this we should have our 'flu clinic plans firmly in place.

The Practice is planning to hold two or three drop-in Saturday clinics (no appointment necessary) and some clinics on our Monday late nights and throughout the week for those that are eligible.

If you are seeing a clinician for other reasons and think you are eligible, please ask them during your consultation.

We will also be routinely offering the nasal vaccine to all children that are aged two, three and four on August 31, 2015. That is, children with a date of birth on or after 1st September 2010 and on or before August 31, 2013.

All pregnant women are also eligible and this can be discussed with your midwife or you can attend one of our 'flu clinics.

We will not routinely write to patients so please do not wait for an invitation - please contact Reception for more information.

## DNAS (DID NOT ATTENDS)

■ In July, patients did not attend for 45 doctors' appointments and 65 nurses' appointments.

This is a total of 110 appointments and 18.3 hours of clinical time. Please try to help us by cancelling appointments as soon as you realise they are no longer required - you can do this in person, over the 'phone, by text or online.

## FRIENDS AND FAMILY TEST

■ The Practice is taking part in the national Friends and Family Test scheme and would value your input. ## OVER ORDERING MEDICATION

■ We have recently had lots of medication

returned to us that had been stockpiled in patients' homes. Please can we ask patients not to re-order medication which is not required / needed at that time.

When drugs are returned to us like this, we are unable to put them back into stock and can no longer send them to third world countries and so they are unusable and wasted.

Often these drugs have to be destroyed and one example recently was the return of over 1000 tablets which had cost the NHS £60 and then another £20 in destruction kits plus the staffing time taken to do this.

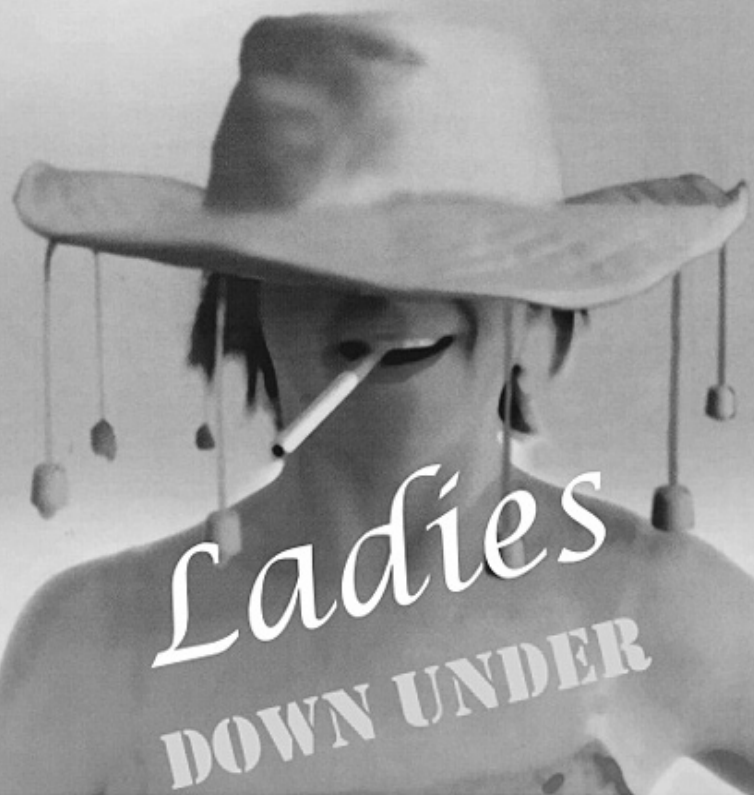
