




A BIG THANK YOU

c) Christmas Tree event November 25... i. Approval of purchase of Christmas tree: Unanimously Resolved that the Christmas tree be purchased through Glendale Ltd who would erect the tree.

ii. Arrangements for the event: A gazebo would be loaned, along with heater for wine; lighting at the event would be provided by a resident; mulled wine to be purchased; hamper to be made up by Clerk to value of £25; mince pies to be ordered; licence to be applied for; consideration given to attendance at tree by Santa. Mrs Solly would make enquiries with EB School for attendance by its choir. It was also noted that replacement lights for the tree may be required after this year.

The above was unanimously Resolved. ▶ d) Sports event - September 8, 2018 report: Due to the weather the sports had not been able to be held, but it was reported that the stalls and music had taken place inside the hall and been enjoyed by those attending.



SUMMARY OF PARISH COUNCIL MEETING HELD ON NOVEMBER 1, 2018

▶ Co-option of Councillor: Mr Mike Turnbull was co-opted to the vacancy on the Parish Council.

▶ Repairs to play equipment: The Parish Council approved expenditure on the play equipment at both sites. These repairs are as recommended in the RoSPA annual report.

▶ Litter Pick - Report from the organiser: 'With the October weather threatening to rain, 16 intrepid locals took to the streets of Sudbrooke as part of our regular Litter Pick sessions to tidy up the general appeal of the village. Armed with high-vis jackets and litter grabbers, the volunteer's split into 6 teams and worked diligently to collect huge amounts of glass and plastic bottles, fast food containers and tin cans from paths, hedge bottoms and ditches and waterways around the village.

As well as the usual rubbish also collected was a number of unusual items including the remains of a significant number of party balloons, as well as left over equipment from the recent road and

electric works on Scothern Lane. A huge thanks to all the volunteers who gave up a couple of hours of their time; all are welcome at the next session. And a reminder to anyone dropping litter in the village, please remember that someone has to clean up your mess so please take your rubbish home.' Donation of tree obtained by resident from the Queen's Commonwealth Canopy: Consideration was given to where the tree could best be planted. It was felt that the new sports field would be a good location. Trimming of trees Courtfield Close/ Holme Drive: Thanks were extended to a resident who had kindly cut the lower branches from the trees in this area. enabling better access for the grass cutting machinery.

PUBLIC MATTERS WITH DISTRICT COUNCILLOR BOB WALLER

WINTER WORRIES

▶ In the November issue I highlighted the opportunity for residents to have their say on the WLDC budget. One of the areas covered was council tax and this has given rise to questions relating to who pays and how is it proportioned?

Council tax is a local tax set by local councils to help pay for local services. Council and Police services are paid for by government grants, council tax, fees and other charges. There is one council tax bill

for each domestic dwelling whether it is a house, flat, mobile home or houseboat.

West Lindsey Council collects the council tax, but keep less than one ninth of it. The rest is given over to the Lincolnshire County Council, Police and Crime Commissioner for Lincolnshire, Parish and Town Councils.

Council tax is usually paid by the owner occupier or the tenant of a property. Where there are two or more people who are joint owners or joint tenants, they are each responsible for paying. Married couples, civil partners and people living together as a couple will be jointly liable for the bill while they both live at the property; this is the person or persons who come highest in the following list:

• You own the freehold of the property

• You hold the leasehold of the property

• You are a tenant • You have some other right of occupation • You are a

resident In the following circumstances the

owner of the property will be the person who must pay:

• Houses in multiple occupation - this is usually properties divided into bedsits

- Dwellings occupied by resident staff
- Residential care homes
- Religious communities
- Asylum seekers

So, as you can see not all your council tax is spent on the immediate area, but is used to provide county-wide services.

TIME OF THE SEASON

MEET THE NEW OWNERS OF

FROM LANCASHIRE, VIA DEVON AND TENERIFE, TO SUDBROOKE

There's a change in the air at Sudbrooke's only eating establishment, with the distinct smell of that English classic, fish and chips, wafting from the Meditteranean-style premises.

And it's all thanks to new owners Paul and Marsha Jackson, with son Mark, who have upped sticks from Clitheroe, in Lancashire, to breathe new life into the Cherry Tree cafe & bistro.

With the cafe having been on the market for the past few months, the Lancastrian couple have taken over the business and one of the first things they decided to do was add fish and chips to the menu, giving diners the option of eating in or taking away.

"We'll be serving haddock amongst other fish," explains Paul. who shows me three lovely fresh portions of the popular fish, "with chips, mushy peas and homemade tartare sauce. We'll still be doing the Sunday carvery as well as that is very popular."

Front-of-house worker Paul Rignall, one of the recent additions to the staff roster chips in: "Sunday lunches are still great."

The Jacksons are hoping to appeal not just to passing trade, but to the locals as well, adding: "We want to attract everybody, we want as many as people to come here."

When asked about his background, Paul laughs and tells me: "We have been in the business for 20 vears and this

is the last



one. We're from Clitheroe, in Lancashire. We were looking around for another business, saw this one for sale, came to have a look at it. put an offer in and it was accepted.

"It's a lot quieter than I thought it would be, but we've had a couple of good Sundays though.

"We have had chippies in Blackpool, Devon and Yorkshire, and we had three years in Tenerife - we had a tapas restaurant and wine bar. "We came back because I had a

heart attack out there and I thought if anything else was to happen. I'd rather it happen over here (in the UK).

"We're living down at Cherry Willingham at the moment. We haven't bought the house that came with the cafe yet, that'll be next year

- we do have options to buy it." Paul's wife adds: "It's lovely around here. We've been to a few places already - it's all flat.






I'm really looking forward to. "We also have Black and Whites coffee on offer for that cappuccino or latte, etc...

Tonight (November 15) on Radio Lincolnshire, Sudbrooke was mentioned and police stated that extra patrols would be patrolling because of an incident in St Edwards Drive. Whoopee! Extra police patrols! It will be great to see a uniformed officer in the village... I haven't seen one in here for years.

The reason given was because someone had apparently cut back a hedge overhanging the public pavement by about three feet or more without consulting the owner of the hedge from who's property it protruded over the highway, restricting the passable width of the pavement from eight feet to a mere three feet where it met a lampost.

Police apparently consider a serious offence (enough to warrant a mention on the radio and in local neighberhood crime bulletins.

Is it me or was there no mention of the offence under the Highways Act being committed by the homeowner? Why was that person NOT reported for what was obviously a long-standing blatant offence of permitting his hedge to encroach over the public pavement preventing the use of the the area over which it stood by pedestrians.

I would like to remind police of the statement of Lord Chief Justice Goddard, who defined "Obstruction of the Highway' as being where the presence of any person, object, item or vehicle over an area of the highway prevented that area over which it stood being used or walked or driven and was an offence without lawful excuse.

Look if up if you have forgotten your basic police training. It is stated in the very first introduction of the Highways Act of which there have been numerous addition and amendments over many years, but this definition has never altered.

There are numerous other hedges in this village which encroach over the pavement and it is about time the Parish Council and police took steps to enforce the law and make the public aware of their obligations to trim back their hedges. Perhaps a few fines would bring home to folks their duty to keep within their bounderies .

Would it not be possible for a Parish Council volunteer or employee to report illegal encroachment of the highway and take cases to the courts and not leave it to the odd individual who finds it nessesary to bring it home to offenders that they need to trim back their hedges by cutting them, which has clearly happened on this occasion and so angered police?

There are two Places in St Edward's Drive where overgrown hedges actually completely covered the pavement... the worst being at No.15 You have to actually walk on the roadway to pass it. This has not just

happened, it has taken years to get to that state. Why are the Parish Council allowing this to happen?

So far, no culprits have been caught, but neither do they seem to have struck again, although the story brought up the issue of overgrown hedges, with a local resident writing into the magazine with his thoughts on the matter you can also read the Parish Council's reply to him, below. The mystery continues...

Dear Mr Wharton

I have been sent a copy of your email to the editor of **Sudbrooke** News and found your comments about the Parish Council offensive and incorrect. The contact details of the Parish Council are printed on the back of every **Sudbrooke News**. Rather than "grandstanding" to the editor you could have contacted us

with your comments and heard first hand what our actions had been. The condition of the hedge to which you refer has been raised during Parish Council meetings by members on at least six occasions since January 2016. The house in question was occupied by an elderly resident who we understand to now have moved into a Nursing home. The house is being looked after by a relative. We have written to the owner about the necessity of cutting the hedge back, but have had no response.

You yourself further reported the hedge to a Councillor in June 2018 and the matter was raised and minuted as follows: 'A resident had drawn attention to the overgrown conifer hedge on St Edward's Drive. This had previously been observed by LCC Highways two years ago and considered that no action be taken at that time. However, the hedge had continued to grow and was now covering the footpath. The Clerk had further reported it to LCC Highways and upon the Chairman's instruction had written to County Councillor Sue Rawlins requesting her intervention. A reply was awaited.'

Reference is also made to the hedge in the July and September 2018 minutes, all of which are printed in the **Sudbrooke News** for residents' information.

As you will see the Parish Council has raised a complaint about the obstruction caused by the hedge with Lincolnshire County Council Highways department who have responsibility for the maintenance of roads and pathways. They have informed us that they have written to the owner, but have had no response and have since started statutory procedures in order to legally deal with this matter.

The Parish Council consider this obstruction to be a road safety issue and have requested our County Councillor to take up the issue with the head of LCC Highways to resolve it.

As to taking direct action, the recent publicity over hedges in Sudbrooke has shown that the police regard it as a civil matter.

The members of the Parish Council are all volunteers who give their time freely not only for the monthly meetings, but organising and running events to benefit the village, such as generation of a Neighbourhood Plan, Litter Picks, A sports day, the Christmas tree lighting and many other activities. If you feel that we are not up to the job then perhaps you should stand for the Parish Council in next year's election. Peter Heath, Chairman Sudbrooke Parish Council

A PENSIONER REMINISCES:

F you've been reading this wonderful village magazine for a while, you'll be aware that I spent some time in the RAF, but that was only until I was 30 years old, so how did I cope with life out there in civvy street?

Nowadays people who come out of military

a trip away from camp to pick up some radio isotopes from a nuclear facility and return to Waddington and fit them close to the engines where they could be photographed using a gamma source (bit like taking X-rays), saved taking the engines off the plane in order to inspect them. So all I left Waddington with was a handshake and the words "good luck" ringing in my ears, from my flight commander, and the gates closed behind me. I was

watching a programme recently on TV, where



another place. But here I was in the same boat, with a growing family to feed, and limited prospects. I refused to go on benefits, and on the Monday morning went out and bought a second-hand baby Austin car for $f_{.15}$, a ladder and a bucket, and began knocking on doors to see if I could build up a window cleaning round.

A friend of mine, Dave Brook, had done the same thing a few months before and appeared to be making a success of it. I was soon making a modest living, and the bills were being paid. I was capable of carrying out small domestic repairs,

and broken items like electric kettles, toasters, irons, hairdryers, etc. were within my capabilities and something I could do in the evenings.

People chuck them away now, but not then. Spares could be obtained from a local Lincoln wholesaler, (no Amazon around then) and queuing up at the counter brought me into contact with local electrical contractors. I always used those occasions to pump them for information with loads of silly questions, but that's how you learn, eh? My small terrace

house in Lincoln needed rewiring and not being able to afford that, I bought a book on how to do it yourself, and carefully reading the instructions, set about the job.

It wasn't too difficult, even with my primitive hand tools and lack of knowledge, and on completion, the Electricity Board tested it and connected it to the supply. Gradually I offered to do similar work for friends, and in the fullness of time went to night school to learn a

bit more about electrical contracting, and finished the course being capable of doing this work in strict accordance with current regulations.

It was suggested by my peers that I applied to the body that governs this work, the National Inspection Council for Electrical Installation

Contracting, and at the second attempt was accepted as a member, and work came in from builders, architects, local authorities etc.

My neighbour and good friend Dave had been an electrical apprentice before joining the RAF, but only for about a year, and we decided to pool our resources, pass on our window cleaning rounds to another friend, and in 1969 launch out as Brook and Mayo Electrical. Along the following 50-year journey, we had our fair share of ups and downs as the business had both good and bad years.

The worst during the 80s, when house building dragged to a halt, and we had to search around for alternative work. We had been doing pretty large estates, especially down Brant Road and on the Birchwood, and as far away as Grimsby, and was forced to lay off staff who had become our friends. Just in time we got a contract to wire the new Damons on the A46 bypass which kept us going for the next few months.

Dave and I were together for 30 years, but work pressure was taking its toll, and he

decided to move back to his roots down south, and I bought him out. Not many years later he died of leukaemia, a very sad day.

My son Nick had come into the business in 1982 and later I made him a partner, and though I've been left for many years now, he has taken the business from strength to

strength.

They have recently acquired new offices in Nettleham for a six-figure sum (directly opposite the police headquarters

on Deepdale Lane) and are already extending them to allow for the plumbing firm Andrew E Barnes Ltd that Brook and Mayo Ltd have recently acquired to join them in the same building. Their latest accolade is to have been voted by the electrical industry as best electrical contractor of the year for 2018, the story is in the Electrical Times. With a multi-million pound turnover, I see no reason why they shouldn't be around for a long while to come! All I did was to get on my bike!


