

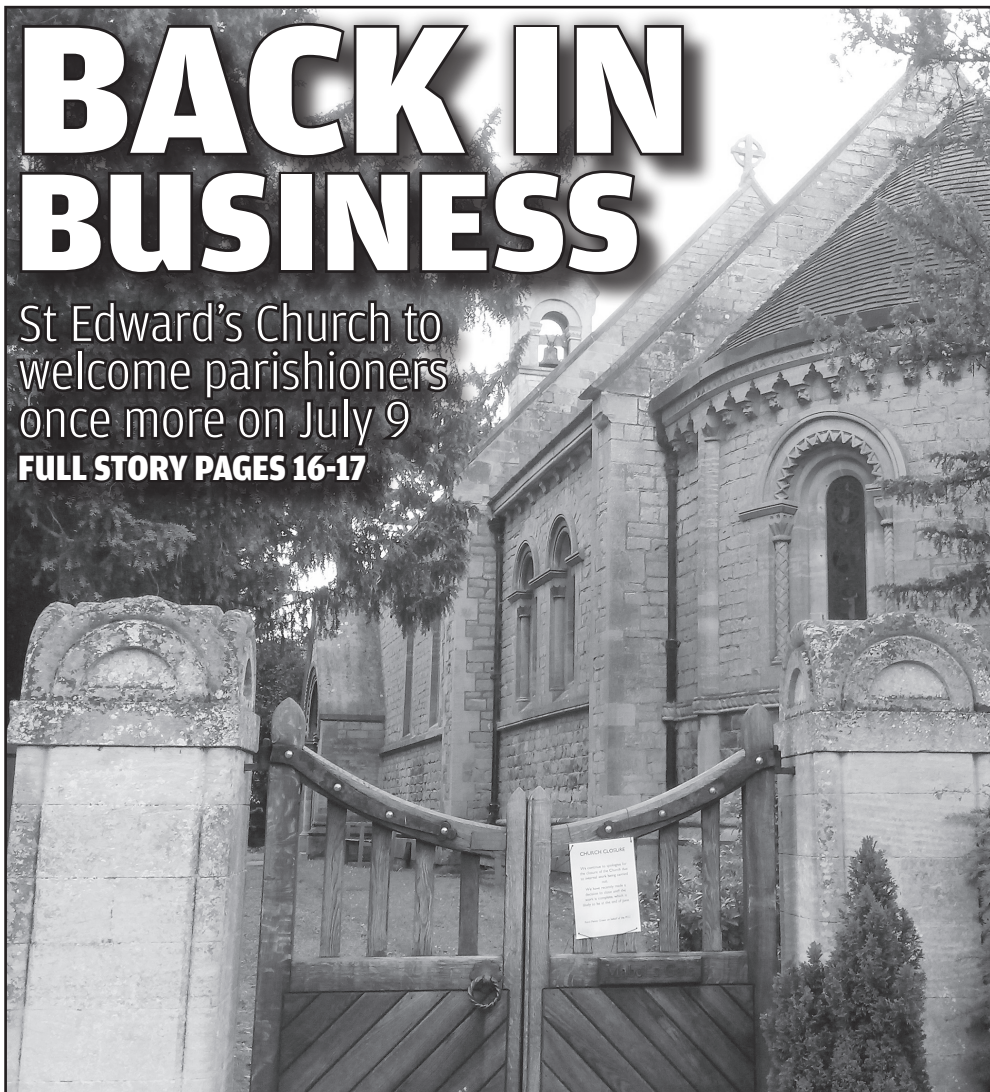

# VILLAGE SIGN

## UPDATE

■ Coral Evans and the team of wood carvers have now completed the carving on the tree trunk, currently laid in the Village Hall car park. A grant of £100 has been received from the District Councillors Initiative fund for the metalwork showing 'Sudbrooke'. It is a splendid piece of work. Now the siting - not quite as simple as it may seem...

If the sign is to be put on the highway verge, LCC Highways have stipulated that it be three metres from the edge of the highway. Obviously services in the verge also have to be avoided. Its siting would also have to be carried out by a LCC Highways 'approved contractor'.

The Parish Council have considered various places - areas on Scothern Lane and outside the Village Hall. It had agreed for the sign to be sited in the Jubilee Garden fronting Scothern Lane, adjacent to the footpath. Any further ideas for its siting could be re-considered by the Parish Council, but the above factors need to be taken into account.

It will require fixing into the ground or preferably mounting on a foundation - can any resident design a foundation or recommend a builder who could do the job?

# PARISH COUNCIL MINUTES

May 2017

## Notes of the monthly meeting of Sudbrooke Parish Council held on Thursday 11 May in the Sudbrooke Village Hall.

### PRESENT:

Councillors Peter Heath (Chairman), Andy Cottam (Minutes), Stuart Curtis, Ian Russell, Lyn Etheridge, Miss Rose Dobbs, Paul Rignall, Mrs Bridget Solly (Treasurer)

### 22) Parishioners' Items

■ The following items were raised by parishioners:

▶ 4 Courtfield Close. Concern about height of trees. Clerk to speak to highways.

▶ State of drainage ditch and infringement of covenant of parking a caravan, Fox Covert. The Chairman stated that the drainage ditch would be the responsibility of Witham Drainage Board, but no problems of drainage in that area had been reported. The subject of covenants was not an issue that the Parish Council could become involved. The advice to residents would be to check with the solicitors for the original vendor.

### 23) Appointment of Chairman/Signature of Declaration of Acceptance of Office

■ Proposed by Councillor Ian Russell and seconded by Councillor Stuart Curtis that Councillor Peter Heath be elected Chairman for the 2017/18 year. Councillor Peter Heath duly accepted and signed the Declaration of Acceptance of Office.

### 24) Appointment of Vice Chairman/Signature of Declaration of Acceptance of Office

■ Proposed by Councillor Stuart Curtis and seconded by Councillor Mrs Lyn Etheridge that Councillor Bob Waller be elected Vice Chairman for the 2017/18 year. Councillor Bob Waller was unable to sign the Declaration of Acceptance of Office due to absence, but this would be signed at next Parish Council meeting.

### 25) Apologies

■ Councillor Bob Waller and Clerk to the Parish Council, Mrs Christine Myers. Resolved unanimously that the reasons given for being unable to attend be accepted.

### 26) To Receive Declarations of Interest on any item on the agenda

■ None declared.

### 27) Notes of the meeting held on April 6, 2017 to be signed as minutes

■ That the notes be signed as Minutes Resolved unanimously.

### 28) Police Matters

■ No incident statistics received.

# PARISH COUNCIL MINUTES

## 29) County Councillor's/District Councillor's Reports

- A) County Councillor's report: None received. Councillor Peter Heath congratulated County Councillor Sue Rawlins on being re-elected in the recent Local Council Elections.
- B) District Councillor's report: DC Curtis reported that the Central Lincolnshire Local Plan was adopted on April 24, 2017.

## 30) Reports on Matters Outstanding

- a) **New sports field/tennis courts tidying – use of National Citizen Service Action 2017 programme – update:** Clerk's briefing note read out. A discussion took place regarding disposal costs which had been received from WLDC for removal of cuttings. The cost was felt to be too high and it was suggested that a bonfire be held in the village car park to burn the rubbish.
- b) **Village sign – Update re siting from Consultant Engineers:** A further structural engineer's visit is required. In view of these problems, a discussion took place about siting the sign on the opposite side of the road close to the board showing the plan of the village. This proved to be a popular idea. Clerk to arrange a further site visit by LCC and obtain quotes for mounting the sign in the new location.
- c) **Electrical box check, Scothern Lane/Millennium Stone lighting – quotations received:** A further, more favourable quotation had been received and in accordance with minute 8-17/18 the work had been completed. Two bulbs had also been replaced in the millennium stone lights which were now working satisfactorily. Proposed by Councillor Paul Rignall, seconded by Councillor Peter Heath and Resolved unanimously that payment be made to the contractor.
- d) **Painting of park gates – update:** An offer has been made by a painter and decorator who lives in Scothern and lectures at Lincoln College. He was interested and felt that it might be something his students could do as a project. Cost to PC would be for materials only. He is going to look at the gates and report back to the Clerk. Agreed that this item be placed on the June agenda.
- e) **Defibrillator – training for use – update:** This took place on Monday 24 April and 11 residents attended. The trainer was asked whether we should have paediatric pads. Volunteers would not be instructed to use the defibrillator on a child. The hairdresser asked at the training event if she should have the code for the box housing the defibrillator. Discussion took place at the PC meeting and it was agreed that it would not be necessary for this as the code is given to whoever calls the emergency services.
- f) **Highway matters:**
  - (i) **Anything further to report on works required:** It was reported that a good job had been made on St Edwards Drive.
  - (ii) **Operation of LCC Highways Service – Update letter from Councillor for Highways and Transport:** The letter was read out at the meeting by Councillor Peter Heath and was noted for information.
  - (iii) **Letters from LCC re highways/amenity cutting:** There is confusion surrounding Highway grass cutting for 2017. It seems that we could be getting more cuts than usual and it will be a case of wait and see. Councillor Stuart Curtis requested that the Clerk ask Pat Wright to cut the field and mark out the running track a couple of days before Sports Day.

## 31) Offer by Rotary Club of Bailgate for Provision and Planting of Bulbs in the Village

■ It was agreed that the kind offer by the Rotary Club be accepted. Proposed by Councillor Peter Heath and seconded by Councillor Paul Rignall.

■ **b) Internal Audit Report:** This has been completed by Mr John Tomlinson and has been signed off with no issues.

### ■ c) External Audit 2016/17:

**(i) Consider, approve and sign Annual Governance Statement for 2016/17:** The Treasurer presented the 2016/17 Annual Governance Statement for consideration. Resolved unanimously that the Statement be approved and signed by the Chairman. The Clerk will also need to sign.

**(ii) Consider, approve and sign the Accounting Statements for 2016/17:** The Treasurer presented the Accounting Statements for 2016/17. Resolved unanimously that the Accounting Statements be approved and signed by the Chairman. The Clerk will also need to sign.

■ **d) Pensions Regulator declaration:** This had been completed by the Treasurer.

■ **e) Completion of authorised account persons form - Co-op Bank:** This had now gone through. Councillors Heath, Waller, Curtis and Rignall are now signatories.

■ **f) Grant for Neighbourhood Plan from Groundwork - unspent funds:** Unspent funds of approximately £3,800 need to be returned to Groundwork. The Neighbourhood Planning Group need to obtain an estimate of what is still needed. Bridget to complete a post-grant form online.

## 33) Planning Matters

■ **a) Sudbrooke Neighbourhood Plan – Report to date/application for grant funding for public events:** Nothing to report.

■ **b) Report on Nettleham Beck, retrospective approval of completed survey and PC support for improvement works to local becks, including Nettleham beck:** Would the PC support improvement works? Councillor Ian Russell has drafted an application which will be submitted shortly, with a result due in September. The Chairman thanked Councillor Russell for his work on this.

■ **c) i. Application 135618 – hybrid application for approval of reserved matters for up to 130 dwellings, a new building to provide up to 25 apartments for retirement living and a full application for a public house/restaurant as approved at appeal under hybrid application 133284 – land adjacent to Sudbrooke Park off West Drive, Sudbrooke – reserved matters application – comments to WLDC:**

Comments submitted:

**Condition 6 (i):** Preference would be for 10 per cent of the total site to be dedicated to the Parish Council as Public Open Space with an agreed commuted sum for future management. If, however, the applicant elects to transfer the land to a Management Company, provision must be made for access to the POS at all times for the general public notwithstanding any maintenance charges being met by the owners of the new dwellings. The PC would also need to be represented on the Management Company.

Proposed POS is understood to include existing woodland west and east of beck and around existing balancing ponds, part of 10 acre covert (between West Drive and Beck), area in front of proposed restaurant, part of biodiversity area (meadow/orchard) and some green areas within new housing.

Additionally, the compensatory new woodland to be planted to east of Lake field (immediately south of Scout camp) should also be made POS. This would mitigate the loss of access to woodland environment and compliment existing public footpath access around the village. Access to the compensatory woodland should be made from existing FP158 via the existing short track west of Scout camp.

Designating this area as POS is an ideal opportunity to provide an area to be enjoyed by residents and visitors of all ages, particularly schoolchildren and those visiting the scout camp, who could be involved in planting, surveys etc. thereby taking an active interest in a growing woodland.

**Condition 6(iii):** The proposed new road running parallel to public footpath FP816 on east side of Beck, between existing steel footbridge and West Drive comes extremely close to footpath in places, e.g. less than three metres between existing footpath and new road opposite plot 34 (Dwg (90)002). Such close proximity will mean the value and feel of the existing woodland walk will be lost due to passing traffic and noise and open views to housing.

The new road should be re-aligned eastwards to increase the distance to existing footpath, thereby reducing this impact. From the plans, there is adequate room to do so.

## 33) Planning Matters continued

The Parish Council welcomes new footpaths in POS. These should include “claimed” footpaths as the current application to Lincolnshire County Council wherever possible. Dwg (90)003 shows a new footpath crossing the Beck, though there appears to be no reference to a new footbridge. This particular crossing is also close to existing kingfisher breeding area. Further clarification is required.

Loss of protected trees (TPOS) should be kept to a minimum. From existing information it is difficult to determine exactly which trees will be lost. Landscape Design Report (p35) refers to tree protection and demolition plan, but not yet available (“in progress”).

Habitat creation and improvements should be explored and implemented to the full. Bird boxes should include those for swifts (declining species). There is reference to de-silting existing balancing ponds and selective tree removal around edges to allow light to enter, thereby increasing waterway biodiversity potential. The extent and cost of such works should not be underestimated if they are to make a difference. Further details are needed.

**Condition 13:** Any scheme to prevent vehicles from accessing the private drive (Main Drive) to A158 must allow provision for all existing property owners within the Park to continue to exercise their legal vehicular rights of way at all times to and from A158 Wragby Road.

**Condition 19** (Provision 25% Affordable Homes): The PC preference would be for starter homes with provision to remain affordable for first and subsequent occupiers with priority for existing local residents. If an essential need for Affordable Homes cannot be shown for Sudbrooke, the PC would wish to see a small percentage of Retirement Bungalows being provided for the Village instead of Affordable Homes being allocated elsewhere across West Lindsey.

**ii. Report of meetings with Globe Consultants/further meeting:** Meetings took place on April 20, 2017 and May 11, 2017 at the Village Hall. Notes were taken and it was agreed that a further meeting take place in the near future.

■ **d) Application 136072:** Erection of agricultural biomass boiler with integrated straw fuel storage building and hard standing – Grange Farm, Station Road, Langworth. Councillor Stuart Curtis commented that access should not be through adopted roads.

Comments submitted to WLDC:

Available individual councillors have been contacted by me for their views and those who are in a position to comment wish your authority to note the following:  
That a condition for access to the proposed biomass boiler and associated straw fuel storage building by heavy commercial vehicles and tractors/trailers should be along the existing private service road connecting the A158 Wragby Road or the applicants adjoining arable land. Access should not be over any adopted road servicing residential properties.

■ **e) Permission:** 135830 18 Holme Drive – Extension.

■ **f) Additional item:** Councillor Ian Russell stated that a TPO application at The Spinney, Main Drive is not yet on the WLDC website.

# PARISH COUNCIL REPORT

## Brief report of meeting held on June 14, 2017

■ **Sudbrooke News:** An approach had been made from a printer with a suggestion that local villages, including Sudbrooke, amalgamate to produce one monthly magazine. The Editor of **Sudbrooke News** was invited to join in the discussion and it was agreed that it could develop into one of the 'glossies' that seem to be popping through the letter boxes and may not have so much relevance to Sudbrooke. All agreed that Sudbrooke currently has an excellent magazine and Editor and that it carry on exclusive to Sudbrooke.

■ **Proposals for Main Drive by developer:** Some residents of Main Drive attended the meeting with concerns about the proposals the developer had made for access to Main Drive. The Parish Council agreed to write to Jackson and Jackson stating that it does not want to promote one solution over another without the support of the majority of residents in the Park who have right of access to Main Drive and therefore suggests that details of the various schemes be sent out to residents for comments.

■ **Highway works in Sudbrooke:** LCC Highways had reported that they had filled in over 200 potholes in the village! It is hoped to surface dress the highway in Church Lane and slurry seal the footpath. Scothern Lane - Slurry sealing is programed for the footway on Scothern Lane this summer.

## JUNE MEETING: A GARDENER'S DELIGHT

■ A truly lovely garden which gives immeasurable pleasure to both its owners and visitors alike - our thanks to Coral and Paul for inviting us to share it with them for the evening.

The vegetable plot deep beds were in full production of asparagus, courgettes, broad beans and various brassicas, with leeks, onions, runner beans and celeriac to follow on. The greenhouse had a good display of tomato, cucumber, pepper and chilli plants which should provide a bounty of produce in the coming months. Outdoor fruit included apples, plums, damsons, raspberries, loganberries, blackcurrants and gooseberries.

A smaller greenhouse in the main garden contained a display of geraniums and cacti. The shrubberies and flower beds were set with many wonderful plants including Spiraea, Peonies, Weigela, Roses (Alan Titchmarsh and Ballerina looking particularly delightful), Deutzia, Cornus Kousa, Foxgloves and several varieties of perennial Geraniums, to name but a few.

The wildflower area of the garden contained Yellow Rattle, Ox Eye Daisies, Ragged Robin, Red Camion and wild common Orchids.

Paul had been busy on his computer compiling a quiz morphing the faces of famous gardeners and the bodies of Super

Hero characters - our congratulations go to the winning team comprising Ruth and Dave Marshall, Angela Gould and Mike Cannon.

Members are looking forward to a private tour of the Hall followed by lunch and an afternoon free to explore the gardens.

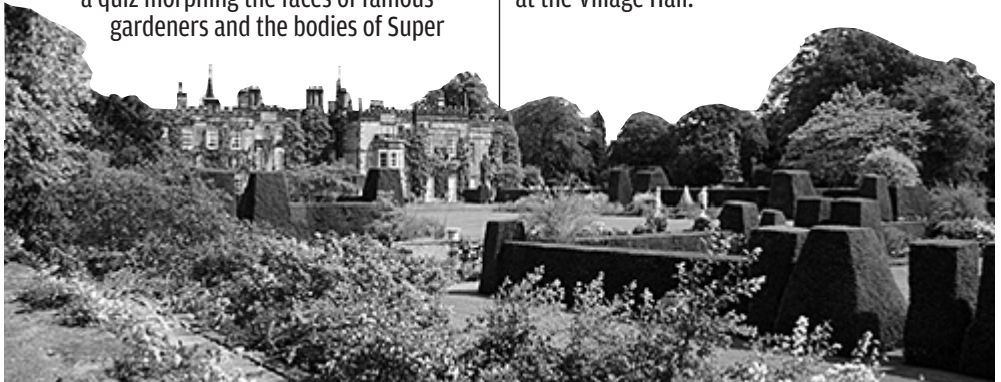
## HANGING BASKET COMPETITION

This year, the event will be celebrating its 40th year and will welcome scouts and guides from countries such as Egypt, New Zealand, Sri Lanka, Russia and Canada.

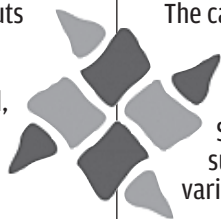



# DOGS DIE IN HOT CARS

# IF YOU SEE A DOG IN A CAR ON A HOT DAY:

- ✓ Establish the dog's health/condition.
- ✓ What is the dog doing – are they panting or drooling?
- ✓ If the dog is displaying ANY signs of heatstroke – dial 999 immediately.

- If the situation becomes critical for the dog and the police are too far away/unable to attend, many people's instinct will be to break into the car to free the dog. If you decide to do this, please be aware that, without proper justification, it could be classed as criminal damage and you may need to be prepared to defend your actions in court.
- Make sure you tell the police what you intend to do and why, and take images/footage of the dog and the names and numbers of witnesses to the incident. The law states that you have a lawful excuse to commit damage if you believe that the owner of the property that you damage would consent to the damage if they knew the circumstances (section 5(2)(a) Criminal Damage Act 1971).
- If the dog is removed from the car displaying signs of heatstroke, follow the emergency first aid advice overleaf. This could be the difference between life and death for the dog.

It can be hard to know what to do in this situation. Many people's immediate reaction is to call the RSPCA, or other welfare organisations, but in an emergency, RSPCA inspectors may not be able to attend quickly enough and – because they have no powers of entry – they would still need police assistance.

**Don't be afraid to dial 999, the police deal with hundreds of such incidents each year.**

**The police will inform the RSPCA of the incident if animal welfare assistance is/may be required.**

## IF THE DOG IS NOT DISPLAYING SYMPTOMS OF HEATSTROKE, FOLLOW THESE STEPS:

- Establish how long the dog has been in the car – is there a 'pay and display' ticket showing a start/expiry time?
- Make a note of the registration number of the car. If the owner returns but you still feel the situation was dangerous for the dog, you may wish to report the incident to the police.
- If you're at a superstore/venue ask the staff to make an announcement on the tannoy or public address system to alert the owner of the situation. If possible, get someone to stay with the dog to monitor their condition. If the dog begins to display signs of distress/heatstroke, make sure they're prepared to dial 999.
- You can also call the RSPCA cruelty line for advice on what to do at any time – **0300 1234 999** – but please be aware that if the situation is dangerous for the dog, dialing **999** should always be the first step.

## DISPENSARY

■ A reminder again that the Dispensary staff require at least two working days to process a request for a routine repeat prescription. Queries and non-repeat requests may take longer.

The Dispensary staff always endeavour to process these requests as quickly as they can. Patients are able to help streamline the process in the following ways:

- Signing up to electronic prescribing and ordering repeat prescriptions online - this is much quicker than all other methods as requests are made electronically and signed off several times a day.
- Leaving requests for repeat prescriptions on the Dispensary answer machine - option 4 on the telephone system.
- Only telephoning to speak to the Dispensary staff between 2pm and 4pm when they are able to have a dedicated response.
- By being aware of Bank holidays / weekends when it may take longer than normal to process your prescription and to make requests in good time.

## PHARMACY2U

■ A company called Pharmacy2U have written to some of our patients offering their services for the processing, dispensing and posting of medication. However, there are some important considerations that we feel patients should be aware of:

- Under current local NHS rules, we are not permitted to receive requests for repeat prescriptions from these types of Pharmacies.
- The letters are using the NHS logo and Practice name without the authorisation to do so.
- The letters state that we recommend this company, which we do not and we do not know how they have

obtained your contact details.

- They do not deal with fridge items or controlled drugs and a separate prescription will be required for these.
- If you choose to use this company, there is very little the Practice can do to help in the event of your medication being delayed. Medicines are delivered by Royal Mail and could be taken to a sorting office if no one is home.

If you have any further queries relating to this matter, please contact Dispensary.

## DNAS

■ In May, 24 patients did not attend for their appointments with the doctors and 66 appointments with the nurses. Almost 15 hours of clinical time was lost due to patients not attending for their appointments.

Please try to remember appointments or cancel with us if they are no longer required. If you would like to be able to receive booking confirmations and text message reminders for appointments, please see Reception to sign up for this.

## CYBER ATTACK
