Notes of the monthly meeting of Sudbrooke Parish Council held on Thursday 5 November in Sudbrooke Village Hall.

125) Parishioners Items

■ Attention was drawn to the number of vehicles parking in Scothern Lane, during school bus drop off times, near to the junction of Wragby Road and the possible danger of young people crossing the road. The local PCSO would be informed and asked to observe and take the necessary action to alleviate the problem.

■ A resident reported trees overhanging the footway from an empty property on St Edwards Drive. Councillor Stuart Curtis offered to speak to the owner and if he was in agreement he would cut back the trees.

■ Report of a new road sign on West Drive stating 'West Drive leading to Sudbrooke Park'. The Clerk was asked to contact the County Council to ascertain if it had been sited by LCC.

■ Report of dogs running loose on West Drive. Local PCSO to be notified.

■ Report of cars parked on the footpath near to the church during service times making it difficult for walkers who had to walk on the road. Councillor Stuart Curtis offered to speak to Revd Penny Green about this.

130) District Councillor's Report

■ DC Stuart Curtis reported that local community groups could now apply for up to £8,000 via the West Lindsey Community Grants scheme.

He also stated that the final draft of the Central Lincolnshire Plan would be available next spring and be then passed to the Government Inspector for final adoption by the end of next year.

131) Correspondence and Reports

■ **a) TPOs in village:** Noted that WLDC were working with owners re development on Wragby Road.

■ **b) Strimming of footpaths:** Councillor Ian Russell reported that he had arranged a site meeting with LCC Officers for November 10, 2015.

■ **c) Footpath between Main Drive and Fox Covert – consideration of quotations:** Two quotations received in the sums of Company A - £2745.00 and Company B - £1100, plus £400 for additional gravel if required.

The Clerk was instructed to ascertain the depth of the stone to be laid by company B and if 2" or more instruct the company to proceed with the work. Proposed by Councillor Miss Rose Dobbs seconded by Councillor Paul Rignall and Resolved.

■ **d) Overhanging trees, Courtfield Close:** Notification received that only the footpath leading from Holme Drive to Courtfield Close had been adopted by LCC highways. The area of land adjoining Holme Drive would appear to still belong to Somerville Properties, of which the company had been dissolved. Enquiries would continue to be as to whose responsibility it is to maintain the area.

■ **e) Christmas tree switch-on event:** The following arrangements were agreed unanimously:

- Revd Chris Hewitt to switch on the lights
- Kate Buckley to prepare the mince pies
- Mulled wine, children's drinks/biscuits etc. to be purchased by Clerk
- Hamper items to be prepared by Clerk to value of £25 approximately.
- Risk Assessment - Councillor Andy Cottam was thanked for preparing the Risk Assessment which was accepted. Proposed by Councillor Peter Heath, seconded by Councillor Bob Waller.

■ **f) Church Lane – suggestion of 7.5 tonne weight limit:** Reply awaited from Nettleham Parish Council whose meeting would be later in the month.

■ **g) Reconsideration of window in bus shelter:** Two quotations were considered in the sums of company A - £163.00 and Company B - £195.00.

A vote was taken for members for and against proceeding: For = 6 - Against = 2. Resolved that a window be provided in the bus shelter.

That the quotation from Company A be accepted - Knights of Langworth - in the sum of £163 proposed by Councillor Andy Cottam, seconded by Councillor Paul Rignall.

■ **h) Silver Jubilee Seat, Wragby Road:** Slats made from recycled material were proving to be costly, therefore Mr Dave Etheridge had offered to obtain the price for the materials for wooden slats.

■ **i) CCTV – Village Hall:** Repeated requests by email and phone had been made to the installers, Link Security, to attend to the CCTV which appeared not to be working correctly. Members instructed the Clerk to write stating the disappointment of poor customer service by the company.

■ Manufacturers (Wicksteed) quotation for repairs recommended by RoSPA inspection received for Northfield Park in the sum of £279.90.

Due to the necessity of this work proposed that the above quotations be accepted by Councillor Andy Cottam, seconded by Councillor Andy Cottam and Resolved.

134) Planning

■ **A) Consideration by Parish Council of pursuing the production of a Neighbourhood Plan for Sudbrooke:** The Chairman suspended Standing Orders at this point in the meeting (8.10pm) in order for residents present at the meeting to speak.

It was stated that at the Parish Meeting held on October 22, 2015, the majority of those present were in support of the production of a Neighbourhood Plan and several residents had offered to assist in its production.

Councillors offering to be members of the Steering Group were Councillor Stuart Curtis, Ian Russell and Bob Waller.

Following discussions, the Parish Council agreed in principle to the production of a Neighbourhood Plan for Sudbrooke providing sufficient volunteers can commit themselves to carry this out.

Proposed as above by Councillor Paul Rignall, seconded by Councillor Mrs Lyn Etheridge and Resolved. Standing Orders resumed at 8.20pm.

134) Planning continued

■ **B) Request by Greetwell Parish Council for support in opposing proposal for Traveller site at Wragby Road East, North Greetwell:** Greetwell Parish Council had asked for support from Sudbrooke Parish Council and its residents in objection to the proposal in the draft Central Lincolnshire Plan for a traveller site on the A158 at North Greetwell.

Members agreed unanimously to object to the proposal on the grounds of the unsuitability of the site on a busy main road, causing safety hazards for both users of the road and users of the site.

Note: Councillor Stuart Curtis declared an interest in the above as a member of the WLDC Planning Committee.

■ C) Planning applications received:

i) 133536 - Six detached dwellings with associated infrastructure, including new bridge crossing, new passing places to Poachers Lane and the provision of a new footpath link from Sudbrooke to parish boundary. It was noted that a site meeting was to be arranged with the Planning Officer and residents to which Councillor Curtis had been asked to attend. Councillors Peter Heath and Bob Waller also agreed to attend. Comments would be submitted by the Clerk under delegated authority following that site meeting.

ii) 133594 - 4 The Paddock: Two storey extension - No objections.

iii) 133499 - Garden House, West Drive: Single storey rear extension - No objections.

■ D) Permissions

i) 133416 - 73 Holme Drive: Two storey extension

ii) 133418 - 16 Beresford Drive: Erect detached garage

■ E) Draft Central Lincolnshire Plan:

a) Comments to be made by Parish Council - as above re proposed travellers' site. Residents could make objections until November 25, 2015.

b) Consultation event - Cherry Willingham - Friday 6 November 2015: This had been widely advertised in order to allow residents to attend.

135) Chairman's Comments

■ The Chair stated that he felt the village shop was currently giving a second-rate service to the village since it re-opened following difficulties. It was now often low on stock items and sometimes closed whilst papers were delivered to Langworth.

Members agreed that he write a letter to the shop owner on behalf of the Parish Council expressing these concerns and stating that the Parish Council were keen to see the shop continue.

138) Parishioners Items

- A resident present stated that she had reported to WLDC that trees had been removed at a property on Wragby Road. Councillor Ian Russell agreed to look into this and if necessary take discuss with the WLDC Trees Officer.
- The lights at the Millennium Stone were reported as not working. The Clerk would arrange for them to be checked by an electrician and necessary repairs carried out.
- Report made that there was standing water in holes in the footpath outside 66 Scothern Lane making it difficult to walk on the footpath. The Clerk would report this to LCC Highways.

139) Apologies

- Councillor Peter Heath. Reason for absence accepted proposed by Councillor Bob Waller, seconded by Councillor Paul Rignall and Resolved.

140) Declarations of Interest on any Item on the Agenda

- None declared.

141) Notes of Meeting held on November 5, 2015

- That the notes be signed as a true record proposed by Councillor Andy Cottam, seconded by Councillor Stuart Curtis and Resolved.

- **B) Loose dogs:** Confirmation received that the owner had been spoken to by a Police Officer regarding this incident.

- **C) Parking for pick-up/drop-off school bus on Scothern Lane:** Correspondence from Police received stating that although the situation is not ideal, there are no offences occurring that can be seen, but the situation will be monitored.

143) District Councillor's Report

■ DC Curtis stated that the period of consultation had now ended for the Central Lincolnshire Local Plan and that there had been many comments regarding the proposed travellers' site at North Greetwell.

144) Correspondence and Reports

■ **A) Strimming of footpaths:** Councillor Ian Russell reported on a meeting held with the Footpaths Officer of LCC.

The footpaths in The Park from Main Drive to the ponds/along the stream would in future only be cut by LCC on a reactive basis and if funds were available.

It had been suggested at the meeting that some paths could be wood chipped – £500 was available from LCC Parish Path Partnership funds.

Members agreed unanimously that an application be made to LCC for £500 for woodchips to be applied to FP 816/817.

■ **B) Land between Courtfield Close and Holme Drive:** LCC Highways had confirmed that whilst the link footway between Courtfield Close and Holme Drive does form part of the publicly maintained highway, the verge areas either side were not adopted. They also stated that given that these areas serve no useful purpose for highway users, and with current funding levels being what they are they would be unwilling to take on the future maintenance of this open space.

They further suggested that the Parish Council contact the Crown Estate Office for further advice. Proposed by Councillor Stuart Curtis, seconded by Councillor Ian Russell that the Clerk be instructed to obtain information from the Crown Estate Office regarding the above and report back to a future meeting of the Parish Council.

■ **C) Christmas tree Event:** Due to the severe wind on Sunday 29 November, only the switch-on of the Christmas tree had taken place and all activities had been transferred to the Village Hall. The function had been well attended. Funds taken by the Parish Council for the sale of mince pies/raffle had totalled £109.00.

Discussion ensued as to whether next year's event at the Christmas Tree should be continued or whether all attractions should be based at the Village Hall. Members agreed that this be an agenda item for September 2016's meeting of the Parish Council.

■ **D) Church Lane – suggestion of 7.5 tonne weight limit sign:** This would be discussed by Nettleham Parish Council at its December meeting. Councillors Paul Rignall and Stuart Curtis agreed to attend the meeting.

■ **Silver Jubilee Seat:** The cost of the replacement materials for the seat were £156 ink VAT. Members approved unanimously the purchase of the materials and thanked Mr Etheridge for voluntarily renovating.

Note: Councillor Mrs Lyn Etheridge declared an interest in the above as wife of Mr Dave Etheridge.

It was noted that the wood would be treated with oak stain and would therefore not require painting as previously mentioned.

■ **E) CCTV at Village Hall:** It was reported that the service provided by Linc Security had been unacceptable in their refusal to answer requests for maintenance both verbally and in writing. Mr Martin Dickie had offered to speak to the company on behalf of the Parish Council to ascertain what their problem may be. Proposed by Councillor Bob Waller, seconded by Councillor Stuart Curtis and Resolved as above.

144) Correspondence and Reports continued

■ **F) Jubilee Garden – preparation of land for wildflower seeds:** Date agreed for digging over the area for the wildflower seeds January 10, 2016.

145) Policy Consultation on Lincolnshire Schools Admissions Arrangement for September 2017

■ The Consultation Document for the proposed changes to the admissions policy to Ellison Boulters Church of England Academy had been received for comment. It was noted that it was proposed to not give priority to children whose parents live in the parishes of Barlings, Scothern, Stainton-by-Langworth and Sudbrooke and attend any of those churches.

Members stated that the school at Scothern was originally relocated from Langworth and that priority should continue to be given to the children in those villages.

It was also considered that Sudbrooke was fortunate in having a purpose-built cycleway from the village to Scothern for use by children to and from school. The alternative of travelling to Reepham or Cherry Willingham to schools would mean crossing the main A158 and this should not be considered in the interest of safety.

Proposed by Councillor Stuart Curtis, seconded by Councillor Bob Waller that the above comments be forwarded to Ellison Boulters School and a request made for the proposed new policy to be re-considered.

146) Emergency Planning Event, 10am-4pm, January 20, 2016 Wragby Fire Station

■ This event was brought to the attention of members. Any member wanting to attend was asked to contact the Clerk in order to book a place.

147) Finance

■ **A) Cheque signatories – additional information required for change of signatories at Co-op Bank:** Difficulties were being encountered by the Treasurer in changing the bank signatories who appeared to have not deleted previous Councillors.

That Mr Derek Ordish and Mr Roger Adams be removed from the banks records as signatories to the Parish Council account RESOLVED unanimously.

■ **B) Retrospective approval for expenditure given by Clerk and Chairman for additional works required to electrical box, Scothern Lane:** During works to changing of the timer at the electrical box it had transpired that the electrics were due for inspection/testing. In the interest of safety and insurance the Clerk and Chair had given immediate instruction to Imp Electrics to undertake the work required, which had been carried out and certified.

Members unanimously approved the above actions and expenditure incurred.

148) Planning Matters

■ **A) Application 133193** - 32 Scothern Lane - Due to information recently received the final paragraph of comments made by the Parish to this application were amended as follows:

'It should also be noted that the frontage on Scothern Lane includes protected trees. Some at the edge of the TPO area have been felled but were not considered by WLDC to be protected due to their age. All trees fronting the Lane provide important amenity value. It is noted that there is no reference to protected trees in 13 or 15 of the application, though there is reference to TPO's on the Design Statement.'

Proposed by Councillor Ian Russell, seconded by Councillor Bob Waller and Resolved.

■ **B) Application 133536** - Six detached dwellings with association garages and infrastructure, including new bridge crossing, new passing places to Poachers Lane and the provision of a new footpath link from Sudbrooke to parish boundary - 'Sudbrooke Parish Council have viewed this application and also met with residents and the WLDC Case Officer and object as follows:

1) The new exit from the development will create a potentially dangerous junction with traffic exiting from the existing houses on Poachers Lane. The existing houses have high external walls and have very limited visibility on to Poachers Lane and would require much greater driver caution.

2) The original outline planning application had the bridge and exit onto Poachers Lane further along and well away from the existing houses. It provided good visibility and a relatively risk-free junction.

3) The proposed bridge position is flanked by mature trees that line the roadway and provides a screen between the existing and proposed development. The trees when combined with the original application access bridge position created two entirely separate developments giving greater privacy to both. The new bridge position will create a direct link between both developments thus reducing privacy and creating a large single entity development.

■ **C) Permission 131612** - Change of use of agricultural land to church yard to be consecrated for burial, St Edward the Confessor, Church Lane, Sudbrooke.

148) Planning Matters continued

■ **D) Lincolnshire Minerals and Waste Local Plan:** Consultation on proposed modifications to the core strategy and development management policies - Councillor Stuart Curtis outlined this document to members.

■ **E) Neighbourhood Plan for Sudbrooke:** The first meeting of the Neighbourhood Plan Steering Group had been held on November 26, 2015. Mr Andy Telezynski had been appointed Chair and Mrs Barbara Bingham would administer the Group. Finances would be through Parish Council accounts.

149) Chairman's Comments

■ The Chair thanked Mr Bernard Bartram and Mr Martin Dickie for re-staking a tree on West Drive.

150) Correspondence

■ Confirmation from LCC Highways that a new directional sign would be provided at the Scothern Lane/Church Lane junction. LCC Highways had asked that the Parish Council arrange removal of the vandalised kissing gate on FP159 this gate. Councillor Bob Waller offered to do this.

PARISH COUNCIL REPORT

Brief report of meeting held on January 7, 2016

■ **Notes of Parish Council meetings** - These are available on the the parish website or via the Clerk to the Council. They are not now available in Nettleham Library due to its closure.

■ **Church Lane/Nettleham Lane - request for 7½ tonne weight limit** - Nettleham Parish Council have supported the request for a weight limit down this stretch of road and a request will be made to LCC Highways.

■ **Neighbourhood Plan** - The boundary plan for the Sudbrooke Neighbourhood Plan was unanimously agreed.

OUR HEROIC CARERS

■ For those villages for which this is the first newsletter of the year, may I wish you every blessing for the new year. For those who have a January newsletter - I hope your new year has begun well.

As I write this, on January 5, I have just begun some time out, which will almost have ended by the time you read this. This for me is time to reflect, pray and time to perhaps shed some of the things that I have picked up in the five years of my ministry in this area.

We all carry things that we are not meant to carry. I am reminded of Jesus' friend Lazarus. John's gospel tells us that he went to the grave of his friend and cried to him 'Lazarus, come out!', at which point Lazarus came out of the tomb, complete with the burial cloths he had been bound with....

Jesus said to him 'take off the grave clothes and let him go'. Whether or not you believe that Jesus had the power to raise the dead, there is great truth in that account. The real Lazarus was buried under grave clothes, bound up and so often in life, the person that we are meant to be gets lost inside the layers of other people's expectations on us.

That's often not intentional - some of us try to gain love by trying to live up to the expectations of others; some of us try to model what we do and how we are on other people we admire and eventually we are bound by those things because frankly we can't be anyone else but ourselves - the

person that God created us to be. Some of us are bound by unforgiveness - we can't free ourselves from things that have been said to us or done to us - at some point, if we are not to be damaged by that, we have to let go.

I was given a Russian doll for a Christmas present - one of those dolls that sits inside each other, and in this case, make seven layers. I love it, and it reminds me of something very important - that we are a series of layers: There is the layer on the outside that we allow most people to see, it is our public layer; then there is the next layer that our friends and family see - it goes a bit deeper; then there is the layer that the people who really love us see - those with whom we share ourselves; then comes the layer that only we know about - our deep longings, our true selves, a part that we allow no-one into; then the next layer the one that only God knows about, our relationship with Him, the longings of our soul.

It's that layer that influences the rest - if we are called into a relationship with God, then our deepest self is the place where, when we allow God in is the place of greatest influence.

I think we can be scared of that and it feels very risky and even painful, but we must know that God loves us immeasurably and wants the best for us, and its with that trust that we approach Him and His calling on our lives.

I trust that this new year will bring you every blessing.

BOWLED OVER AT POTTERS RESORT

Just Retirement Professional World Indoor Bowls Championships



I KNOW there are a few keen bowlers in Sudbrooke, so I thought I would share my experiences of the World Indoor Bowls Championships, held at Potters last month.

I spent three days at the five-star holiday venue in Hopton-on-Sea, rubbing shoulders with the best players in the world as they sought to get their hands on the Langham Glass Bowl - the Singles trophy - plus a cheque for £55,000.

Nick Brett, from Huntingdon, eventually came out on top, beating Robert Paxton in the final - believe it or not, only the third-ever all-English final. Brett is one of the most popular players on the circuit and you can also be assured of some 'good copy' in his interviews.

After both his semi-final and final wins, he launched into a tirade against England outdoor team boss

John Bell, as Brett has amazingly been ignored at international level since 2012.

His next big ambition is to win a Commonwealth Games gold medal, but he insisted that while Bell's still in charge, he's got no chance.

He's the world No.1 and cannot get into the international squad? There's something wrong there...

Also, just to emphasise how down to earth the bowlers are, Brett - a plumber by trade - revealed he was starting a new job on the Monday, a 'requirements manager' at RAF Wyton. Even he admitted he had no idea what one of them did.

What about that £55,000 cheque I hear you ask. Well, the players have an agreement between themselves to split the winnings, which is very noble, and not something you would find happening in most other sports.

Meanwhile, six-time world champion Alex Marshall was widely expected to win his seventh crown after playing some of his best-ever bowls on the run to the semis, but fell to Paxton.

Surprisingly, for someone who has 'legend' status in bowls, with over 20 world titles to his name and numerous Commonwealth Games gold medals, he told me at the bar later that night that someone riled him

on Twitter by suggesting he "blew it" against Paxton.

He was having none of that and sent the poster a

private message asking him to describe exactly how he blew it. He was still waiting for a response...

Lincolnshire had one player in the tournament in Grantham's Matthew Orrey, who amazed everyone by first beating favourite Paul Foster, before reaching the quarter-final, where he narrowly lost to David Gourlay.

His wife was a comical sight up in the 'Players Lounge' urging him on and also criticising him under her breath in equal measures, before their baby decided he wanted feeding, to which she had to watch

her husband for the next few minutes on the TV.

One thing you notice, though, is how honest the players are. They are always quick to criticise themselves and praise their opponents - Stewart Anderson was spitting feathers with himself after his last-eight defeat to Marshall, but also hailed 'Tattie's' performance.

Greg Harlow complained about the underlay underneath the portable blue rink, while I bet Gourlay is still shaking his head at 'that measure' against Brett in the semi, which cost him a final place.

Announcer Richard Beare loves his smutty jokes with the crowd, most of whom it has to be said, are of pensioner age, but he dropped a few clangers this time around, including after the final when he called Robert Paxton, Robert

Paxman, as he was about to receive his runners-up cheque.

Former BBC commentator David Rhys Jones, who travels around the world reporting on the sport, has more bowling anecdotes than you shake a stick at and when prompted is only too happy to regale a story of a certain bowler or other.

Anyone remember Richard Corsie, the Scot who dominated the sport in the 1990s, winning three World Indoor titles and losing in another four finals? Well, according to David he hated the sport, preferring to play golf, but for two weeks of the year he 'put his sensible head on'.

And as for Potters itself? What a fabulous place, but make sure you are prepared to eat and eat and eat as one thing they are not short of, apart from bowling rinks, is food!

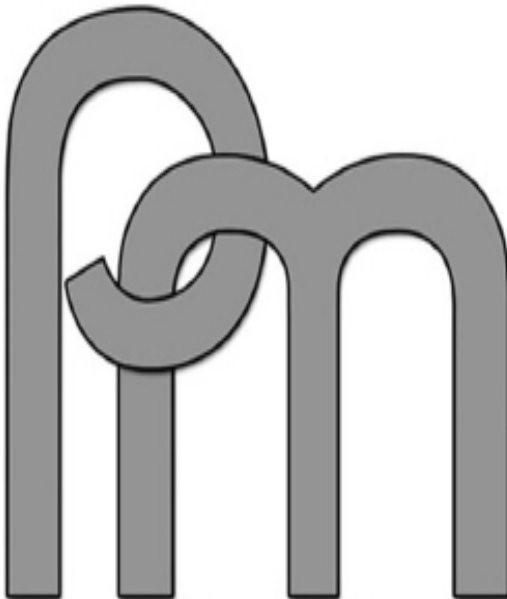

REFLECTION CORNER

Where Sudbrooke residents can share their thoughts on life and living

ALEC C. CARROTTE ON CONFIDENTIALITY

In past times we all thought we knew the meaning of the word 'confidentiality', (ie) if we shared a conversation with another person, then it was believed that any information given, was to remain between the two parties involved and would not be divulged to other people outside that particular conversation. This perspective is re-inforced when consulting dictionaries:

*"Spoken, written or given in confidence, secret, private, entrusted with another's secret affairs".
Behind closed doors, between ourselves.*

Collins English Dictionary & Thesaurus

"Private, secret, within these four walls"
Chambers Thesaurus

All the above definitions of 'confidentiality' seemed quite clear and non-negotiable in past times. However, nowadays a lot depends on its interpretation by the person, agency or formal organisation with whom the information is being shared, and in addition, the influence of any modern legislation on the topic of information sharing.

So, when is it reasonable to expect 'confidentiality' to be breached by an individual or organisation? Generally, the following would be regarded as reasonable justification for breaching confidentiality, bearing in mind the main principle at all times is one of proportionality:

- Where a client may be at risk of self-harm (suicide)
- Where a client displays mental illness requiring treatment
- Where a client may be at risk from others
- Where others may be at risk from a client (child abuse, domestic abuse, revenge attacks, rape, murder, manslaughter, kidnap)
- Where a client has broken the law (depending on the seriousness of the act)
- When subpoenaed by the courts
- When someone gives permission to disclose (eg) when wanting to access a medical service/ treatment or affiliated services
- In consultation with nearest relative if client is incapable of making a rational decision

- Public protection – duty to warn others (eg) bomb threats, treason, state security

- In clinical supervision of 'professionals' where staff are given clinical supervision by a 'mentor' in order to improve their skills as a practitioner (eg) (doctor, psychologist, social worker, solicitor, counsellor, psychotherapist, psychiatrist, dietitians, occupational therapists, physiotherapists, chiropodists etc).

- In a teaching situation. This information is usually in the shape of an anonymous case study, limited to class members and the teacher

- In the field of research which seeks to improve service delivery. The information 'collected' is usually codified with a reference number of coded letters, in order that any individuals cannot be identified by name.

- Within a multi-disciplinary Case Conference, where all the professionals are meeting to formulate an 'action plan' to improve a client's situation.

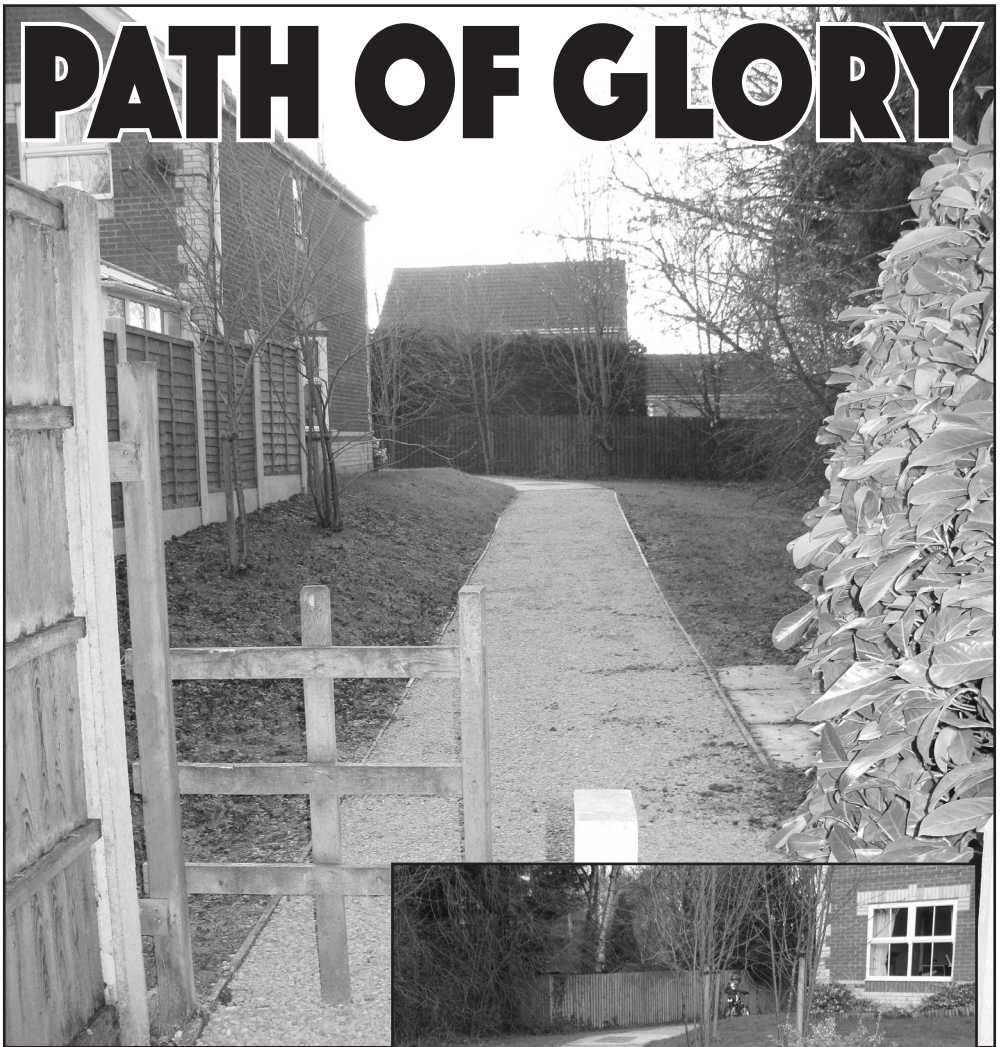
Establishing the limits of confidentiality

Before beginning to disclose your personal information with an individual or an organisation, you need to establish the 'ground rules':

- Does the information stay within the 1-1 relationship?
- Does it get placed on organisational records?
- If placed on organisational records, are my details codified to hide my identity?
- Who has access to my records within the organisation?
- Do I have access to my personal records?
- If my records contain errors of fact can I have them corrected?
- How long are my personal records kept within the organisation?
- If confidentiality is breached by the organisation will I receive advance notice?

Be aware that certain professions have different obligations/options regarding disclosure (doctors, accountants, lawyers, counsellors, psychotherapists, psychologists).

NB. Stay in control of your 'private stuff'.

SCAM MAIL

■ Have you received scam mail through your door recently? The likelihood is that you probably have. Scam mail is sent by fraudsters, often from overseas, trying to persuade residents to part with money or personal information by tempting them with 'cash prizes'. These scams can result in considerable financial loss to the victims.

Trading Standards have become aware of an incident where a resident was sent a scam letter enclosing a photograph of a cheque with the victims' name on it, claiming that they had won the 'Football Lottery'. The victim was asked to post a considerable amount of cash in order for the cheque to be released. Not surprisingly, this was a scam and the victim lost the money.

Other victims have had emails telling them they have won prizes or cash and to click on a link to give them more details, this could also be a scam in order to gain access to your computer or bank account details.

These types of scams are often time limited which puts pressure on the potential victim to reply quickly.

Once the letters are replied to the residents personal details are often added to a list of potential targets which are then circulated to other fraudsters. Residents who respond to scams can then be bombarded with similar scam mailings.

Please keep an eye on vulnerable neighbours, family or friends to help prevent

them becoming the targets of these types of scams.

Trading Standards advise you not to respond to any mailing which has the hallmarks of a scam and would encourage you to forward the letter to Royal Mail Scams Department, Freepost, Scam Mail, PO Box 797, Exeter EX1

Never accept goods or services from someone that has contacted you directly without being asked. If you make a mistake and sign up for a service, you have seven days to cancel the contract in writing.

Register with the Telephone Preference Service (TPS) and Mail Preference Service to remove yourself from mailing lists and unsolicited sales: www.tpsonline.org.uk and www.mpsonline.org.uk Ring: 0845 070 0707

To report a fraud or scam contact Action Fraud: www.actionfraud.police.uk Ring: 0300 123 2040

To report incorrect trading practices call your local Trading Standards office. For Lincolnshire email: tradingstandards@lincolnshire.gov.uk Ring: 01522 782341

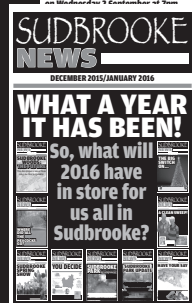
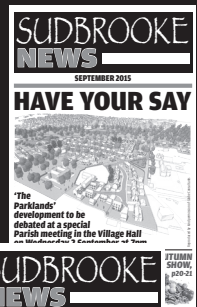
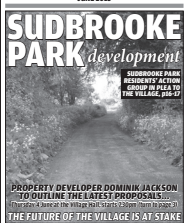

UPDATE

■ It has been suggested that there may still be people out there who don't know what or who the PDA are. I have now given us our full title and can I give you a little bit more information?

2016 is the 25th anniversary of the PDA. It was originally formed to promote communication, liaison and mutual support between patients and staff of the Health Centre.

This is still something we aim to do as we assist the practice with the patient surveys they carry out and we also help to provide equipment, through fund raising and donations, for items not covered by the NHS budget.

If any patient has a complaint or compliment (it's a pity those words are very similar as we wouldn't want to get them confused!) they can always speak to a member of the PDA Committee. We have a notice board inside the waiting room and all Committee members are listed there.

Although the transport scheme began at the same time as the PDA was formed, it has grown beyond anything that could have been imagined. I believe that initially there were just a few drivers who transported patients free of charge.

The earliest records I have are for the period 2000 to 2001, where we travelled 2,082 miles and transported 178 passengers.

In the 2014 to 2015 period, we travelled 29,841 miles transporting 1,996 passengers. The figures seem to increase each year.

These journeys are to any medical appointment anywhere in the country, to which the patient has no other means of transport available to them. This could be hospital, doctor, dentist, optician, chiropody etc.

Drivers receive 45p per mile funded partially by the patient and partially by the PDA again through our fund-raising efforts. Their time is given free of charge and on occasions drivers can be away from home for up to 12 hours on very long journeys. We have recently taken patients to

Moorfields Eye Hospital, London, Papworth Hospital, Cambridge, and John Radcliffe Hospital, Oxford to name a few.

Early starts with a 5.30am pickup and late finishes with an appointment at Derby Royal Infirmary at 7pm are all in a day's work. Having said that the majority of journeys are local and up to two hours!

Having read this you will appreciate the need for constant fundraising which leads me on to say that our next 3 events are:

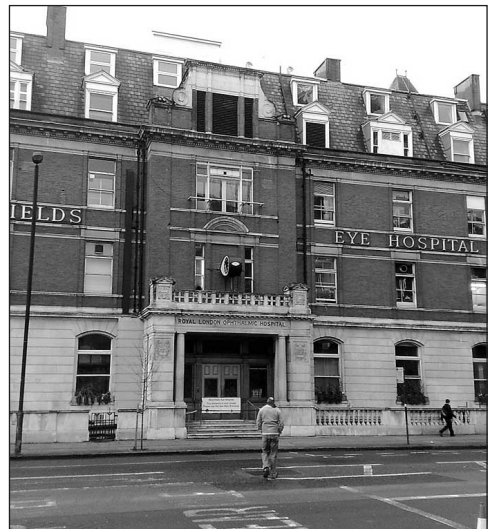

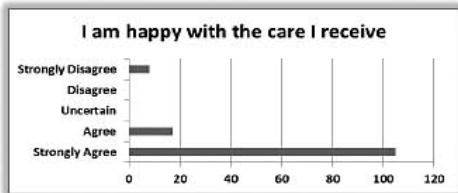
